# **DEATH BY LOCKDOWN**

Yes, lockdowns kill! They are killing people, industries and livelihoods alike. They kill in many ways and with great force too. And no, we have never

been locked-down like this before and there is no solid science to backup the claims of their effectiveness. The longer lockdowns continue, the worse things are going to get. They need to end now!

Almost everyone, including the World Health Organization, is in agreement that lockdowns are destroying society while offering little, if any, real-world effectiveness. A year later, the evidence for this is mounting, including real-world examples of lockdowns being lifted, resulting in lower Covid-19 cases.

Lockdowns are simply not proportionate reactions! They harm more than they help (and so), at what cost are we going to continue going down this path?

## **Death of Hope**

Emotional and psychological effects of the lockdowns and fear-based news media

contribute to the development and exacerbation of mental illness. They also directly contribute to *deaths of despair*.

People experience despair due to a bleak sense of their long-term social and economic outlook. Drug overdoses, suicides, weight gain and conditions like alcoholic liver disease are directly attributed to despair and are all on a sharp rise. It is also known that there is at least an additional 1% increase in suicides for every 1% increase in unemployment. It is not hard to imagine why people will seek destructive behaviour patterns, like drug abuse, in these trying times. This certainly includes children and the elderly alike. Despair can be a real killer.

Calls made to suicide help lines including *Kids Helpline* have more than doubled year-over-year in 2020 and are on trend to continue rising sharply in 2021. At this rate lockdowns are initiating what may soon be known as *The Great Depression* of our time...

## Death of Childhood

No more hugging friends or talking to them during lunch break in school. No more smiling, singing or dancing and certainly no more sports either. No more field trips or family vacations. No school at all, even for weeks on end and when you are in school, you must stay inside your specific, drawn-out circle. Kids are slowly being forced to not socialize and they are being programmed with fear. Also, if you test "positive" for Covid-19, you have to be quarantined away for weeks. Even guilted into thinking you may kill someone if you break the rules!

The lockdowns are harming children. We are scaring them into extreme territories of dehumanization, forcing them to wear masks and robbing them of needed human closeness; for a virus that is less harmful than any past flu season. They have to wear masks with their friends and family. For everything. Many kids now do not feel comfortable bearing their face, even to their own parents! How important is facial expression and other social contact in early development and socialization? Gaslighted by government ad campaigns and mainstream media

## **Death of Small Business**

Costco and Walmart can let dozens of people in their stores at once (with massive lines of people crowding outside) yet other small businesses need to stay closed because they are deemed as "non-essential"? Numerous industries have been decimated from the restrictions including the events, entertainment, hospitality, and tourism industries to name a few. In reality, all forms of in-person work by small businesses have been impacted for more than a year, since the start of the lockdowns.

Much of the middle-class income and future opportunity is vanishing. Wealth disparity between the middle-class and the elites continues to increase, with big global corporations like Amazon, breaking sales records and further dominating the market, contrasted by a sharp increase in homeless population numbers and bankruptcies.

## **Death of Healthcare**

In a world obsessed with Covid-19, all other health care considerations took a back seat. From the disastrous canceling of elective surgeries to, slowly but surely, losing most forms of private health care. We are destroying healthcare as we know it. And as much as they try to sell us on it, telephone meetings (that are now the norm for doctor visits) are not, in any way adequate for performing a role of a simple, in-person, appointment.

There is also a new instilled reluctance from the public to interact with health care workers, like intentionally avoiding going to the E.R. for what may truly be life threatening issues. Ailments are going undiagnosed through telephone appointments, and to top it off, mental disorders are developing or exacerbating without the usual social support systems in place.

## **Death of Rights and Freedoms**

What makes Canada one of the greatest countries in the world? The simple answer is, freedom. Where that freedom stems from is a bit more controversial, but,The Charter of Rights and Freedoms, The Bill of Rights, The Constitution and Police Code of Conduct, among many other regulatory bodies in Canada, are what contribute to making this country amongst the freest of countries in the world.

e world. The Canadian Bill of Rights, as an example, pro-

> vides an individual's right to life, liberty and security, whilst enabling freedom of religion, speech, assembly and association and press.

> For the first time in Canada's short history, these rights and freedoms are under attack. The government, working with big corporations, have ramped up censorship online, where most of our social communication happens. It is becoming exceedingly difficult to find information that goes against the mainstream narrative.

#### **Death of Protest**

For the first time in Canadian history, protesting was "deemed" illegal. On January 16th, 2021, two weeks after Ontario initiated a stayat-home order, Toronto Police took an aggressive stance on protesting. That day, hundreds of police officers lined Dundas Square and arrested and ticketed dozens of pro-

testers seemingly at random, setting a trend for the next few weeks. Even people who stayed "socially distant" were ticketed and/or arrested if they appeared to not be there for "essential exercise."

Governments throughout that world have ushered in anti-protest laws. Last month in the U.K., "The Police, Crime, Sentencing and Courts Bill" was passed, and it limits the right to protest in many ways, including: allowing police to impose start and finish times, arrest "annoying" protesters and outright ban protests in front of the U.K. Parliament. Similarly, multiple U.S. states passed anti-protest laws, including Oklahoma and Iowa where granted immunity to drivers whose vehicles strike and injure protesters in public streets, and anyone convicted of unlawful assembly is barred from holding state employment in Indiana and barred from receiving student loans, unemployment insurance, or housing assistance in Minnesota.

## **Death of Informed Consent**

Individuals receiving COVID-19 vaccines are typically not informed that the vaccines have not been FDA approved (they are being distributed via "Emergency Use Authorization" in the US and "Interim Order Authorization" in Canada, which is technically allowed because we are in a "state of emergency"). Clinical trials will not be concluded until 2023, and by consenting to take the vaccine now, you are consenting to participate in phase 3 and 4 of these clinical trials. Vaccine manufacturers are not liable for any injuries you may sustain, including death. Neither are insurance companies.

## **Death of Scientific Inquiry**

The pandemic response has had a haunting effect on the pursuit of truth. For science to thrive, opposing ideas must be openly and vigorously discussed and either supported or countered based on facts and data. Instead, politicians, journalists, doctors and scientists

# Why We Cannot Trust the Vaccine Data

or over 30 years, Johnson & Johnson knew that the company's raw talc and finished powders sometimes tested positive for asbestos, and the company executives, mine managers, scientists, doctors and lawyers fretted over the problem and how to address it while failing to disclose it to regulators or the public. When questioned, J&J assured the U.S. Food and Drug Administration that no asbestos was "detected in any sample." As a result of their negligence and greed, roughfly 25 thousand of their customers developed a rare form of cancer and many died. The company announced last May that it would stop selling its iconic talc-based Johnson's Baby Powder in the US and Canada. J&J gaslight their own user-base by attributing their decision

to "misinformation around the safety of the product and a constant barrage of litigation advertising." And this is a company we are told to trust with our lives?

The four companies who have COVID vaccines on the ket are or have either: never brought a vaccine to market before COVID (Moderna and Johnson & Johnson). Are serial felons (Pfizer, and AstraZeneca). Are both (Johnson & Johnson). Moderna had been trying to "Modernize our RNA" for years, but had never successfully brought any product to market until now (it seems the US government's infusion of \$1.53 billion dollars helped.) Meanwhile, all other vaccine manufacturers have paid out tens of billions of dollars in damages for other products they brought to market when they knew those products would cause injuries and death. If these drug companies willfully choose to put harmful products on the market when they can be sued, why would we

trust any product where they have no liability?

Major Johnson & Johnson lawsuits and recalls for faulty products include:


- 2019: bribery (for illegally paying off government officials in return for securing contracts national health programs along with price gouging and inflating prices in Brazil
- 2011: corrupt payments to physicians in Greece
- 2010: buying off officials in Greece, Poland and
- 2013 & 2016: paid billions to compensate victims of their flawed products.
- 2008: engaged in a "phantom recall" when its Motrin IB caplets were discovered to not properly dissolve, J&J hired outside contractors to buy up store supplies in order to avoid making public declaration.
- 1995: paid a \$7.5 million fine for destroying documents to cover up an investigation into wrongful marketing of its Retin-A acne cream.
- 2001: Paid out \$860 million in a class action lawsuit for misleading customers about prematurely discarding its 1-Day Acuvue soft contact lens. J&J recommended they should be worn only once, although it was discovered the lenses were no different than the regular Acuvue lens that would last for two weeks.
- 2010: paid a \$81 million settlement for misbranding its anti-epileptic drug Topamax to treat psychiatric disorders and hired outside physicians to join its sales force to promote the drug for unapproved conditions. The following year, J&J paid \$85 million for similar charges against its heart drug Natrecor.
- 2011: Several J&J baby products were discovered to contain carcinogenic ingredients.
- 2013: The U.S. Justice Department charged the company \$2.2 billion in criminal fines for marketing its autism and anti-psychotic drug Risperdal for unapproved uses.
- 2019: ordered to pay \$465 million for its role in Oklahoma's opioid epidemic.

While J&J's rap sheet is long Pfizer has the distinction of the biggest criminal payout in history. The company lost so many lawsuits it's hard to count. Below is a list of just some Psizer's crimes:

- 2009: paid a record \$2.3 billion to settle federal charges for mis-promoting medicines not approved by medical regulators (Bextra) and paying kick-backs to compliant doctors.
- 1996: paid \$10.75 million to settle Justice Department claims that the company lied to get federal approval for a mechanical heart valve that has been fracturing, killing hundreds of people.

- 2004: reached a \$60 million settlement of a class action lawsuit over it's Rezulin diabetes drug that resulted in liver failure and death.
- 2016: fined £85 million by the UK government for overcharging the NHS 2600%
- 2004: paid more than \$430 to resolve criminal charges and civil liabilities for manipulating the publication of scientific studies to bolster the use of its epilepsy

drug Neurontin for other disorders, while supressing research that did not support those uses. They also paid physicians to prescribe the drug for other disorders, and partook in racketeering in the marketing of the drug. During the investigation, they admitted to paying \$20 million to 4,500 doctors and other medical professionals for consulting and speaking on it's behalf just in the last 6 months of 2009. Pfizer also paid \$15.3 million to 250 academic medical centers



- 2012: US Securities and Exchange commission reached a \$45 million settlement with Pfizer to resolve charges that its subsidiaries bribed overseas doctors to increase foreign sales.
- 2001: paid over \$75 million dollars for breaking international laws for conducting an "illegal trial of an

unregistered drug" after Nigerian families accused the company of testing 2 dangerous new antibiotics (Trovan & Ceftriaxone) without parents' consent and using their children as human guineapigs. 11 children died, and other suffered brain damage, paralysis, and hearing loss.

Pfizer also pledged to donate and distribute \$50 million worth of AIDS drugs, but never did. And more recently with the COVID-19 vaccine, Pfizer is demanding that countries that don't have liability protection put up collateral to cover vaccine-injury lawsuits. They have even demanded military bases as guarantee.

Finally, AstraZeneca has similarly lost so many lawsuits it's hard to count. Many of their crimes are related to fraudulent marketing. The company had its COVID vaccine suspended in at least 18 countries over concerns of a rare form of blood clot occurring in young

> women, and it completely botched its meeting with the FDA when numbers from their study didn't match. And then Johnson & Johnson and AstraZenca, had a little mix up in their ingredients in 15 million doses!

> Given the free pass from liability, and the checkered past of these companies, why would we assume that all their vaccines are safe and made completely above board? Bernstein market analyst Ronny Gal predicts COVID-19 vaccine sales will reach \$40 billion this year. A more realistic figure is likely higher as together, Moderna and Pfizer project their revenues at \$32 billion. What crime might these companies commit to keep their vaccines on the market?

> Previous to this year, approximately 6% of vaccines developed passed their trials and made it to market. Is it not odd that all of the vaccines developed for COVID so far have been approved for "Emergency Use Authorization" in the US and "Interim Order Authorization" in

Canada (they cannot get FDA approval until their studies are completed)? Remember, we will not have access to the raw data of these studies until 2023. Until then, we just have to take the word of known liars and criminals. Where else in life would we trust someone with that kind of reputation, let alone trust someone with

# The Cop Who Came In From The Cold

ne of the more unique stories over the last week of almost constant small scale protesting at multiple locations throughout the province was the case of Mississauga Ontario based Huf Boxing Gym, which has remained open since Wednesday in spite of police and bylaw enforcement efforts to the contrary.

On Friday, the gym was visited by an on-duty Peel Regional Police officer who announced that he supported the gym's efforts to remain open, didn't wear a mask, then offended a local member of the legacy media by offering to hug people and pose for photos.

Good times were then had by all except perhaps for Global News correspondent Sean O'Shea, who was on-site in the parking lot at Huf Gym and took offence to hugging in general and anyone hugging him in particular.

The reporter was also confronted by a number of other protestors, most of whom didn't want to hug him, but instead were

angry regarding his biased perspective on the situa-

As noted in the April 16, 2021 Global News post, "Peel officer suspended after hugging COVID-19 protesters, accusing the journalist of agitating attendees," the Peel Regional Police service suspended the officer (with pay) as soon as they learned about his actions through social media.

Because that's what people, even police chiefs, currently depend on for their view of reality. Going outside to see what's actually going on is "verboten" under the current Ontario provincial government.

Peel Regional Police Chief Nishan Duraiappah later issued a statement (also on social media) indicat-

ing that the "Peel Regional Police are committed to ensuring the safety of our members and the public. Our officers will enforce municipal and provincial regulations as required."

Later in the day and as noted in the April 18, 2021 Freedom Forum News post, "Ontario Reverses COVIDafter Restrictions Criticism from Experts & Police: With Commentary from Viva Frei," and the April 17, 2021 Insauga post, "Police won't randomly stop people or vehicles in Mississauga and Brampton," the Peel Regional Police Association (PRPA) was among the numerous Ontario police associations which came out against new provincial

government restrictions, calling them in conflict with the Canadian Charter of Rights and Freedoms.

Many, but not all, of those restrictions have since been reversed. Maybe Sean O'Shea should have taken the hug when it was offered.


censorship.

# This Is Why We Are Protesting

pril 25, 2021 marks the 1 year anniversary of Canada's fight for our rights and freedoms. I am outraged at the Federal, Provincial, and Municipal government's negligent lockdown at the expense of the economy and the very things that makes Canada, Canada. Democracy, capitalism, freedom. There's a reason why we have a Charter of Rights and Freedoms. I'm angry at a lockdown based on shoddy scientific models and government-sponsored statistical fraud at the behest of unelected, international institutions. Institutions like the World Hoax Organiz -no, World Health Organization, World Economic Forum, and the United Nations. Unelected, international institutions that are controlled by a handful of wealthy elite psychopaths hell-bent on unilaterally imposing their own globalist ideological vision of the future at the expense of our innate, GOD-given human rights and freedoms and our GOD-given right to live.

# Would a Vaccine "Immunity Passport" Violate The Canadian Charter Of Rights And Freedoms?

In the latest escalation of rights infringements, governments in Canada are now actively discussing vaccine passports, which would

effectively mandate vaccination for Covid.

A government threatening or mandating liberty restrictions against Canadians who do not want a Covid vaccine would, in our view, be a violation of the section 7 right to life, liberty and security of the person, and the right not to be

deprived thereof except in accordance with the principles of fundamental justice. Once established, the government would then have to prove that this serious rights infringement is demonstrably justified on a preponderance of evidence.

The Supreme Court of Canada, in a foundational case, established that in Canada freedom means the absence of coercion or constraint. If Canadian governments move

to force or otherwise mandate vaccines, they need to be effectively and immediately challenged in court.



How many times did he *think* it was going to work after "this one final experiment"-and it didn't?

There is no question that Edison was very clever, but this is the way of science and new discovery, and it always has been. And don't tell me that mRNA technology has been studied for decades. That doesn't cut it; Covid-19 had only been with us for about 9 months when the vaccines were rolled out. For one example of this corner cutting: you can't have results of a two-year study until two years have passed, and that isn't a conspiracy theory.

This article is not meant to be an indictment against Big Pharma (there are plenty of those out there already) but it *is* meant to be a wakeup call to those who think it is safe to just "take your chances" and forego the fine printassuming you can even *find* the fine print to read.

So what is all the excitement about? Well, if you ask anyone who has just gotten a jab they will most likely tell you that they feel like celebrating doing their part to save the human race. They may think that is the case, but I believe the real reason is a strange, and possibly largely unconscious, belief that technology will save them from actually being human.

We seem to believe that we have risen from animal status to some sort of higher, transhuman status, or at least are on our way to that lofty position. If we trust our scientists and others who are leading the way, we may even one day be able to transcend death itself, because death, of course, is the messiest animal thing an animal does and we don't want that.

Haldimand Norfolk is the 3rd largest food producer and one of the most diverse food producing counties in Canada. From beef to melons and chickens to sweet corn, you can find it all here and that is why we are called Ontario's Garden.

You may be asking why does this matter to me? I am here to tell you from the inside, from the ground, that our food supply chain is under attack and that affordable fresh food & produce is going to disappear.



## **Open Letter To Bonnie Henry From Concerned BC Doctor**

The first dose of the Moderna vaccine has now been administered to some of my patients in the community of Lytton, BC. This began with the First Nations members of our community in mid-January, 2021. Nine hundred doses have now been administered.

I have been quite alarmed at the high rate of serious side-effects from this novel treatment. From this relatively small number of people vaccinated so far, we have had:

- 1. Numerous allergic reactions, with two cases of anaphylaxis.
- 2. One (presumed) vaccine induced sudden death in a 72 year old patient with COPD.
- 3. This patient complained of being more short of breath continually after receiving the vaccine, and died very suddenly and unexpectedly on day 24, after the vaccine. He had no history of cardiovascular disease.
- 4. Three people with ongoing and disabling neurological deficits, with associated chronic pain, persisting for more than 10 weeks after their first vaccine. These neurological deficits include; continual and disabling dizziness, generalised or localised neuromuscular weakness, with or without sensory loss. The chronic pain in these patients is either generalised or regional, with or without headaches.

So in short, in our small community of

Lytton, BC, we have one person dead, and three people who look as though they will be permanently disabled, following their first dose of the Moderna vaccine. The age of those affected ranges from 38 to 82 years of age.

So I have a number questions and comments;

- Are these considered normal and acceptable long term side-effects for gene modification therapy? Judging by medical reports from around the world, our Lytton experience is not unusual.
- 2. Do you have any idea what disease processes may have been initiated, to be producing these ongoing neurological symptoms?
- 3. Do you have any suggestions as to how I should treat the vaccine induced neuromuscular weakness, the dizziness, the sensory loss, and the chronic pain syndromes in these people, or should they all be simply referred to a neurologist? I anticipate that many more will follow, as the vaccine is rolled out. This was only phase one,

- and the first dose.
- 4. In stark contrast to the deleterious effects of this vaccine in our community, we have not had to give any medical care what-so-ever, to anyone with Covid-19. So in our limited experience, this vaccine is quite clearly more dangerous than Covid-19
- 5. I realise that every medical therapy has a riskbenefit ratio, and that serious disease calls for serious medicine. But we now know that the



recovery rate of Covid-19, is similar to the seasonal flu, in every age category. Furthermore, it is well known that the side effects following the second shot, are significantly worse than the first. So the worst is still to come.

6. It must be emphasised, that these people were not sick people, being treated for some devastating disease. These were previously healthy people, who were offered an experimental therapy, with unknown long-term side-effects, to protect

- them against an illness that has the same mortality rate as the flu. Sadly, their lives have now been ruined.
- 7. It is normally considered a fundamental principle of medical ethics, to discontinue a clinical trial if significant harm is demonstrated from the treatment under investigation.
- 8. So my last question is this; Is it medically ethical to continue this vaccine rollout, in view of the severity of these life altering side-effects, after

just the first shot? In Lytton, BC, we have an incidence of 1 in 225 of severe life altering side-effects, from this experimental gene modification therapy.

I have also noticed that these vaccine induced side effects are going almost entirely unreported, by those responsible for the vaccine rollout. I am aware that this is often a problem, with vaccines in general, and that delayed side-effects after vaccines, are sometimes labelled as being "coincidences", as causality is often hard to prove. However, in view of the fact that this is an experimental treatment, with no long-term safety data, I think that perhaps this issue should be addressed too.

Furthermore, I have noticed that the provincial vaccine injury reporting form, which was clearly designed for conventional vaccines, does not even have any place to report vaccine injuries of the nature and severity that we are seeing from this new mRNA therapy.

It is now clearly apparent with medical evidence from around the world, that the side-effect profiles of the various gene modification therapies against Covid-19, have been vastly understated by their manufacturers, who were eager to prove their safety.

any nurses have called for lockdowns. We who our children." value freedom and human dignity are dismayed that media and politicians have used these siren calls to leverage the destruction of basic constitutional protections against arbitrary government force.

Across the globe, people were told they cannot go

to work, send their kids to school, attend a gym class, open their business, or even visit the playground. To justify this horrific government overreach, news and social media portrayed doctors and nurses crying and pleading for the public's compliance.

We must take a critical look at these fallacies of emotional appeal and bias.

An ICU nurse says, "If you had to see someone struggling to breathe as I have, then you would understand! I'm working on the frontline where people are suffering! You've never had to hold someone's hand while they take their last, dying breath! Please stay home for my sake and yours!"

Such whinging and pleading is a brazen appeal to emotion. By implication, because of suffering, basic principles of freedom must be squashed.

Guilt, anxiety, and fear are very powerful negative emotions. Consider the statement: "Who are you to think you should be allowed to get a haircut when it could result

in someone stuck on a ventilator in the ICU!" A statement like this arouses feelings of guilt.

Positive emotions can be weaponized too. An appeal to empathy or compassion comes in the form, "It might break your heart to see your children deprived of their little-league sports and forced to wear a mask, but just think about the elderly people or those with comorbidities, we need to care about them, not just ourselves and

In the above examples, appeal to emotion can override our sense of what is true. Hence, critical thinkers must ask questions of cause and effect. Does getting a haircut or my child playing T-ball truly cause someone to get stuck on a ventilator and die in ICU?

Seeing someone struggle to breathe and require



invasive medical procedures is stressful and perhaps traumatizing for nurses. However, dealing with these challenges is what critical care nurses signed up for. Yearly, critical care nurses and doctors might spend hundreds or thousands of hours in the presence of acute suffering where people are in pain and cannot breathe properly.

of reality. In the context of Covid19, the ICU nurse is spending their time seeing the worst of the worst victims. For multiple twelve-hour days a week, month after month, an ICU nurse sees the worst cases possible.

Seeing this devastation can lead to a cognitive bias. False extrapolation leads to the emotional conclusion that all cases look like this. Even though objective data

> demonstrates a recovery rate of well over 99% for Covid19, the ICU nurse is immersed in a context, day after day, where everyone is extremely sick and potentially dying.

> Witnessing the worst-case scenarios and a constant media and political campaign of Covid19, some nurses are tempted to go to media and emotionally bloviate about the need to "stay home and save lives" while neglecting the broader, negative impacts of prolonged shutdowns of society. But this kind of bias is not unique to the pandemic.

> For example, many obstetricians and maternity nurses believe home birthing children should be banned because they routinely witness worst-case birthing outcomes while ignoring the inherent risk associated with hospitals. Many pediatricians believe backyard trampolines should be banned because they treat the worst-case outcomes of trauma while ignoring the broader context of joy and

exercise they provide.

Sound public policy requires seeing the forest for the trees. With Covid19, our constitutionally protected freedom has been severely damaged by amplifying the cries of nurses working among the sickest trees while ignoring the health of the forest.

# Police in Alberta Actually 'Stole' A Church

n April 7 2021, the RCMP swarmed GraceLife Church in Edmonton, Alberta and proceeded to fence off the building, and eventually the entire church property.

This is in reaction to Pastor James Coates violating Alberta Health Services restrictions again and returning to the pulpit on March 28, a week after spending 35 days in a maximum security prison for this very same thing.

GraceLife Church is to remain closed until "it can demonstrate the ability to comply with AHS restrictions".

The church had previously defied AHS orders beginning in December, causing a closure order to be issued in January. In February, the church was charged with exceeding the allowable capacity of

The pastor was imprisoned and only released when he pleaded guilty to a charge of breaching bail. He was also fined \$1500 however, the judge stated his 35 days in custody would count as credit for the fine.

For weeks now, the property has dozens of officers standing on watch while a constant vigil of protestors, sometimes hundreds, gather at the roadside. The adjoining property is owned by a church member who has allowed the protestors to use his land in order to avoid fines.

The result is, instead of a short weekly gathering, there is now a large ongoing vigil of sometimes hundreds. Their plan to limit gatherings seems to

have backfired. Small church services have taken place there in the open field. Larger services have taken place at secret locations, to avoid \$1200 tickets, with several hundred in attendance.

Some incidents have arisen, including protestors mistakenly parking on First Nations lands, and a section of fence being pulled down on April 11. Protestors helped to restore the fence, realizing it's only symbolic of the greater issue. Tempers flared as opposing views were exchanged. It concluded with one of the instigators being charged by police.

Still now (April 24th) the church remains in police custody.

Incidentally, what is the cost of having 30 RCMP officers guard a church around the clock? Is this what we pay them for? Are there no real crimes happening anymore? Are we really ok with this?

Not far away though, thousands of people are shop-

ping at West Edmonton Mall everyday, but a few hundred people are forbidden from gathering for their weekly worship service.

The photo of the church wrapped with an 8 foot steel fence is shocking but serves as a perfect reminder of all our rights and freedoms that are in jeopardy. This goes beyond religious freedom. Every Canadian should be greatly offended and be speaking out, loudly, against such strong overreach by the government.

I really can't believe this is happening in Canada and



that there isn't more outrage over such a repulsive series of events. This police occupation of a church amounts to religious persecution!

Section 176 of the Criminal Code of Canada clearly states that a person who obstructs a religious service is guilty of an indictable offence and liable to imprison-

When did we stop following the rule of law in Canada? Pastor Coates now awaits his approaching trial on May 3 where he, and the church, will be represented by the Justice Centre for Constitutional Freedoms. (JCCF. ca) Although the JCCF has prepared extensive scientific and expert witness medical evidence, the defence is being denied the opportunity to challenge the constitutional validity of the chief medical officers orders. As well, the government will not be required to produce scientific evidence in support of CMO Deena Hinshaw's orders.

Lawyer John Carpay, president of the Justice Centre,

"After 13 months of violating Charter freedoms, the Alberta Government refuses to present evidence in support of lockdowns in Court, and unfortunately the courts have permitted the government to delay facing accountability in regard to Charter violations. Is it clear that the government's approach to any challenge to its lockdown policies is to withhold the evidence and delay as long as it can. By May 3, the government will have had 14 months to assemble proper

medical and scientific evidence to justify lockdowns and the resulting violations of our fundamental Charter freedoms. For the Alberta Government to request that it not be required to provide evidence on May 3 in support of Dr. Hinshaw's Orders, while at the same time barricading the church, is both reprehensible and pathetic.

The Alberta Government supposedly has enough medical and scientific evidence to shut down hundreds of small businesses, pushing many of them into bankruptcy, and to cancel over 20,000 medically necessary surgeries, and to force Albertans into a third lockdown. But when asked to produce this medical and scientific evidence at trial, the Alberta government declares itself incapable of doing so.

Pastor Coates is defending freedom of association and freedom of peaceful assembly, which are freedoms exercised by the entire population, not just churchgoers. This is likely the first time in Canadian history that a federal or provincial

government has directly restricted religious freedom. Unscientific and arbitrary health orders have been imposed by an unelected and politically appointed doctor, whose Orders are not scrutinized by elected Members of the Legislative Assembly."

So these folks hope to continue their vicious charade while making a mockery of the justice system. The public now knows they've been continually lied to throughout the past year. Maybe we can start placing bets on exactly which day this house of cards will collapse?

here an organism injures another there is abuse. One who suffers from sustained and repeated lockdowns is a victim of abuse.

Those in favor of sustained and repeated lockdowns support and perpetuate lockdown-induced depression, loneliness, decreased physical health, drug overdoses, suicide, mental health crises, spousal abuse, child abuse and marital breakdown.


It is true, abuse-denier: with respect to lockdown victims you're a victim-blamer, your views steeped in neither science nor soul.



# MISSISSIPPI LIFTED MASKS ORDERS MARCH 3 HOSPITALIZATIONS DOWN 56%



Since lifting all mask mandates March 3, Mississippi continues to see impressive declines in Covid-19 cases, hospitalizations and deaths.

Hospitalizations have dropped 56% since Mar. 3, and deaths have fallen from a 7-day moving average of 19 deaths per day on Mar. 3 to just 6 deaths per day on Apr. 22.

The decline in cases and severe outcomes cannot be attributed to vaccines, as only 21.9% of Mississippians have been fully vaccinated—well short of the WHO-recommended 70% to reach herd immunity.

# QUEBEC CONTINUES LOCKDOWNS CASES AND SEVERE OUTCOMES REMAIN LOW

There is no tsunami of cases or deaths and Quebec's hospital system is not overwhelmed. Yet, it remains one of the most severely locked down jurisdictions in North America with some regions having shuttered schools and businesses, imposed 8 p.m. curfews and masks orders outdoors.

Date of death


On April 15, the Quebec govt's data showed deaths per day at 15 and fewer since Feb. 13 from a peak of 68 deaths on Jan. 13. There were 664 hospitalizations (0.008% of population) and 167 people in intensive care (0.002% of population) in the province of 8,575,812 people.

Despite the encouraging scenario and cases remaining at just 1/3 of Ontario's with 1,527 cases reported Friday, Premier François Legault said Tuesday that Quebecers shouldn't expect a return to normal before the end of June. (Vaccinations do not account for the low cases and severe outcomes as just 2,223,775 doses have been administered, that is, less than 20% of Quebecers have been vaccinated—well short of the 70% recommended by the WHO.)

With increased reports of lockdown harms and no data to support severity of the  $3^{\rm rd}$  wave, what is the Quebec govt basing its intensified lockdowns on?

decided to terminate our services ... The LifeSkills Centre is challenging. Throughout elementary and high school, Isaac was usually left on the sidelines; other students,

> not understanding how to interact and involve a child with special needs, would enjoy their play and activities oblivious to him sitting alone. The day program he was in for the last three years with same-age peers was a God-send.

> I don't know exactly what led to the decision by the program leader. Was it fear, was it manipulation by the mainstream media, or is it becoming a given that the COVID shot will be required in order to receive services?

> Our non-political, previously non-activist family has been ignited. We have filed a Human Rights application, have been speaking and writing publicly, and have solicited the assistance of our Ontario Member of Provincial Legislature.

> There comes a time when one must take a stand. I have never been a public activist although I have advocated on behalf of my son for years. Now, I am publicly advocating for everyone,

States like Florida never imposed state-wide lockdowns or masks mandates and their cases continue to go down. Texas, Arizona and over a dozen others followed suit, all with similar results. In Belgium the people have even gone as far as challenging the government's system of implementing the lockdown measures with a lawsuit. They won, and the Belgian state was ordered to "lift all COVID-19 measures within 30 days".

If it is truly a matter of life and death then we must seriously examine the effects that lockdowns have on our society. It's time we analyzed these reactionary measures from a risk perspective. 

## A List Of Some Of The Most Absurd Things That Have Happened In Recent Weeks

- Forbes estimates the world's billionaires are worth a combined \$13.1 trillion, and are a "staggering 86% richer than a year ago." Forbes also reports its annual list of the world's billionaires "exploded" over the past year to an unprecedented 2,755 people.
- After numerous reports in the US of people accidently being injected with a saline solution at vaccination centers, it was discovered that at least half a dozen people in Vaughan, Ontario were injected with saline instead of the COVID-19 vaccine.
- Ontario's "emergency brake" plan, introduced on April 3 prohibits virtual concerts from taking place in local
- Face masks that were distributed throughout Canada, including millions sent to schools and daycares across Quebec, are being recalled after a toxic carbon coating was found on the mask's surface. The grey and blue masks, identified by the code SNN200642 from the supplier Metallifer, are now being recalled after they were found to be coated with "Nanoform graphene." - · Anti-lockdown celebrity Chris Sky found out he has been added to Canada's "nofly" list, a list reserved only for terrorists or suspected terrorists, after being barred from flying to Calgary to give a speech at a freedom protest.
- · A Montréal freedom protester was fined \$1546 for pulling his mask off for a few **seconds** to unlock his phone with facial ID. In Montréal, masks are required in outdoor public spaces. Montréal has issued millions of dollars worth of tickets at freedom protests in the past year.
- The European Medicines Agency (EMA) admits there is a 'clear' link between AstraZeneca's Covid vaccine (and likely J&J's vaccine) and a rare form of potentially deadly blood clots that has previously not been known to occur in healthy, unmedicated people. Experts believe the jab may cause the body to produce antibodies - normally used to fight off viruses - which mistake platelets in the blood for foreign invaders and attack them. - Despite stay-at-home orders being in effect for Ontario due to "overwhelmed hospitals," Sunnybrook's COVID field hospital (built weeks before the current lockdown) has yet to see a single patient.
- Trudeau has announced a deal with Pfizer for millions of boosters shoots through till 2024.
- Vitamin D is "fake news" according to our federal Health Minister Patty Hajdu. Despite admitting that most Canadians have a deficiency, Health Canada

- doesn't actively recommend supplementing vitamin D, and vitamin D blood testing is not OHIP-insured (unless you have Osteoporosis or a similar condition). This isn't the first time Canadians have been told vitamins were fake news. Last year, Dietitians of Canada advised the public that "You cannot boost your immune system through diet. No specific food, supplement, or natural health product will prevent you from catching COVID-19. ... Please follow the advice of Public Health Officials. Do not spread misinformation."
- Biden administration has just spent 1 billion dollars on their vaccine propaganda campaign. He's also spending nearly \$3 billion to counter alternative news and



"anti-vaxxers."

- Israeli study finds that those who have received both doses of Pfizer's COVID-19 vaccine, and still got infected, were 8 times more likely to be infected with the South African variant compared to infected people who were unvaccinated. Infected people who received one dose of the vaccine were also more likely to get the UK variant. Pfizer is currently working on a 3<sup>rd</sup> booster shot to address these variants.
- YouTube finally admits their algorithms favors corporations/mainstream media and suppresses inde**pendent journalists** when searching for anything "news related." YouTube's CEO ironically stated in an interview that occurred days prior to her accepting the Freedom of Expression Award, (from a YouTube-funded First Amendment group), It's easy to "make up content and post it from your basement" so we boost "authoritative
- It has been revealed in legal documents that the US post-

- of Americans who are "anti-lockdown" and reporting those individuals to federal, state, and local law enforcement. They claim to be doing this to "proactively identify and assess potential threats to the Postal Service, it's employees and customers, and its overall mail processing and transportation network."
- Canadian government is introducing an internet control bill. The first of its kind legislation, if successful, will force social media platforms to remove content deemed harmful (including "hurtful" language against politicians) "within 24 hours of having it being flagged." The heritage minister explained that "ultimately" the goal of tighter internet control "is to create a safer environment for all people online."

The CDC finally admits: intense disinfectants are likely doing more harm than good: "Fogging, fumigation, and other such theatrical performances of industrial cleanli-

ness can easily do more harm than good when it comes to human health."

A senior Ontario government source says schools are safe despite The Ontario Teacher's Federation "obstruction (to restart school) at every possible step." The federation, who also owns the Cadillac Fairview Corporation, owns stocks in a handful of vaccine manufacturers, including: Pfizer, Moderna, and Johnson & Johnson, as well as big box stores like Costco. The Teacher's fund closed out 2020 with net assets of \$221.2 billion, up \$13.8 billion from a year earlier.

- Mere days after Ontario Premier Doug Ford implemented provincial border checkpoints, Ottawa police announced they will cease 24-hour checkpoints between Ottawa and Quebec after lineups grew to 13km long. They will instead be conducting "rotating checkpoints" throughout the city as only "essential traveling" is allowed. OPP are still conducting armed checkpoints at the Manitoba-Ontario border.
- Over 87,000 Americans died of overdoses in the 12 months leading to September 2020, a 30% increase from the previous year, according to newly released US federal data. An increase in drug use, combined with the closing of drug abuse programs, and using alone is thought to have led to this increase. The biggest spike occurred in April and May, when shutdowns were strictest.
- Peel Police suspended Sgt. Paul Brown after hugging and agreeing with human rights protesters outside of Huf Gym, just outside of Toronto.
- At least 55 of America's largest corporations paid no taxes last year on billions of dollars in profits. 26 of the companies listed, including FedEx, and Nike, are among those found to have avoided paying any federal income tax for at least 3 straight years, even though they reported a combined income of \$77 billion. The biggest upward transfer of wealth in American history, the \$2.2 trillion CARES ACT, passed last year to help business survive the pandemic restrictions, included a provision that allowed businesses to use losses in 2020 to offset profits earned in previous years.
