The Birth of Medical Segregation in North America

Under the guise of 'the greater good,' there is an effort to impose the injection of experimental medical treatment of unknown safety and efficacy upon every individual on the planet. Those who exercise their inherent right to informed choice by not receiving the COVID vaccine have become the latest target of public enmity.

We are at a crucial time in the history of humanity. Never have bodily sovereignty, informed consent, freedom of choice, parental rights, and democracy been under such threat. Idealists and fundamentalists are contributing to the detriment of humanity in their misguided efforts to do good and protect one another.

COVID vaccination enforced by government mandate would be highly unpopular. Instead of mandates, businesses, universities, colleges, and service providers have been deputized to use coercive measures as a means to enforce government edicts. Employees are now being forced to choose between their sovereignty and their livelihood. Students are forced to choose between a public education with their peers or no education, based on their vaccination status. Even professional athletes are forced to choose between either getting the injection or acquiescing to a series of measures designed to coerce all but the most fervent to accept the shots.

We are witnessing the birth of a medical apartheid system in Canada, based solely on whether one has or has not participated in human trials for a genetic experiment.

Safety Concerns – No Medical Justification

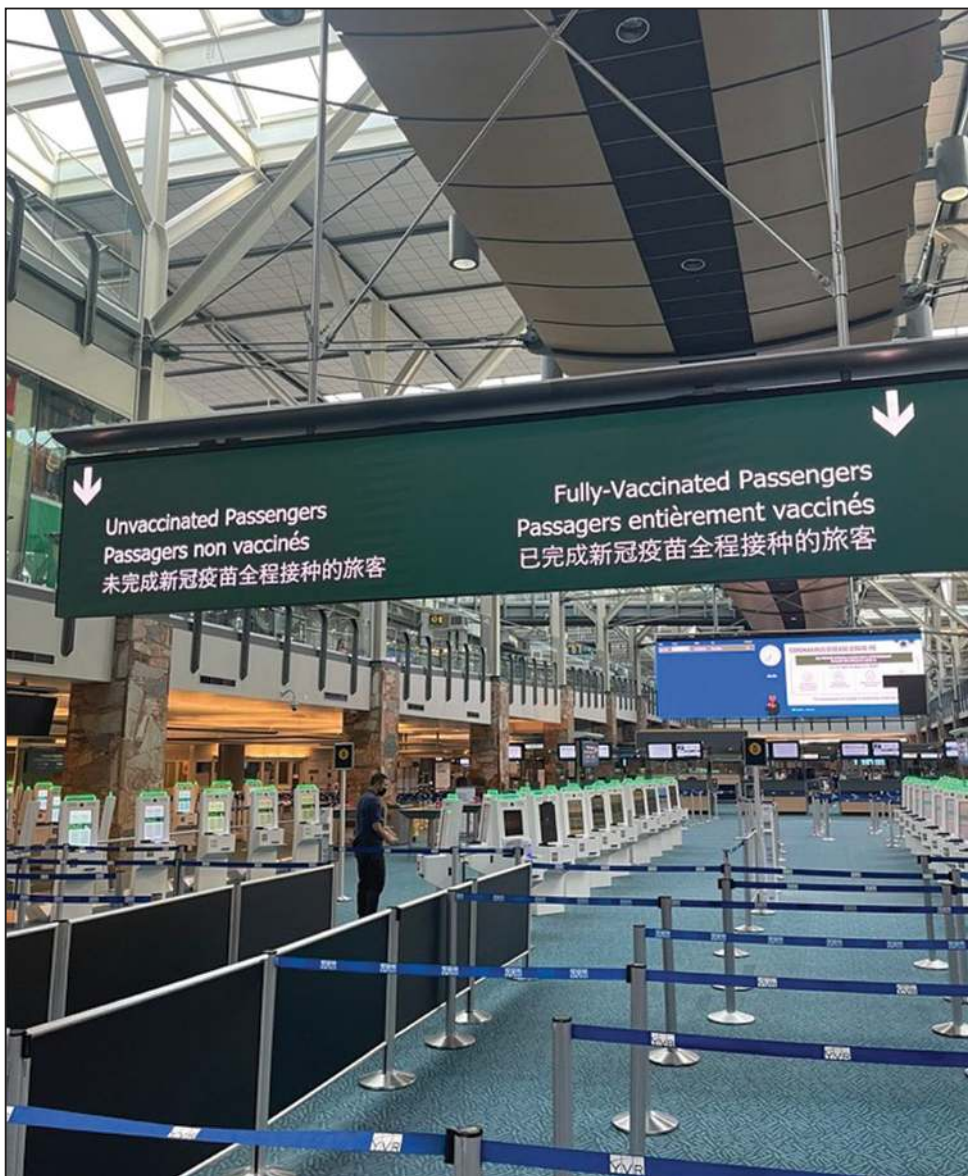
It is an intentional misrepresentation to call COVID injections vaccines when in fact they are medical devices that inject never before used synthetic genetic modification technology. COVID genetic treatments have not been formally approved and have not been adequately tested for safety. The long-term consequences of injecting this technology into the human body are unknown. Individuals receiving COVID injections are participating in human experimentation.

The purported reasons to receive COVID injections are two-fold. One advantage being sold is the idea of reduced risk of infection or transmission. The other selling point is the promise of reduced severity of symptoms should one be diagnosed with the illness named COVID. Neither of these governmental/pharmaceutical sales pitches is supported by medical evidence. In fact, the manufacturers of the COVID genetic treatment openly admit that their products do not prevent infection, nor have they been proven to prevent transmission.

It is important to note that the survival rate of the illness in the unvaccinated is 99.85% for all ages, and that there are numerous reports of previously healthy individuals coming down with COVID following inoculation.

Those who are truly concerned about those most vulnerable to COVID illness want everyone vaccinated, including those not at risk, despite the risk and dire consequences associated with these experimental injections.

Researchers and physicians across the world are ringing the alarm bells warning that COVID shots may

cause life-long injury and death, infertility, miscarriages, birth defects, and may alter human genetics.

VAERS data released July 16, 2021, by the CDC showed a total of 463,457 reports of adverse events from all age groups following COVID vaccines, including 10,991 deaths and 48,385 serious injuries between Dec. 14, 2020 and July 9, 2021. It is also acknowledged that less than 1% of vaccine adverse events are reported indicating that the true number of injuries and deaths may be 100X these numbers.

The evidence is clear that COVID injections are the most dangerous "vaccines" ever produced. More deaths have occurred following the COVID shots than the total number of deaths from all vaccines combined over a 30-year period.

Violation of Rights and Freedoms

Those participating in discrimination, segregation, and other coercive measures that remove the right to voluntary informed consent are agents in undermining essential individual rights and freedoms. To coerce or compel the acceptance of a medical product that has not been proven safe is dangerous and immoral. It also is criminal.

Those imposing vaccination requirements by means of coercion are effectively practicing medicine without a license. More disconcerting is that they are complicit in coercing the rapidly growing number of vaccine risk-aware citizens to violate their own right

of informed consent by submitting to these inadequately tested and fast-tracked experimental shots. Those complicit in this violation of our most basic human rights can be held accountable.

"Vaccine compliance elicited under threat of coercion, bullying, or suspension of rights and freedoms, constitutes an extreme bullying and coercion and is construed under Canadian Medical Law as a battery." – Lawyer, Rocco Galati

Discrimination against individuals who choose not to participate in medical experimentation violates our rights and freedoms and fundamental medical ethics. The intention of such discrimination is to arbitrarily restrict the rights and freedoms and demonize non-complying individuals. Such discrimination has no place in a free society.

To deprive employees, students, and consumers of their right to medical choice is to deny their sovereignty over their own bodies. The protection of bodily sovereignty and informed consent is legally guaranteed under provincial legislation and in international covenants such as the Universal Declarations of Bioethics and Human Rights, and the Nuremberg Code.

The Universal Declaration of Bioethics and Human Rights describes consent as follows: *"Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be expressed and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice."*

The Nuremberg Code, developed in response to the medical abuses of the Nazi regime, describes informed voluntary consent as *"the person involved... should be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior forms of constraint or coercion."*

Conclusion

Discrimination and segregation based upon one's medical choice is an unconscionable violation of the rights and freedoms of every Canadian. Current restrictions based on COVID vaccination status being promoted by businesses, universities, colleges, organizations, and associations clearly are a mechanism of intimidation and coercion that will serve only to increase the profits of the pharmaceutical industry and its bedfellows.

There is no evidence base that shows that demanding COVID shot compliance protects human health. Worse, acceptance of an experimental medication via coercion puts health and liberty in jeopardy and places vaccine compliance enforcers in a position of criminal liability.

There is absolutely no justification that could possibly legitimize this violation of our inherent rights and freedoms. Discrimination and segregation are unacceptable, no matter how they are marketed.

Discrimination: Does It Never End?

I remember the first time I experienced discrimination; I remember the visceral emptiness in my stomach. I was a child growing up in 1980's London (UK). Without provocation, an older boy approached me in the school playground and asked me, "Oi! What are you? Are you half-cast or something?" I had never heard the term 'half-cast' before and had no idea what it meant. Despite this, the derogatory and aggressive question elicited the intended feeling. My stomach sank, and I somehow felt less than, unsure of myself. That night's conversation over dinner stripped a layer of innocence away as my parents revealed that I was likely to be treated differently due to the colour of my skin and texture of my hair. My father laid down a litany of his negative experiences living in England since the early 60's, from having a failed paper in college overturned to a distinction by an independent review, to the signs on the doors of pubs stating "No Blacks, No Dogs, No Irish!"

Racism and discrimination were par for the course growing up in London in the 80's. You just dealt with it, eventually being called the 'N' word had zero to little effect. However, I never expected to experience it from my own people. As I got older and gained acceptance into private school, suddenly I wasn't 'black' enough. My parents always insisted that I spoke 'properly' and they did not tolerate cockney slang. In the early 90's I picked up a job at a local liquor store, where another incident occurred that would profoundly affect me. One evening a Jamaican man walked into the store. He brought his beer cans to the check out, looked at me disdainfully, and aggressively stated, "You know white bwoy cyan 'av 'airstyle like dat!" (I had a high top fade.) There was that feeling again: I felt the nasty intent. Why was this man attacking a teenager for his hairstyle? Perhaps, judging by his thick accent, he felt insecure in a foreign country and chose to project that insecurity. That was the last time I felt that emptiness inside; in fact, it was the catalyst for me accepting myself just the way I am.

You can imagine my shock when an emotion long forgotten, filed away under 'ancient history' resurfaced. At first I couldn't identify the feeling in my stomach. But as a familiar whiff of perfume or cologne sets the mind racing to identify a distant memory, I looked inward. There it was again: I was being discriminated against. But how could this be? In Canada, in 2021?

My children and I were recently walking through the lobby of our building, unmasked. As we approached the elevator area, a woman engaged in conversation shouted for all to hear, "You'd better back up, they're not masked!" I was instantly aware of my children's discomfort. What were we, some kind of sub-human pariahs? The intent was vicious, the tone rude and disrespectful. Then, as the media circus continued to whip up the uninformed populace into a fear frenzy, I noticed that people started to become more vocal in public spaces when I didn't wear a mask. Recently, I entered the elevator and courteously held the door open for a woman following behind me. She was about to get on the elevator and stopped herself and said in a derogatory fashion, "Oh no, you're not wearing a mask!" I replied, "But yours works, right?" If looks could kill, I would be playing a harp on a cloud right now. Her glare was hateful.

Where is the Canada to which I emigrated in the mid 90's? The open, friendly, tolerant, accepting, multicultural Shangri-La, where when someone asked where I was from they were genuinely interested in where I was from? What happened in sixteen months to the calm, peaceful inclusive society that was the envy of the world? People from all over the world have fled oppressive communist regimes to find their freedom in this amazing country. Yet here we are, sixteen months after "Just two weeks to flatten the curve," a society transformed and divided. Labels bandied about with irreverent carelessness: 'Anti-masker,' 'Anti-vaxxer,' 'Conspiracy theorist.' The age-old 'divide and conquer' playbook plays out in predictable fashion. Are we so malleable, so programmable, so easily controlled through behavioural modification techniques and neuro-linguistic programming? How did a society turn on itself within a year? Families and friends at odds, intolerance and judgement based on pseudo-science, rhetoric and hyperbole? What happened?

In 1987, I had the opportunity to visit Israel. I have a certificate stating that I am a Pilgrim of Jerusalem. In order to have that distinction, a number of sites have to

be visited and studied; one of which was Yad Vashem. Not one person exited the museum with a dry eye the day I was there. The overriding consensus was that this heinous crime, this colossal failure of humanity, must never be allowed to be repeated. The coach ride back to

the hotel was silent.

When societies would rather conform and 'virtue signal' to avoid the oppression their silence and complicity enables, personal liberty is in perilous jeopardy. When an individual judges another individual based on superficial information, it is discrimination. Discrimination has always been an effective tool to maintain the hegemony that has dominated this planet for so long. 'Un-masked' and 'un-vaccinated' are just the latest linguistic weapons in the repertoire of societal prejudice that lends itself to fanaticism.

You see, the Holocaust didn't start with box cars, camps and showers. It started with fear, bigotry and intolerance. Slavery didn't start with ships, whips and plantations. It started with the misguided concept that one group of people is considered inferior or superior to another. The travesties of our human history have not solely been the result of an extraneous evil. Atrocities occur when good people turn their backs on their own inherent moral decency rather than stand up and do what is right.



AFLDS Seek To Immediately Revoke Emergency Covid Vaccine Use Based On Disturbing New Mortality Data

America's Frontline Doctors (AFLDS) yesterday filed a **motion seeking immediate injunctive relief** in Alabama Federal District Court to stop Emergency Use Authorization (EUA) of the experimental COVID-19 injections for three groups of Americans.

A knowledgeable AFLDS source inside the Centers for Disease Control (CDC) stated that deaths occurring within 72 hours of COVID-19 shot injection are significantly underreported in the publicly-available VAERS database maintained by the Federal Drug Administration (FDA). "This is shocking," the source said, "and informed consent, which is required under the law, is impossible when safety data is so misleading." **As of July 9th, reported deaths in VAERS totaled 10,991. Of those, 4,593 were within 72 hours of vaccination.** The CDC source has provided a sworn statement that the actual number of deaths are conservatively five times higher, meaning that as of publication, we are approaching at least 55,000 vaccine-related deaths.

The AFLDS lawsuit seeks to immediately stop any further use of the experimental COVID vaccines for the following three groups:

Group (1): Young people 18 years of age and under. Children are at statistically 0% risk of death from COVID-19. By contrast, expert studies show that the number killed by the vaccines is well into the tens of thousands, and those injured is well into the hundreds of thousands. AFLDS Communications Director Dr. Teryn Clarke said: "Children are one-third of our population and all of our

future. Children are never the experiment."

Group (2): All those who have already recovered from COVID-19. Natural immunity is superior to manufactured immunity. In addition, the vaccines can trigger a dangerous and deadly hyper-immune response in people with immunity.

Group (3): Every other American who has not yet received informed consent, as defined by Federal law. It is unlawful, and unconstitutional, to administer experimental agents to individuals who cannot make an informed decision as to the true benefits and risks of the vaccines. They must be of an age or capacity to make informed decisions, and they must be provided with all of the risk/benefit information necessary to make an informed decision.

One of the named plaintiffs, Deborah Sobczak, the mother of a 15- and 17-year-old, said: "My child will not be the subject of an experiment. What kind of monsters are we allowing to control us? Perfectly healthy children have developed heart inflammation, brain bleeding, and even died! I have had enough. I am not sacrificing my child so a pharmaceutical company can experiment on her. This madness has to stop."

AFLDS Legal Director Ali Shultz, JD, said: "Preserving Americans' God-given and constitutionally-protected freedoms, including a doctor's free speech ability to provide honest information to a patient, so the patient (or minor patient's parents) can decide whether to freely consent, is AFLDS' mission."

Does Common Sense Still Exist?

7 Common Sense Questions

After a year of constant fear-mongering, fact-checking, and cancel-culture-ing, is our common sense still intact? Or did Big Brother somehow succeed in robbing us of this important tenet of critical thought? Let's ask some explorative, common-sense questions to find out.

POINT OF CONSIDERATION:

While many people over the course of the pandemic have compared lockdowns to putting on a seatbelt before a car accident occurs rather than after, an NCBI study entitled “Forecasting for COVID-19 has failed” speaks to this point saying: “Prolonged draconian lockdown is not equivalent to seat belts. It resembles forbidding all commute.”

►WOULD YOU INTENTIONALLY ABUSE YOUR CHILD BY LIMITING THEIR OXYGEN INTAKE, SOCIALIZATION, EDUCATION, AND PHYSICAL ACTIVITY?
ANSWER:

Of course not! You love your child. You’d understand that their brains are growing and developing and that they need friends, schooling, and extracurricular activities in order to stay physically, emotionally, and mentally healthy.

POINTS OF CONSIDERATION:
1) Masking children limits their oxygen intake. A JAMA Pediatrics Randomized Clinical Trial entitled “Experimental Assessment of Carbon Dioxide Content in Inhaled Air With or Without Face Masks in Healthy Children” states:

“This [masking] leads in turn to impairments attributable to hypercapnia. A recent review concluded that there was ample evidence for adverse effects of wearing such masks. We suggest that decision-makers weigh the hard evidence produced by these experimental measurements accordingly, which suggest that children should not be forced to wear face masks.”

2) Limiting the social and educational opportunities of children is harmful to their development and well-being. The conclusion of an NCBI article entitled “Impact of COVID-19 and lockdown on mental health of children and adolescents: A narrative review with recommendations” states:

“The containment measures like school and activity centers closures for long periods together expose the children and youth to the debilitating effects on educational, psychological, and developmental attainment as they experience loneliness, anxiety, and uncertainty.”

►WOULD YOU TRUST YOUR GARAGE IF THEY RAN THEIR DIAGNOSTIC TOOL LONGER THAN RECOMMENDED, RESULTING IN FALSE POSITIVES?
ANSWER:

Of course not. You’d realize that this would lead to all sorts of wasted money, resources, and time, and you’d also question the morals and intentions of your mechanic.
POINT OF CONSIDERATION:

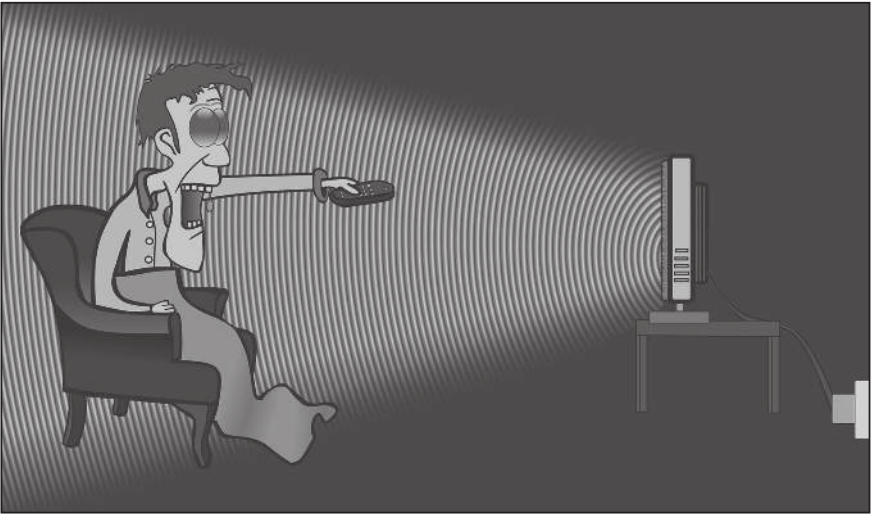
Despite the warnings from several prominent experts (i.e. Michael Mina, epidemiologist; Juliet Morrison, virologist; Carl Hanegan, Oxford professor) stating that the cycle threshold for PCR tests (the test used to diagnose COVID) should be cut off around 30-35 cycles, many labs are continuing to cycle their tests up to 40 cycles.

Even Dr Tony Fauci states: “If you get a cycle threshold of 35 or more, the chances of it being replication-competent are miniscule. You almost never can culture virus from a 37 threshold cycle, even 36, it’s just dead nucleoids, period.”

Of course not. If you were brave (unwise?) enough to trust them at all, you’d at least wait until long-term data was available before using their new product.
POINT OF CONSIDERATION:

Both Johnson and Johnson and Pfizer (two of the leading COVID jab manufacturers) have abysmal safety track records - thousands upon thousands of serious, safety-related lawsuits. Pfizer, in fact, had the (dis)honour of being rated as “least reputable pharmaceutical company” (according to public perception) on RepTrak.com’s 2017 and 2018 reputation lists. Johnson and Johnson have also made such a (in)famous name for themselves that there is



an entire website dedicated to their lawsuits and failures: johnsonandtoxin.com

►WOULD YOU TRUST YOUR LIFE SAVINGS TO A FINANCIAL ADVISOR WHO HAS YET TO SUCCESSFULLY INVEST MONEY ONE TIME?
ANSWER:

Of course not. Before investing you’d spend plenty of time researching the names of reputable investors, looking for those who have a solid history of experience and success.

POINT OF CONSIDERATION:
In stark comparison to Pfizer and Johnson and Johnson’s atrocious track records, Moderna’s—(one of the other major COVID jab manufacturers)—track record is clean! That is, because they don’t have a track record. At all. Moderna has never successfully made a pharmaceutical drug, and this “vaccine” is their first vaccine (though it, more appropriately, should be called mRNA therapy). The garden started as rocks with a little bit of dirt. We hauled in plenty of dirt and manure over the years and produced our own compost as well. It has been a labor of love and we have even lost an entire harvest as a learning lesson along the way.

That is what freedom is. The ability to say, “No, I am not done with this life. My best years are ahead of me and I am going to take charge of my own life and become as self-sufficient as I can.”

You have the freedom right now to start over no matter your station or disabilities. You can purchase a piece of land and make a homestead out of it and create something out of nothing.

Now, you can't do that everywhere in America anymore. And that is our own fault. But you can still build the American dream out of nothing but a scrap of land if you seek it. Then, you can truly experience the concept of personal sovereignty.

Can you experience freedom without owning land? Sure, you can also experience music without going to a concert. But once you experience the real deal you understand it on a whole new level, and anything less is somehow less satisfying. By striving to be self-sufficient in our family's food production, I have learned that you can't have liberty without responsibility. That is what freedom means to me.

Majority Of Physicians Decline Covid Shots, According To Survey

Of the 700 physicians responding to an internet survey by the Association of American Physicians and Surgeons (AAPS), nearly 60 percent said they were not “fully vaccinated” against COVID.

This contrasts with the claim by the American Medical Association that 96 percent of practicing physicians are fully vaccinated. This was based on 300 respondents.

Neither survey represents a random sample of all American physicians, but the AAPS survey shows that physician support for the mass injection campaign is far from unanimous.

“It is wrong to call a person who declines a shot an ‘anti-vaxxer,’” states AAPS executive director Jane Orient, M.D. “Virtually no physicians are ‘anti-antibiotics’ or ‘anti-surgery,’ whereas all are opposed to treatments that they think are unnecessary, more likely to harm than to benefit an individual patient, or inadequately tested.”

The AAPS survey also showed that 54 percent of physician respondents were aware of patients suffering a “significant adverse reaction.” Of the unvaccinated physicians, 80 percent said “I believe risk of shots exceeds risk of disease,” and 30% said “I already had COVID.”

Other reasons for declining the shot included unknown long-term effects, use of aborted fetal tissue,

“it’s experimental,” availability of effective early treatment, and reports of deaths and blood clots.

Of 560 practicing physicians, 56 percent said they offered early treatment for COVID.

Non-physicians were also invited to participate in the survey. Of some 5,300 total participants, 2,548 volunteered comments about associated adverse effects of which they were aware. These included death, amputation, paralysis, stillbirth, menstrual irregularities, blindness, seizures, and heart issues.

“Causality is not proven. However, many of these episodes might have resulted in a huge product liability or malpractice award if they had occurred after a new drug,” stated Dr. Orient. “Purveyors of these COVID products are protected against lawsuits.”

The Association of American Physicians and Surgeons has represented physicians in all specialties since 1943. Its motto is *omnia pro aegroto*, everything for the patient.

Depopulation In The Transhumanist Age

“It couldn’t happen again.” “No one is that evil.” “That’s just a conspiracy theory...” Things shifted recently from Orwell and Huxley to, well, Kafka. He sensed what was coming. In his bones. Someone recently suggested I suffer from survivor’s guilt. I realize she’s right, and things are just getting started.

Gregory H. Stanton, president of Genocide Watch and research professor in Genocide Studies and Prevention at George Mason University in Arlington, Virginia, lists 10 steps in destroying a population or culture. Starting with “classification,” we move through symbolization and discrimination to dehumanization, organization, polarization and preparation, to the final stages of persecution, extermination and (finally) denial.

We’re far along that path. The unsanitary — the unclean — are identified not by a Yellow Star. It’s about what they’re not wearing. The mask. In place of racial hygiene we have injections. Instead of bullets and gas we have graphene oxide and spike proteins. Children with clots.

This never gets on CNN or the BBC. But it’s to be found.

An old memory surfaces — the experience that made me a lifelong student of genocides. An afternoon in 1981 found me reviewing old microfiche in Robarts Library as part of my University of Toronto Holocaust course. One film clip featured German soldiers with civilians outside a walled medieval town somewhere in Eastern Europe. A woman undresses at gunpoint while holding her child. The scene ends just as you’d expect. To paraphrase W.H. Auden, the men and women lie upon the ground, neither awake nor asleep.

There have been many genocides just in the past 100 years. Rwanda. Cambodia. Armenia. Turtle Island. Tibet. Libya. The list goes on. The Holodomor was a famine that killed millions of Ukrainians between 1932 and 1933. The extent to which it was planned is hugely controversial. Millions died similarly when the British, under Sir Winston Churchill, redirected food from India

to Europe during World War Two.

destroying measures that have been put in place all over the world.

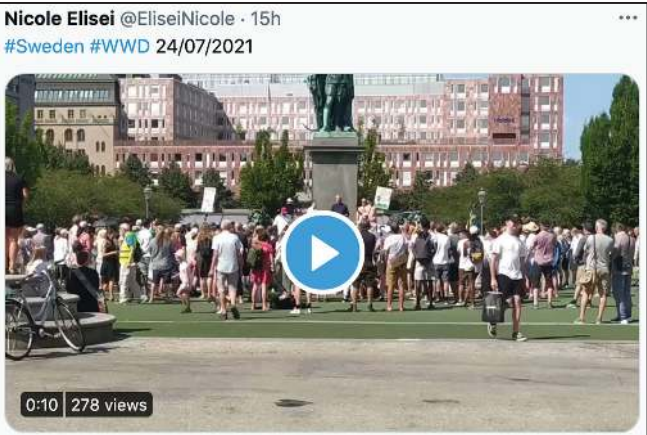

The Same Shady People Own Big Pharma And The Media

What does *The New York Times* and a majority of other legacy media have in common with Big Pharma? Answer: They’re largely owned by BlackRock and the Vanguard Group, the two largest asset management firms in the world. Moreover, it turns out these two companies form a secret monopoly that owns just about everything else you can think of too.

“The stock of the world’s largest corporations are owned by the same institutional investors. They all own each other. This means that ‘competing’ brands, like Coke and Pepsi aren’t really competitors, at all, since their stock is owned by exactly the same investment companies, investment funds, insurance companies, banks and in some cases, governments.

The smaller investors are owned by larger investors. Those are owned by even bigger investors. The visible top of this pyramid shows only two companies whose names we have often seen... they are Vanguard and BlackRock.

The power of these two companies is beyond your imagination. Not only do they own a large part of the stocks of nearly all big companies but also the stocks of the investors in those companies. This gives them a complete monopoly.

A Bloomberg report states that both these companies in the year 2028, together will have investments in the amount of 20 trillion dollars. That means that they will own almost everything.”

Who Are The Vanguard?

The word “vanguard” means “the foremost position in an army or fleet advancing into battle,” and/or “the leading position in a trend or movement.” Both are fitting descriptions of this global behemoth, owned by globalists pushing for a Great Reset, the core of which is the transfer of wealth and ownership from the hands of the many into the hands of the very few.

Interestingly, Vanguard is the largest shareholder of BlackRock, as of March 2021. Vanguard itself, on the other hand, has a “unique” corporate structure that makes its ownership more difficult to discern. It’s owned by its various funds, which in turn are owned by the shareholders. Aside from these shareholders, it has no outside investors and is not publicly traded.

“The elite who own Vanguard apparently do not like being in the spotlight but of course they cannot hide from who is willing to dig. Reports from Oxfam and Bloomberg say that 1% of the world, together owns more money than the other 99%. Even worse, Oxfam says that 82% of all earned money in 2017 went to this 1%.

In other words, these two investment companies, Vanguard and BlackRock hold a monopoly in all industries in the world and they, in turn, are owned by the richest families in the world, some of whom are royalty and who have been very rich since before the Industrial Revolution.”

While it would take time to sift through all of Vanguard’s funds to identify individual shareholders, and therefore owners of Vanguard, a quick look-see suggests Rothschild Investment Corp. and the Edmond De Rothschild Holding are two such stakeholders. Keep the name Rothschild in your mind as you read on, as it will feature again later.

The video found at <https://articles.mercola.com/sites/articles/archive/2021/06/15/does-vanguard-and-black-rock-own-the-world.aspx>, also identifies the Italian Orsini family, the American Bush family, the British Royal family, the du Pont family, the Morgans, Vanderbilts and Rockefellers, as Vanguard owners.

Blackrock/Vanguard Own Big Pharma

According to *Simply Wall Street*, in February 2020, BlackRock and Vanguard were the two largest shareholders of GlaxoSmithKline, at 7% and 3.5% of shares respectively. At Pfizer, the ownership is reversed, with Vanguard being the top investor and BlackRock the second-largest stockholder.

Keep in mind that stock ownership ratios can change at any time, since companies buy and sell on a regular basis, so don’t get hung up on percentages. The bottom line is that BlackRock and Vanguard, individually and combined, own enough shares at any given time that we can say they easily control both Big Pharma and the centralized legacy media — and then some.

Why does this matter? It matters because drug companies are driving COVID-19 responses — all of which, so

far, have endangered rather than optimized public health — and mainstream media have been willing accomplices in spreading their propaganda, a false official narrative that has, and still is, leading the public astray and fosters fear based on lies.

To have any chance of righting this situation, we must understand who the central players are, where the harmful dictates are coming from, and why these false narra-



tives are being created in the first place.

As noted in Global Justice Now’s December 2020 report “*The Horrible History of Big Pharma*,” we simply cannot allow drug companies — “which have a long track record of prioritizing corporate profit over people’s health” — to continue to dictate COVID-19 responses.

In it, they review the shameful history of the top seven drug companies in the world that are now developing and manufacturing drugs and gene-based “vaccines” against COVID-19, while mainstream media have helped suppress information about readily available older drugs that have been shown to have a high degree of efficacy against the infection.

Blackrock/Vanguard Own The Media

When it comes to *The New York Times*, as of May 2021, BlackRock is the second-largest stockholder at 7.43% of total shares, just after The Vanguard Group, which owns the largest portion (8.11%).

In addition to *The New York Times*, Vanguard and BlackRock are also the top two owners of Time Warner, Comcast, Disney and News Corp, four of the six media companies that control more than 90% of the U.S. media landscape.

Needless to say, if you have control of this many news outlets, you can control entire nations by way of carefully orchestrated and organized centralized propaganda disguised as journalism.

If your head is spinning already, you’re not alone. It’s difficult to describe circular and tightly interwoven relationships in a linear fashion. The world of corporate ownership is labyrinthine, where everyone seems to own everyone, to some degree.

However, the key take-home message is that two companies stand out head and neck above all others, and that’s BlackRock and Vanguard. Together, they form a hidden monopoly on global asset holdings, and through their influence over our centralized media, they have the power to manipulate and control a great deal of the world’s economy and events, and how the world views it all.

Considering BlackRock in 2018 announced that it has “social expectations” from the companies it invests in, its potential

role as a central hub in the Great Reset and the “build back better” plan cannot be overlooked.

Add to this information showing it “undermines competition through owning shares in competing companies” and “blurs boundaries between private capital and government affairs by working closely with regulators,” and one would be hard-pressed to not see how BlackRock/Vanguard and their globalist owners might be able to facilitate the Great Reset and the so-called “green” revolution, both of which are part of the same wealth-theft scheme.

Blackrock And Vanguard Own The World

In all, BlackRock and Vanguard have ownership in some 1,600 American firms, which in 2015 had combined revenues of \$9.1 trillion. When you add in the third-larg-

est global owner, State Street, their combined ownership encompasses nearly 90% of all S&P 500 firms.

BlackRock/Vanguard also own shares of a long list of other companies, including Microsoft, Apple, Amazon, Facebook and Alphabet Inc. As illustrated in the graphic of BlackRock and Vanguard’s ownership network below, featured in the 2017 article “These Three Firms Own Corporate America” in *The Conversation*, it would be near-impossible to list them all.

In all, BlackRock and Vanguard have ownership in some 1,600 American firms, which in 2015 had combined revenues of \$9.1 trillion. When you add in the third-largest global owner, State Street, their combined ownership encompasses nearly 90% of all S&P 500 firms.

A Global Monopoly Few Know Anything About

HeartMath tools, technology, and training teach people to rely on the intelligence of their hearts in concert with that of their minds at home, school, work, and play.

It’s becoming clearer to many of us that working together with kindness, compassion and acceptance are the missing pieces for resetting humanity’s fast and furious trajectory into separation and division. It’s also becoming obvious that we cannot create solutions from the same consciousness level that’s creating the problems. Raising our consciousness vibration for drawing peaceful solutions is an undertaking that calls for kindness, forgiveness and an inclusive love that respects our differences.

A large portion of their research has investigated heart and brain interaction. Researchers have examined how the heart and brain communicate with each other and how that affects our consciousness and the way in which we perceive our world. For example, when a person is feeling really positive emotions like gratitude, love, or appreciation, the heart beats out a certain message. Because the heart beats out the largest electromagnetic field produced in the body, it can yield significant data for researchers.

HeartMath has discovered that emotional information is actually coded and modulated into these fields. Did you know that in fetal development, the heart forms and starts beating before the brain is developed? Did you know that a mother’s brainwaves can synchronize to her baby’s heartbeats? Did you know that the heart sends more information to the brain than vice versa?

I recently came across an article published by HeartMath titled “Raising Our Vibration Through Compassion & Unconditional Love” written by Sara Childre, Pres. of HeartMath Institute and Doc Childre, HeartMath Founder. I thought I would post it below for those who are interested.

Vibrations

HeartMath and many systems use the term *vibration* in reference to the quality of thoughts, feelings, emotions and attitudes that are generated and influenced by our beliefs, memories, choices, environmental stimuli and more. For example, you often hear people say, “I had to leave that office, the vibes were so low it was draining my energy, or, “I felt a lift from being in her positive *vibration*.”

The vibration of our moods, attitudes, thoughts and feelings can rise and fall throughout the day, based on our actions and reactions to others, ourselves, or to life’s issues. The vibes we emanate to others and to the environment vary, based on our resilience for balancing our mind, emotions and disposition – especially in today’s

dynamic emotional climate.

Lower-level vibrations can occur at every turn in connection with frustration, anger, disappointment, sadness, judgment, comparisons and much more. These emotions are part of being human, but it is within our power to shift out of these debilitating feelings into higher vibra-



tional attitudes and perceptions.

An easy way to maintain a higher vibration is to interweave the qualities of our heart in our connections and interactions. These heart qualities include love, care, compassion, kindness, appreciation, forgiveness, and more. Anyone who experiences these qualities knows their power to lift our feelings into a kinder and more stress-free outlook.

Raising Others’ Vibrations

For evidence that the heartfelt intentions of one individual can raise the heart vibration of others, HeartMath cites studies it has conducted. You may be familiar with the study in which a dog’s incoherent heart rhythms became coherently aligned with a boy’s heart rhythms as he radiated intentional love and care to his dog. Search “Josh and Mable” to read more.

Science tells us that human beings and all creatures radiate an electromagnetic field produced by the heart-beat. Our feelings broadcast like radio waves through this field. When you are in the presence of a group of friends, family or others, everyone’s thoughts, feelings and attitudes are intermingling in your immediate area — which HeartMath calls the *field environment*.

Another study, with 40 participants, explored the effects of being in a coherent field environment. The participants were divided into 10 groups of four people who were seated around a table. They were all connected to equipment that simultaneously measured their level of heart rhythm coherence. Three of the participants had been previously trained in the Heart Lock-In technique and were instructed to get into a coherent state at random times unknown by the fourth untrained person. Overall, as the coherent vibration of the three HeartMath-trained participants increased, the untrained person’s coherence level also measurably increased from being in that more coherent field environment.

Poised in Higher Vibrations

When poised in our higher vibration, we experience many benefits. Decisions and solutions flow more easily due to increased access to our heart’s intuitive wisdom; our discernment becomes more inclusive and our choices become clearer and more effective; it gets much easier to deflect frustration, anxiety, impatience and other chronic stress producers that strain our critical thinking and reasoning.

Most of us feel more self-secure when in our higher vibrational composure, yet it can be harder to maintain in the midst of challenges and ramped up stress. We can learn to lift our vibration to meet challenges by adding heart qualities of conscious care, kindness, gratitude or compassion in our interactions. As these qualities of love move through our system, it lifts our attitudes automatically for the highest way to deal with the situation at hand.

Unconditional love and compassion are among the highest vibrations of love and are not subject to precon-

ditions, limitations, or requirements of others. They serve the greater interest and benefit of all sentient beings and the environment in which they exist. Many people are realizing that unconditional love and compassion are from our higher consciousness potentials with the capacity for healing and attracting solutions for social transformation.

Uncountable numbers of people have experienced the benefits of compassion and more individuals are resonating with this powerful expression of love in these times of robust change. Practicing compassion is something we can do that benefits all, yet it takes heartfelt commitment to anchor this responsibility to the whole of which we are a part.

Summary of Benefits From Raising Our Vibration Levels

- Increased care and kindness flow more automatically in our connections.
 - We are more clear-minded and self-secure in our choices and actions.
 - Our mind and emotions interact more harmoniously to suit our needs.
 - We deflect common stress triggers – frustration, impatience, intolerance, etc.
 - We are much more resilient and resistant to fears and self-doubt.
- Our heart’s deeper care is not overridden by our disruptive mind and emotions.
 - The lift in our attitude wards off anxiety, excessive worries and overwhelm.
 - We tend to lift others and the environment when our vibration is up.
 - We are less judgmental and intolerant with others and ourselves, which prevents mega stress accumulation.
 - Lifting our vibration amplifies our intuitive heart feelings for better choices and outcomes.

Simple Exercises to Raise Your Vibration

(Adapted from exercises in the *Heart Intelligence: Connecting with the Intuitive Guidance of the Heart book*.)

How to replace lower vibrational feelings, such as sadness, anger, insecurity, anxiety, self-judgment, rejection, etc.

- 1. Exercise:** Find a quiet place where, for a few minutes, you can breathe easily, imagining with each breath that your mind, emotions and body are becoming still inside. In this stillness, desire the uplifting feeling you would like to have, and as you breathe, imagine breathing this new feeling into your being for a while. Imagine you are creating it with your breath.
- 2. Another Exercise:** When feeling low, just sit quietly and imagine radiating love, compassion and stillness into your mental and emotional nature. Self-care is often allowing ourselves to have a low moment without compounding it with self-criticism. When our light is dim, it helps to give ourselves the feeling of compassionate heart warmth that we would give a child or a pet that is infirm. Even if it doesn’t stop the pain, we know it can help energetically. If we feel awkward while trying this, it helps to ask ourselves, “What’s the difference in nurturing ourselves with compassionate intention or taking vitamins and healthfoods for self-care?” Or, “Why do we teach kids to put their hand over a hurt area and radiate sunshine from their heart to help it feel better?” We do this because it’s a natural expression of self-compassion, with benefits to their mental, emotional and physical nature.

You can soon feel a difference when doing these exercises, unless extremely challenged. If it doesn’t work the first time, be patient and simply try again later. Being genuine makes a difference. This activates your heart energy. Practicing for a few days in a row strengthens your capacity to reset unwanted feelings and lower vibrations.

Simple exercises such as these can do more to lift your vibration than you may think. Make it fun to consciously reset your vibration throughout the day and watch your spirit lift and the stress accumulation diminish.

Online Dating In A Twisted Covid World

Finding your soulmate or next lover is all about showcasing your best qualities as a human being to a potential partner. Dating app Bumble is now offering singletons the opportunity to inform would be lovers of their vaccination status in Australia and New Zealand. Users on the app can now add a “vaccination badge” to their profile.

A Bumble spokesperson said that the company will not independently confirm the vaccination standing of those who declare getting the vaccine which means the system of declaration is solely based on users honesty. Bumble added that the rationale for adding the vaccination badge status was in response to a survey which revealed a “45% increase in users asking potential dates if they had the vaccine or have covid symptoms”. Bumble currently enable users to share their dating preferences on issues like mask-wearing and social distancing.

A YouGov poll of nearly 5000 UK adults found that 28% would not date someone who has not received the jab with 2% indicating they would not date a potential partner if they did get the jab.

The normalisation of this intrusive and discriminatory “badge” has been welcomed and encouraged. Dr Rosalie Gillett, a postdoctoral analysis fellow at the Queensland University of Technology stated “As dating apps often encourage in-person interactions, users might feel safer meeting with people who say they have been vaccinated against covid”.

Competitors in the online dating world including Tinder are also planning to introduce the cringing vaccine badge category. In the US, The White House in partnership with many popular online dating platforms issued incentives to vaccinated users. White House advisor Andy Slavitt said, “We have finally found the one thing that makes us all more attractive: a vaccination”. The White House said the dating platforms will offer badges showing vaccination compliance, free access to “premium content like boosts, super likes, and super swipes” and filters to potential hook-ups based on their vaccination status. Super-likes increase your chances of being noticed on dating online platforms.

In the UK, the Department of Health and Social Care have introduced similar plans by teaming up with dating apps to encourage and promote vaccine uptake in young people.

This is another cynical ploy to divide people and incentivise them to get the jab by large multinational companies. If a self-declaration of current vaccine status is a priority when dating, one really has low standards. The covid clown world continues...

Irish Police To Be Granted Powers Allowing Access To Passwords For All Electronic Devices

A new policing Bill in Ireland will grant the Gardai (Irish Police) legal powers to demand personal passwords for phones and other electronic devices. Refusal to supply passwords to the Gardai could result in up to 5 years in prison and penalty fines ranging from 5000 Euros to 30000 Euros according to the new invasive legislation. The proposed Bill requires any person under warrant to supply the Gardai with pin numbers, passwords, or decryption keys on any IT device even in minor offences. The Garda Siochana (Powers) Bill will also allow the Gardai to have increased powers in relation to stop and search procedures.

Irish Minister for Justice Heather Humphreys justified the Bill by stating that “It would be relevant in child abuse investigations and in the investigation of economic crime and corruption”. She said the Bill will have a strong focus on human rights and on the procedural rights of the accused. The Minister went on to say that the new powers will allow the Gardai to access important information in a “timely and efficient way”.

The nature of the draconian Bill has been met with caution and concern over privacy and legal rights. Professor of Law and Chairman of Digital Rights Ireland TJ McIntyre stated that the powers granted to the Gardai were “extraordinarily invasive” and would allow them access to “the entirety of someone’s digital life”. The Irish Council of Civil Liberties (ICCL) are concerned with the Bill’s provision of seizing private and privileged personal information, while also stating that new guidelines that indicates that search warrants could be issued by Garda Superintendents, as opposed to judges, in “exceptional circumstances” is worrying, given those circumstances are currently not defined.

Big Brother is not only watching us all the time but now totalitarian State powers and 21st century policing methods can now access and view our private digital information even if minor offenses have been caused. Our lives have become increasingly digitalised and guidelines and laws to intrude and invade our digital privacy is a worrying development.

“Have The Vaccine Or I Will Jail You!” Says President of Philippines

Filipino President has threatened his citizens that he will jail anyone who refuses a covid vaccine. In a televised address, President Rodrigo Duterte told his nation, “You choose: vaccine or I will have you jailed”. Duterte’s tough words were in response to reports of low turnout at several vaccination centres across the capital Manila.

Duterte who is known for his straight-talking and bullish style issued more threats for anyone who refuses the experimental vaccine. He stated that “As long as you are here and you are a human being, and can carry the virus, get vaccinated. Otherwise, I will order all the village captains to have a tally of the people who refuse to be vaccinated. Because if not, I will have Ivermectin meant for pigs injected into you”.

His aggressive remarks are contrary to those of his health officials who have encouraged vaccine uptake but advised it is currently not compulsory. The Philippines has had a tough stance on covid with strict measures and lockdowns including the President’s decision to keep schools closed.

Duterte showed his dismay that many Filipinos would have the audacity to ignore government advice regarding covid and vaccines. He said, “I’m just exasperated by Filipinos not heeding the government”. The Filipino government hopes that this new low of scare mongering tactics will heavily influence its citizens to take the jab in large numbers.

Elected in 2016 after a landslide victory, President Duterte has established a controversial international reputation for his nonsense approach in tackling the war on drugs, crime, and corruption. His methods have drawn attention from Amnesty and from the International Criminal Court (ICC). In the same televised address, Duterte took aim at the ICC who have sought permission for a full inquiry into alleged state sanctioned murder by police during an anti-drugs campaign. “Why would I defend or face an accusation before white people? You must be crazy,” stated Duterte.

The ‘International Community’ has surprisingly been quiet regarding his veiled threats regarding vaccine compliance. Then again, scaremongering and threatening demands is the order of the day.

Mask Exemption For Business And First-Class Flyers When Seat Is Reclined To A Flat Position

Hong Kong airline Cathay Pacific have announced favourable and questionable mask exemptions for their business and first-class flyers. Passengers can now remove their mask when their expensive seat is reclined to a fully flat position. Passengers flying economy with Cathay Pacific are required to wear a mask for the duration of the flight.

Cathay Pacific have justified this absurd and bizarre waiver by stating that “seats in first and business class are more spacious with partitions, and passengers are exempted when lying flat for sleep”. The airline went on to say that when first or business class passenger’s seat is in the lounge or upright position, masks are required but not when the seat is in its lie-flat mode. A spokesperson for the airline also confirmed that its fleet of aircraft are equipped with filtration systems that are “capable of filtering 99.9999 percent of dust particles, including virus and bacteria”.

Qatar Airlines was the first airline to have lenient mask exemptions for business and first-class flyers. In a statement in June 2020, the airline said, “business class customers are asked to wear their face shield and mask onboard at their own discretion, as they enjoy more space and privacy”. Many view this brazen exemption and loophole as a cynical move to suit wealthy and privileged flyers. Healthline’s Chief Medical Officer Dr.Hanh Le has questioned the science behind it and branded the move a “business decision intended to encourage people to buy more expensive tickets without any foundation in science, evidence or safeguards”.

Covid moves in mysterious ways not just on planes but also on other forms of transport. Former Oasis guitarist Noel Gallagher has questioned the logic and rationality of wearing masks, especially on trains. He responded with calls to wear a mask on a train by saying “Oh right, this killer virus that’s sweeping through the train is gonna come and attack me, but see me having a sandwich and go, leave him, he’s having his lunch?”. Noel Gallagher went on to say that masks are “pointless” and “there’s too many liberties being taken away from us now”.

Flying first class is a luxury that many of us will never experience. This perk and mask exemption policy is another mocking example of a two-tiered system that suits the rich and powerful.

A List Of Some Of The Most Absurd Things That Have Happened In Recent Weeks

- The CDC's guide to "Preparing for a Hurricane or Tropical Storm" lists **the first step in preparing for a hurricane as: get a COVID-19 vaccine.**
- White House Press secretary Jen Psaki admitted in a White House Press Briefing **"we are flagging problematic posts for Facebook that spread misinformation."** She further admits that the White House is working with online influencers to provide them with "accurate information and boost trusted content." Furthermore, Psaki claims that people **"shouldn't be banned from one platform and not others for providing misinformation."**
- A man whose mask strap broke during a flight was **criminally charged with "mischief" for sneezing** on an Air Canada Flight.
- **Youtube censors video of Nobel prize winner Dr. Satoshi Omura for discussing ivermectin.** The Japanese biochemist won a Nobel Prize for his work that led to the development of ivermectin (which is now being described as a **"wonder drug"** for COVID-19 by the medical community, including a group of world experts known as the *Front Line COVID-19 Critical Care Alliance*). YouTube's **"Medical Misinformation Policy"** explicitly prohibits "claims that Ivermectin or Hydroxychloroquine are effective treatments for COVID-19."
- Leaked internal slides reveal **Canada plans on launching a national COVID-19 vaccine passport system** — but not until December 2021 at the earliest. The presentation, prepared by the Treasury Board of Canada, confirmed that the final product will follow the internationally recognized SMART Health Card standard.
- **France just approved a law restricting the unvaccinated from visiting the hospital.** France's new so-called "health law" obliges the French to get a health pass showing they have been vaccinated against Covid-19, or recently tested negative. Starting August 1st, the French population will have to show a COVID-19 health pass to enter restaurants, concerts, shopping malls, hospitals (for non-emergency procedures and visits), and to travel via trains or planes. **Italy has implemented a similar pass** known as the "green pass" and the **UK recently announced its "COVID status certification"** QR scanning app program.
- World renowned epidemiologist **John Ioannidis** published an article titled "Infection fatality rate of COVID-19 inferred from seroprevalence data" in the WHO's academic journal *Bulletin*, where he analyzed 61 studies. The analysis found that **the median COVID-19 infection fatality rate for people under 70 years was only 0.05%** (and 0.23% when corrected for all ages). The study also estimated that over half a billion people have been infected as of September 2020. If this is true, this would mean that COVID-19, while more prevalent than the seasonal flu, actually has a similar fatality rate to the flu after all. As NIAID director Dr. Fauci told CBS News on Feb. 16, 2020: "a very severe seasonal flu is 0.2% to 0.4%; regular seasonal flu is 0.1% or a typical pandemic like 1957 of 1968 is 0.5%-0.9%."
- **The Church of God in Aylmer, Ontario has been fined over \$200,000 for holding outdoor worship services.** The church has been holding outdoor services ever since their doors were locked on May 14, 2021 by the courts for not complying with public health orders.

- When discussing the banning of public gatherings, Robert Chief, **Health Officer of Nova Scotia**, admits that **"the other purpose of the injunction is to prevent groups that are deliberately spreading false information."**
- **BC apologizes for outing the unvaccinated.** The BC Government News' official blue-check Twitter account asked followers to "tag a friend or family member who still needs their first dose." In an effort to "help them register" for their vaccination appointment.
- **Pfizer is seeking U.S. authorization for a 3rd dose** of its COVID-19 vaccine, saying that another shot within

healthcare system cancelled non-essential procedures. Disruptions to healthcare have continued into 2021 as Ontario halted non-essential surgeries in April. Ontario estimates it will take 3.5 years to clear the backlog of surgeries.

- **1/3 of the world's population went hungry during the pandemic**, says the UN. The IFAD president, Gilbert Houngbo, said enough food was being produced to feed everyone and **the crisis is a failure in the food system.**

- **The Canadian Museum for Human Rights is now only welcoming fully vaccinated visitors** and children under 12. Ironically, their new policy is a violation of human rights.

- **Biden claims that social media platforms like Facebook are "killing people"** because **"the only pandemic is among the unvaccinated."** What Biden failed to mention is that a primary reason for this is because, earlier this year, the CDC announced it would stop recording COVID breakthrough infections (infections in vaccinated people) unless they result in hospitalization or death (whereas unvaccinated individuals who test positive for COVID-19 still count as a "case" even if they are asymptomatic). Additionally, new guidance was issued to laboratories recommending a reduction of the PCR test's Ct (cycle threshold) value to 28 cycles (from 40 cycles), but only for fully vaccinated individuals being tested for COVID. **The change in Ct value makes the tests wildly less sensitive for vaccinated people, while keeping the tests overly sensitive for unvaccinated people.** Both changes result in lower overall numbers of reports of **"breakthrough cases"** in the U.S. and a higher number of **"unvaccinated cases."** Nevertheless, **the US government allocated 4 billion dollars to fight vaccine hesitancy.**

- Even when adjusted for inflation, **the US has now officially spent more on the economic fallout of the Coronavirus than it spent fighting both world wars combined.**

- **Deaths from drug overdoses in the US soared to more than 93,000 last year**, a staggering record that reflects the pandemic's toll on efforts to quell the crisis and the continued spread of the supply. **The death toll jumped by more than 21,000**, or nearly 30 percent, from 2019, according to provisional data released by the National Center for Health Statistics, eclipsing the record set that year.

- **The Teletubbies got vaccinated!** They showed-off their "COVID-19 Vaccination Tubby Cards" on Twitter to prove that they were vaxxed with either "AstraTubbica" or "Noo-nson & Noo-nson."

- A study from researchers at the Hospital for Sick Children found that **more than half of children aged 8 to 12 reported clinically significant depressive symptoms during the second wave of the pandemic.** That number jumps to 70 per cent among adolescents surveyed.

- a member of the WHO investigation into the source of the pandemic that issued its report (saying the virus was "likely natural") earlier this year.

- **UK Government ministers are expressing concerns that COVID could be spread through farting.** They have pointed to evidence that suggests Covid-19 could be spread when an infected person breaks wind in a confined space such as a toilet.



12 months could dramatically boost immunity and may help ward off the Delta variant. Pfizer's own data is now showing that its vaccine immunity against the coronavirus declines in vaccinated people over time, particularly in the elderly. In Israel (the only country to have exclusively received the Pfizer shot) data shows **40% of recent COVID-19 cases were vaccinated** -mostly over 6 months ago. Compared to less than 1% who were unvaccinated but had previously tested positive.

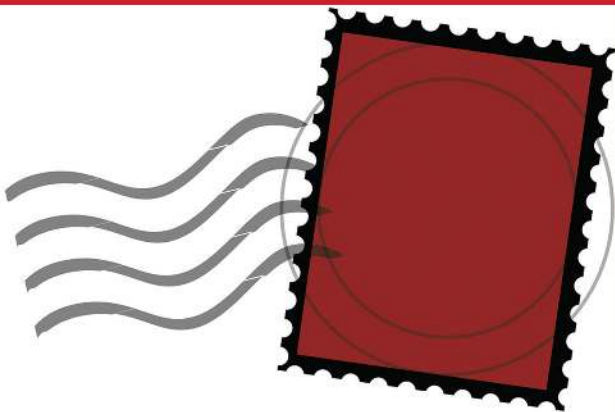

- **A journalist has been summoned to appear in court for the crime of committing journalism** during a state of emergency. The journalist was streaming live for Druthers and had their press badge, Druthers shirt, and Druthers mic flag visible the entire time.
