- 2. Following acceptance of this, the offer must be signed by a fully qualified doctor who will take full legal and financial responsibility for any injuries occurring to me, and/or from any interactions by authorized personnel regarding these procedures.
- 3. Please describe how side effects and injuries will be classified, documented and compensated as a

**medical or legal advice**, it is intended to give people some things to think about in their quest to say NO to these manipulative, coercive, wrong, illegal, immoral & downright evil tactics to push these vaccines on the people.

Some say the trick is to not decline, not to say no. Rather, it may be beneficial to negotiate and insist you be provided with some details and assurances before you agree. The following details and assurances cannot be given to you so this may result in a stalemate and you get left alone.

**Again, this is not legal or medical advice.** This is just another possible way for you to stand your ground and maintain your freedom of choice.



Another way to put this would be in the words of the ancient *Bhagavad Gita*, "Set thy heart upon thy work, but never on its reward. Work not for a reward; but never cease to do thy work. Do thy work in the peace of Yoga and, free from selfish desires, be not moved in success or in failure."

This approach to revolution is not satisfying for the ego, but, since the solution to our existential crisis likely sits on the other side of a massscale awakening from the egoic

consciousness which is the source of all our problems, this is perhaps as it should be.

## **Bill Gates – A Philanthropist?**

Scripture declares that "there is nothing new under the sun," and we see this truth verified in Bill Gates patterning himself after Rockefeller's template. In the words of James Corbett, "Like a true philanthro-capitalist, Gates' gener-

osity ends up benefiting himself most of all," as his foundation donates billions to the very same companies that it owns stocks and bonds in. No surprise then, that since he declared the Decade of the Vaccines in 2010, Gates has doubled his wealth.

## Indian Bar Association sues WHO scientist over Ivermectin

he Indian Bar Association (IBA) sued WHO Chief Scientist Dr. Soumya Swaminathan on May 25, accusing her in a 71-point brief of causing the deaths of Indian citizens by misleading them

about Ivermectin. Point 56 states, "That your misleading tweet on May 10, 2021, against the use of Ivermectin had the effect of the State of Tamil Nadu withdrawing Ivermectin from the protocol on May 11, 2021, just a day after the Tamil Nadu government had indicated the same for the treatment of COVID-19 patients."

Advocate Dipali Ojha, lead attorney for the Indian Bar Association, threatened criminal prosecution against Dr. Swaminathan "for each death" caused by her acts of commission and omission. The brief accused Swaminathan of misconduct by using her position as a health authority to further the agenda of special interests to maintain an EUA for the lucrative vaccine industry.

Specific charges included the running of a disinformation campaign against Ivermectin and issuing statements in social and mainstream media to wrongfully influence the public against the use of Ivermectin despite the existence of large amounts of clinical data showing its profound effectiveness in both prevention and treatment of COVID-19.

In particular, the Indian Bar brief referenced the peer-reviewed publications and evidence compiled by the ten-member Front Line COVID-19 Critical Care Alliance (FLCCC) group and the 65-member British Ivermectin Recommendation Development (BIRD) panel headed by WHO consultant and meta-analysis expert Dr. Tess Lawrie.

The brief cited US Attorney Ralph C. Lorigo's hospital cases in New York where court orders were required for dying COVID patients to receive the Ivermectin. In multiple instances of such comatose patients, following the court-ordered Ivermectin, the patients recovered. In addition, the Indian Bar Association cited previous articles published in this forum, The Desert Review.

Advocate Ojha accused the WHO and Dr. Swaminathan in Points 60 and 61 as having misled and misguided the Indian people throughout the pandemic from mask wear to exonerating China as to the virus's origins.

"The world is gradually waking up to your absurd, arbitrary and fallacious approach in presenting concocted facts as 'scientific approach.' While the WHO flaunts itself like a 'know it all,' it is akin to the vain Emperor in new clothes while the entire world has realized by now, the Emperor has no clothes at all."

The brief accused the WHO of being complicit in a vast disinformation campaign. Point 61 states, "The FLCCC and the BIRD have shown exemplary courage in building a formidable force to tackle the challenge of disinformation, resistance, and rebuke from pharma lobbies and powerful health interests like WHO, NIH, CDC, and regulators like the US FDA."

Dr. Swaminathan was called out for her

This has proved the hollowness of the WHO's recommendation against Ivermectin for Ivermectin areas of Delhi, Uttar Pradesh, Uttarakhand, COVID-19. The dishonesty of WHO and the act of Dr. Soumya Swaminathan in deleting her contentious



tweet was witnessed by citizens across the world, as the news got a wide coverage on social media. By deleting the tweet, Dr. Soumya Swaminathan has proved her mala fide intentions."

The entire world witnessed the effectiveness of Ivermectin against India's deadly second surge as the locations that adopted it saw their outbreaks quickly Originally published in TheDesertReview.com

Among the most prominent examples include the and Goa where cases dropped 98%, 97%, 94%, and 86%, respectively. By contrast, Tamil Nadu opted

Tamil Nadu publicly relied upon Dr. Swaminathan's advice in revoking their initial choice of Ivermectin the day after she recommended against it in her May 10 tweet on social media. As a direct result, Tamil Nadu experienced a surge in COVID death and sickness that continues to this day.

The Indian Bar Association dared to initiate a landmark court case against a Public Health Authority (PHA) to call out corruption and to save lives. As the courts in the United States proved to be the lifesaving force to ensure a patient's right to receive Ivermectin, a court in India is now doing the same.

Criminal prosecution of public health officials will send a powerful signal that disinformation campaigns resulting in death carry consequences. Perhaps this pathway will ultimately break the disinformation and censorship stranglehold

around repurposed drug use to save lives. Maybe we will witness other countries following India's example, both in medicine and in law.

## **Doctors Open Letter To The Unvaccinated**

CLA researcher Dr. Denis Rancourt and several fellow Canadian academics penned an open letter to support those who have decided not to accept the COVID-19 vaccine.

The group emphasizes the voluntary nature of this medical treatment as well as the need for informed consent and individual risk-benefit assessment. They reject the pressure exerted by public health officials, the news and social media, and fellow citizens.

You are not alone! As of July 28, 2021, 29% of Canadians have not received a COVID-19 vaccine, and an additional 14% have received one shot. In the US and in the European Union, less than half the population is fully vaccinated, and even in Israel, the "world's lab" according to Pfizer, one third of people remain completely unvaccinated. Politicians and the media have taken a uniform view, scapegoating the unvaccinated for the troubles that have ensued after eighteen months of fear mongering and lockdowns. It's time to set the record straight. It is entirely reasonable and legitimate to say 'no' to insufficiently tested vaccines for which there is no reliable science. You have a right to assert guardianship of your body and to refuse medical treatments if you see fit. You are right to say 'no' to a violation of your dignity, your integrity and your bodily autonomy. It is your body, and you have the right to choose. You are right to fight for your children against their mass vaccination in school. You are right to question whether free and informed consent is at all possible under present circumstances. Long-term effects are unknown. Transgenerational effects are unknown. Vaccineinduced deregulation of natural immunity is unknown. Potential harm is unknown as the adverse event reporting is delayed, incomplete and inconsistent between jurisdictions. You are being targeted by mainstream media, government social engineering campaigns, unjust rules and policies, collaborating employers, and the social-media mob. You are being told that you are now the problem and that the world cannot get back to normal unless you get vaccinated. You are being viciously scapegoated by propaganda and pressured by others around you. Remember; there is nothing wrong with you.

You are inaccurately accused of being a factory for new SARS-CoV-2 variants, when in fact, according to leading scientists, your natural immune system generates immunity to multiple components of the virus. This will promote your protection against a vast range of viral variants and abrogates further spread to anyone else.

You are justified in demanding independent peer-reviewed studies, not funded by multinational pharmaceutical companies. All the peer-reviewed studies of short-term safety and short-term efficacy have been funded, organized, coordinated, and supported by these for-profit corporations; and none of the study data have been made public or available to researchers who don't work for these companies.

You are right to question the preliminary vaccine trial results. The claimed high values of relative efficacy rely on small numbers of tenuously determined "infections." The studies were also not blind, where people giving the injections admittedly knew or could deduce whether they were injecting the experimental vaccine or the placebo. This is not acceptable scientific methodology for vaccine trials. You are correct in your calls for a diversity of scientific opinions. Like in nature, we need a polyculture of information and its interpretations. And we don't have that right now. Choosing not to take the vaccine is holding space for reason, transparency and accountability to emerge. You are right to ask, 'What comes next when we give away authority over our own bodies?' Do not be intimidated. You are showing resilience, integrity and grit. You are coming together in your communities, making plans to help one another and standing for scientific accountability and free speech, which are required for society to thrive. We are among many who stand with you.

malfeasance in discrediting Ivermectin to preserve the EUA for the vaccine and pharmaceutical industry. Point 52 reads, "It seems you have deliberately opted for deaths of people to achieve your ulterior goals, and this is sufficient grounds for criminal prosecution against you."

The Indian Bar Association posted an update on their website June 5, 2021, noting that Dr. Swaminathan had deleted her now-infamous tweet. # **Covid's Willing Executioners**

few weeks ago, three friends on Facebook told me that they wished for my death. One of them I didn't really know. He freaked out when I calm-

ly suggested there were viable treatment options for those with Covid. He responded: "Stay out of my life! I hope you get Covid and die!" The other two friends were people I knew in college 50 years ago, one was my freshman year roommate, and the other guy introduced me to my first wife. He suggested that I prove Darwin's theory and perish from the virus, the other just basically said I deserved what was coming as a selfish unvaccinated science-denier.

I know Facebook is certainly not the ideal place for reasonable discourse. As a psychologist, however, I do find it an interesting sample of a certain extreme way of thinking and behaving. I also believe my experience with "friends" wishing for my demise is not unusual amongst those on that side of the fence in this debate. At least not unusual in thought. As we all know, Facebook is the place of no inhibition. However, that

said, I do believe it is a grave concern that human beings can be manipulated into this dark manner of thinking and feeling.

The operative word here is "manipulate." I do have faith that for the most part, human beings have evolved from a cave mentality when confronting "other" in the culture. In cave days our psychology was programmed for survival, and it didn't take much coercion to view members from another tribe that wandered into territory that was not their own to be immediately met with suspicion and fear. Today, many thousands of years later, I think it takes a bit of manipulation to view "other" as fatally dangerous — but not much coercion, so it seems.

In this regard it appears we have lost any scintilla of common sense. How can a government (or more likely an even higher organization of authority) convince the masses so easily that the unvaccinated are the mortal enemy with not a whiff of science in the argument? #### Why is this?

"Pandemic of the unvaccinated" has emerged as an expression of propaganda meant to provoke anger toward those who exercise medical choice in deferring or refusing the experimental vaccine. It is meant to isolate, shame, and humiliate anyone who will not agree to surrender medical autonomy to the state. It intentionally divides Americans against one another while simultaneously distracting attention from the medical reality of poor vaccine efficacy and vaccine harm. The expression is devoid of scientific meaning but full of coercive psychological power. It must be challenged. Again, we see this idea of "coercive psychological power" come up in Dr. McDonald's comment. Propaganda and the manipulation of the masses has been a key tenet in totalitarian regimes. Pitting person against person is of utmost importance to having control over the masses. Even in Orwell's dystopian novel. 1984, the opposition to the state was created by the state to keep the masses distracted, or so it is implied. I am reminded of the Stanford Prison Experiment as well as Milgram's obedience studies at Yale. Milgram set up an experiment where a subject, someone who did not know the parameters of the experiment, was in control of administering an electric shock to the "learner" if he/she failed to answer certain questions correctly. The "learner" was also "in" on the experiment and in fact received no shocks. The authority figure egging on the subject was also, of course, "in" on the experiment and played the role of authority that the subject had to succumb to. "Just following orders" is the phrase that immediately comes to mind. The current phenomenon



at this early stage. But the about-faces and insults coming from the newly jabbed are worrisome.

Many people are smarter than I am. You may well be one of them. But the people I see on my Facebook feed calling everyone else idiots are...not.

This is one of those instances, like finance and the Middle East, where those with an interest want you to believe it is oh-so-complicated and you could never, ever understand it. But in reality, when reduced to its essence and stripped of jargon, the concept is rather simple. The questions become bite-sized, even binary.

For example, as alluded to above, how can people be certain about the long-term effects of these injections when they have only been available for a matter of months? Again, it is an honest question and, if at all possible, I would like an answer more substantive than, "Shut up, bigot!"

How about politicians and media figures who, when one person was President of the United States, loudly proclaimed they would never accept these rushed, suspect injections but, now that someone else has the job, insist you must accept the jab or you can never go to Arby's again? (Deal, by the way)

As the kids say, what's up with that?

# **Climate Lockdown** The Next Op Removes Our Last Rights

f you've enjoyed the COVID lockdowns, you're going to just love climate change.

In November 1997 the *Globe & Mail* newspaper published an article I wrote for the weekend Focus & Books section just a few weeks before nations signed the famous Kyoto Accord on climate change, in which they committed to reduce greenhouse gas emissions

to avert the disaster of a heating planet. In the face of a supposed consensus of scientists, my article - entitled "Science Fiction" — featured interviews with dissident climatologists who claimed science was being manipulated to serve a political agenda, and that emissions from human activity had only a negligible effect on global temperatures compared to the Sun the major driver of climate on our planet.

The article was (unsurprisingly) hugely controversial. Then, as now, it's a heresy to question that fossil fuel emissions are appreciably warming the Earth. At the time, I was in the first decade of a 25-year career editing magazines for Canada's environmental service industry; the article offended my own advertisers as well as many *Globe* readers. However, I've always had a damn-the-torpedoes attitude where telling the truth is concerned, so I continued to question the global warming thesis in my writings and in a series of public debates.

I confess my interest waned over time;

it's exhausting going against a well-funded establishment narrative, especially when sufficient funds are available to buy the acquiescence of almost every governmental, academic and media institution. Eventually people not only come to believe the lie — they forget it's even possible to think outside it. Contrarian evidence is dismissed out of hand, and skeptics are shunned (even persecuted). (I'm remind-

ed of Galileo inviting church elders to peer through his telescope to see for themselves there are more planets in the heavens than appear in the Bible. They rejected the invitation, stating, "Your telescope is an instrument of the devil!")


Time was on my side, though, and I was vindicated when the Earth failed to heat up as predicted (though you wouldn't know that from most media reports). I never claimed that human activity (excessive extraction, pollution, etc.) wasn't degrading environmental systems, even crashing them, but rather that the focus on warming would misallocate precious resources. Indeed, we've been exhorted to prepare for a hotter world at precisely the moment our Sun is stepping into a Grand Solar Minimum and global temperatures are cooling rapidly. ## The Persecution Of Physicians And Scientists In Canada

There is a medical and societal tyranny now afoot in Canada. It is based on a single-minded, totalitarian and anti-science opposition to anything other than what constitutes the "official narrative" with regard to the COVID-19 pandemic; and in turn, a well-coordinated campaign to smear, de-platform, persecute and attack anyone who questions the official propaganda that has been constantly emanating from government sanctioned sources over the last several months.

This Orwellian tyranny has now extended to include the persecution of Canadian scientists and physicians who speak up or speak out on purely scientific matters. If the utterance or statement from the scientist or physi-

cian is perceived by the authorities to stray from the official COVID-19 narrative, there are concerted, coordinated moves by health authorities, government public health agencies and licensing bodies, with a compliant media in tow, to persecute and "discipline" the scientist or physician for simply expressing a scientific opinion or pointing out ethical obligations for physicians, such as the obligation of informed consent.

This is all disturbingly similar to the suppression of scientists and academia in the Soviet Union. The totalitarian, communist regime under the Bolsheviks and Stalin, sought to control all scientific opinion and viciously opposed anything perceived to be associated with what were termed "dangerous" ideas from the "bourgeois" and "capitalist" West.

For example, the Soviet and Stalinist authorities allowed only a certain view of genetics perpetrated by Russian scientist TD Lysenko (1898-1976) to be

discussed, taught or practiced in Soviet academies and societies. Anybody perceived to be straying from this official view would be singled out for sham investigations by official tribunals, followed by punishment and discipline; the latter would include deportation to the gulags, long imprisonment or worse - www.mun.ca/ biology/scarr/Lysenkoism\_abstract.html

Soon, all of Soviet science came under the weight of this scientific tyranny, including medicine (the only exception was nuclear physics and space). The systematic persecution of scientists and physicians under this warped and narrow view of science came to be known as "Lysenkosim," with the term coming to mean a similar persecution and suppression of science and scientists occurring anywhere in the world.

Canada is now the grand and unfortunate stage upon which a new brand of medical and societal tyranny, a new "Lysenkoism," is manifesting itself in multiple areas of daily life for ordinary citizens — and in the lives of its physicians and scientists.

#### Here is my story ...

I am a surgeon who lives and practices in Saskatoon, in the province of Saskatchewan in Western Canada. I have been a surgeon for over twenty years and as Clinical Professor of Surgery and faculty member of the University of Saskatchewan, I started the Quality and Patient Safety unit in the department of surgery and co- founded the department's surgical humanities program. Together with the computer science department, we designed the "Morbidity and Mortality App" (M&M App), which is now being used throughout Saskatchewan. I also founded the Journal of The Surgical Humanities, of which I was the Editor: medicine.usask.ca/department/clinical/surgery-pages/surgicalhumanities.php I am a poet and a surgeon - and my book of poems was released to the world a few weeks ago: www.harppublishing.ca/product/to-a-nurse-friend-weeping/ On the June 23 of this year, I was called into a WebEx meeting with the Dean of our College of Medicine, the Chief Medical Officer (CMO) and the interim head, department of surgery. I was fired from my roles as director of our surgical humanities program and my other role as director of quality and patient safety; and in addition, all my academic roles were suspended, including the teaching

and training of residents and medical students.

Why did this happen? The firing and suspension were the result of my advocating for informed consent in the roll out of the m-RNA vaccine to our kids in Saskatchewan — and this was supposed to be my crime.

Canada, along with the United States and Israel, is one of the few countries which are aggressively pushing and propagating the COVID-19 m-RNA vaccines for our children.

In Saskatchewan, even our middle and high schools are being used to administer this vaccine — with several reports of teachers and other people of influence strenuously advertising the vaccine without any kind of informed consent and in some cases, coercing students to receive this new, experimental injection. All this whilst the risks of the vaccine, any benefits from and poor all over the world. In its global scale, this new tyranny is unprecedented and seeks to control every aspect of every human being's life.

One of the methods by which this new dictatorship seeks to exert and consolidate control is by co-opting the press and media to be arms of government. This is also a well known, Soviet tactic — and bears a close, disturbing

In November 1917, Vladimir Lenin gave a speech, promulgating what was called, the "Council of People's Commissar's Decree on The Press." According to this decree, the "Council of People's Commissars" could proscribe temporarily or permanently any publication or news item. In the years 2020-21, a similar "council" has emerged only too plainly in sight — it consists of big

pharma, big tech (YouTube, Twitter, Facebook ...), big government and public health officials working in concert to suppress, divert and censor free speech, destroy the free flow of information and de-platform the free debate of scientific ideas so germane to the progress of science.

Clause (3) of Lenin's 1917 ordinance on the press stated that, "The present ordinance is of a temporary nature and will be repealed by a special decree as soon as normal conditions of social life set in." But as we all now know, the control of the press was maintained with an iron grip by the authorities behind the iron curtain until the collapse of the Soviet Union in the 1990s - i.e. for a period of more than 70 years.

In the present era, governments and authorities keep telling us that draconian and soul-sapping measures of control including lockdowns and control of the press would last only for a few weeks; then a few months ...


and now we are several months into this charade, with governments

the vaccine and any alternatives to the vaccine - i.e. the basics of

informed consent — are *not* being explained in any meaningful way to parents or children. Children as young as 13 can even opt to receive the vaccine, without their parents' consent or knowledge.

In a press conference on 17 June this year, I had called for full, informed consent to be put in place for our parents and children, before the m-RNA vaccine is administered to our kids. This should not be a controversial position for anyone — obtaining informed consent is a bedrock of medical ethics and has been a foundational requirement for physicians for several hundred years. It also forms the basis for several regulatory codes, including the Nuremberg Code. The latter was written as the result of the horrific medical experiments that were conducted by Nazi Germany on concentration camp prisoners without their consent. The civilized nations of the world came together after the second world war to say "never again." Never again would any kind of medical intervention or treatment



in most countries continuing various measures to keep

emergency powers in place. The Canadian provinces for example, have continued to renew their declarations of emergency rule, from early 2020 onwards.

But totalitarian regimes have a defined life-span and the human quest for freedom and liberty can never be suppressed forever. Even in the darkest days of the Soviet tyranny, small and makeshift, secret publications sprang up in multiple, major cities. Excerpts from the Bible, the great works of Russian literature - including Boris Pasternak's immortal and lyrical novel, "Dr. Zhivago" - and other banned material were typed/ printed, then smuggled into the street and alleyways of Russian towns and cities. This alternate, underground press has since received the now celebrated name, "samizdat" (Russian for clandestine press).

be administered to anybody, without full and voluntary informed consent.

I am not alone in this persecution. Several physicians and scientists have been de-platformed, smeared and harassed in Canada, simply for expressing a scientific opinion or pointing out the need for full, informed consent — this includes world-renowned, Canadian virologist and vaccinologist, Byram Bridle. In the U.K. Dr. Sam White is facing a similar hounding by the authorities because of his expressed desire to practice evidence-based and scientific medicine. There have been several other all too familiar cases, all over the Western world, of attempts at authoritarian suppression of free speech, the free debate of scientific ideas and the scientific method itself.

The same totalitarian darkness which descended upon the Soviet Union is now rapidly descending upon Canada - and alas, upon many countries, rich

# **Deaths Of Despair**

Thile we typically see an increase in mental health issues, substance abuse, suicide attempts and suicide ideation with adults during periods of increased unemployment and economic recession, we have never before seen suicidality among our children rise at such alarming rates as we have during the lockdowns of 2020/21 in Canada and around the world.

While the lives of adults and parents are important, it is our goal to bring much-needed attention to rising rates of attempted and successful child suicide during

the lockdowns. These are a foreseeable consequence of the long and harsh lockdowns, and therefore are attributable to lockdown measures, which resulted in lengthy absences from school, isolation, reduced (or eliminated) social and sporting activity, loss of routines and many other ordinary behaviours and experiences that children require for adequate social development and mental health.

One might argue that our provincial governments' initial decision to go into lockdown based on early projection models was justified. However, even if one also ignores the fact that lockdowns were unprecedented and never recommended before 2020, in 2019 the World Health Organization (WHO) itself ruled out lockdowns under any circumstances, it is certainly no longer a valid argument as we now have over 17 months of outcome data that clearly show lockdowns resulted in widespread harm to mental health and educational outcomes for children without delivering unambiguous benefits in any arena. Our governments and Public Health officials have failed in their responsibility to our children to balance risk and reward in their decisions during this pandemic.

We have known for at least a year that

statistically, children are virtually unaffected by COVID-19, except in rare circumstances in which they suffer from a compromised immune system or related health challenges. We have also known that children are not socalled "super-spreaders". As a matter of fact, all the available data that we are aware of shows that no child under the age of 10 has ever passed COVID-19 on to an adult in any country around the world. According to Dr. Paul E Alexander, MSc PhD, McMaster University and GUIDE Research Methods Group, children are at very low risk of acquiring COVID-19 infection and are at an even lower risk of spreading it amongst themselves in a school setting. The data clearly show that children are not spreading this to adults or teachers and while the risk of serious illness to children from COVID-19 is extremely rare, it has been determined that the few children who are acquiring COVID-19 are predominantly catching the disease in their home and from their parents. Statistically the safest place for children including university-aged adolescents, is in school.

This may be the first time in recorded history that adults at a societal level are not protecting children, but are instead expecting children to suffer in order to protect adults from an infectious disease that is statistically no worse than annual influenza, except for the very old resulting in severe disruptions to our children's lives in response to a virus that is statistically less dangerous to them than regular influenza. Furthermore, following early reports that suggested asymptomatic transmission (the main means by which children might be vectors of the disease) was not a contributing factor, we now have compelling recent data indicating that asymptomatic transmission of COVID-19 is a negligible factor, if it exists at all.

Canadian statistics tell a similar story. According to Statistics Canada, in the 5 years before COVID-19 an average of 25 children aged 0–19 died of influenza each year.



In the 15 months since the pandemic was declared, 11 children died with COVID, all of whom had comorbidities. These statistics demonstrate clearly that Influenza is approximately twice as deadly to Canadian children as COVID-19 . Only children with serious underlying medical conditions are at risk of death from COVID-19 , and even then, that risk is **lower** than that of endemic seasonal influenza, which we have all tolerated every single year without any special, let alone world-changing, precautions.

We have presented the data that indicate that, whatever the seriousness of COVID-19 as a general public health issue, it is most certainly not an issue for children, nor does allowing children to get on with their busy, interactive lives at school and elsewhere exacerbate the spread of COVID-19. And yet we have allowed our governments to pretend otherwise. Let us turn now to the damage that this has wrought.

Here is the evidence. McMaster Children's Hospital, in Hamilton Ontario, reported an almost 300% increase in serious youth suicide attempts with 26 youth admissions between October 2020 and January 2021 compared to only 7 in the same time period the previous year prior to lockdown. You might be tempted to think, "These are small numbers, compared to the children at risk from COVID-19." That would be an incorrect assertion. The facts are that in the entire province of Ontario, a total of 5 deaths with/from COVID-19 have been reported for all people under age 20. More than 5 times as many children attempted suicide in a single Ontario Region in a 4-month period of lockdowns as died from COVID-19 in the entire Province of Ontario since the start of the pandemic. McMaster Children's Hospital also reported that youth substance abuse has doubled and child eating disorders have increased 90% during lockdown compared to the previous year. According to a peer-reviewed study by the American Academy of Pediatrics, a Texas hospital reported that child suicide attempt was 2.34 times higher in March 2020 compared to March from the previous year. It also reported that suicide ideation was 1.6 times higher during that same month. The average age of children in the study was only 14 years old. The study suggests that children, unlike adults, do not need to suffer privation for long periods before they resort to suicide ideation. They are more immediately sensitive to the uncertainty, isolation, lack of structure, family tension, and limited access to doctors, teachers, and coaches. Just the fear of these losses, the mere thought that they could be away from their friends

has an immediate negative impact on children's mental health, thus one can only imagine how children feel and respond when these losses become real.

Pima, the second-largest county in the state of Arizona, reported a 67% increase in child suicide during the 2020 lockdown.

Suicide is the second leading cause of death among people aged 10-24, after accidents. It therefore makes no sense of any kind to put extra stress factors that would exacerbate suicide ideation to this demographic.

We have included data from the United States not only to supplement our limited Canadian data, but also to

> indicate that this problem is widespread throughout North America where lockdowns of this nature have been carried out. It also sheds light on the various governments' ignorance or concealment of information about child suicide rates during the lockdown. It should be obvious that removing children from their friends, coaches, routine, sports, and ability to pursue their life's ambitions and dreams will have an immediate and strongly detrimental effect on their mental health; despite this, the Canadian government has implicitly encouraged our health care institutions and Statistics Canada to downplay the severity of youth suicide during the pandemic. Preliminary suicide statistics from the province of Alberta suggest that suicides of people under the age of 19 have only increased by one death during the 2020 lockdown compared to 2019. It is difficult to square this claim with the report from McMaster Children's Hospital. in which named officials appear to back up the alarming increases that are quoted. Even reports from the early days of the COVID-19 outbreak indicated that the Canada Suicide Prevention Service was significantly busier: by April 2020, they reported 50% more interactions compared to the previous year, as well as a 62% increase in "active rescues" (i.e., responses

to suicides in progress)

Further evidence of a simmering crisis comes from reports that Kids Help Phone received over 4 million calls in 2020, more than double the 1.9 million calls received in 2019.

The CDC has reported that online learning causes "more risk" to emotional and other mental health issues, they surveyed adolescents between 18 and 24 and revealed that 75% admitted to mental health problems or drug use during the lockdown. In that same survey one in four young adults admitted to suicide ideation in the last 30 days. The CDC also reported a 24% increase in emergency room mental health visits with children between the ages of 5 and 11.

Boston Children's Hospital reported a 47% increase in children hospitalized for suicide attempts and suicide ideation between July and October 2020 compared to the same period in 2019.

In January 2021, the UK Centre for Mental Health announced that 500,000 children in England under the age of 18 with no previous issues would need mental health care due to the lockdown.

British infirmaries reported that in the years preceding the lockdown, they would treat between one and two children per week for mental health and suicide attempts, but that during the lockdown they were treating an average of two per day, with some of the children as young as eight years old.

and infirm.

According to the Centers for Disease Control and Prevention (CDC), the survival rates for people who get infected with COVID-19 by age and without treatment are:

- 0-19 99.997%
- 20-49 99.98%
- 50-69 99.5%
- 70+ 94.6%

For the 0-19 age group, a survival rate of 99.997% implies a death rate of 0.003%, i.e., 3 children out of every 100,000 infected are expected to die. Note that of the 335 children (under 18) who had died with or of COVID-19 in the US (as of mid-July 2021), 100% of them had a pre-existing medical condition, such as cancer or diabetes. In contrast, the CDC estimates that 434 children died of influenza in the 2019-2020 season, and only 43% of the reported cases involved children with known underlying conditions. In other words, only children with serious underlying medical conditions are at risk of death from COVID-19 , and even then that risk is lower than that of annual influenza, which we have all tolerated every single year without any special, let alone world-changing, precautions. And yet our governments enacted lockdowns

In Ontario the Youth Services Bureau of Ontario reported a 40% increase in mental health centre contacts in January 2021.

In France, it has been reported that children, some as young as eight years old, have deliberately run into traffic, overdosed on pills and self-harmed during the lockdown. And in Japan, the education ministry reported that child and adolescent suicides hit record levels.

It is crucial to emphasize that many countries around the world did not take their children out of school. Sweden, for example had zero child deaths due to Covid, despite refusing to subject its people to lockdown, and never taking children out of school. Except for a two-week extension to the school winter break. Taiwan only participated in a brief eight week lockdown where they did not take their children out of school, never used a vaccine and reopened without re-infection.

Many countries have not engaged in lockdowns for more than a few weeks, and therefore, their children have

received a complete education. The major disruptions to two years of education have placed our children at a significant disadvantage, and it may take years for our children to catch up with children from other countries, who might even compete successfully against ours for admission to our own universities!

Rahul Sapra, President of Ontario Federation of University Faculty Associations, stated: "As a result of the COVID-19 pandemic and the scramble to move courses online, we have lost that human connection and educational quality has suffered." His organization found that 62% of students and 76% of faculty believe online education has a negative impact on education quality. This should not be surprising, given that our teachers and schools were not prepared, qualified or trained to switch to a completely different teaching methodology that failed to acknowledge millions of students' requirements for face-to-face learning, structure and support.

The use of hybrid and remote (online) learning fails to consider that over 15% of Ontario's children live in poverty, and that 25% of Ontario's high school students need special education assistance. It also fails to incorporate a variety of methods that face-to-face classrooms apply. Results from hybrid and remote learning for high school from several parts of Canada suggest a drop in academic performance. School boards looking at students' midterm marks found a failure rate of 16%, almost double the rate of the previous year. Thus education is currently not only failing our children's mental health, but is also robbing them of a proper education, which will have extensive negative impacts on virtually every aspect of their future and the future of our society as a whole.

To present another counter-example: Florida reopened without restrictions and children returned to in-person learning in schools. In contrast, 33 states that were not fully open to in-person learning had more COVID-19 cases among children than Florida. It remains unclear why our governments did not at least consider this example publicly, let alone follow it when it became clear that their approach was both successful and sustainable.

Keep in mind that in May 2020 when the CDC reported the first 68,998 deaths attributed to COVID-19, only 12 (0.017%) were of children under the age of 17, and only one had no underlying medical conditions.

The CDC estimated that 600 children died of influenza in the 2017/2018 season, and according to the *Journal of the American Medical Association (JAMA)*, children are at greater risk of critical illness from influenza than from COVID-19.

The Journal of Medical Virology states unequivocally that there is no evidence of child-to-child or child-

to-adult transmission of COVID-19 . "... while children become infected by SARS-CoV-2, they do not appear to transmit infection to others."

A biological mechanism has been proposed to explain why children are at virtually no risk of serious infection or death or even spreading COVID-19 . They have comparatively few angiotensin-converting enzyme 2 (ACE2) receptors, to which the SARS-CoV-2 attaches itself in adults' epithelial lining cells. Because children and adolescents have so few ACE2 receptors, they are at the lowest risk of severe outcomes from COVID-19 .

To recap: we have presented significant amounts of evidence demonstrating that lockdowns and withdrawal from in-person schooling are destroying our children's education and mental health, resulting in increased sui-



cide attempts and suicide ideation. These effects were wholly predictable: ordinary parents, caregivers and teachers as well as clinical psychologists and other healthcare professionals from institutions including Sick Kids Hospital warned that forcing social distancing and masks on children would cause major, potentially irreparable psychological damage. School closures have caused our children to suffer substantial educational deficits and a loss in future income potential which could lead to a future of despair.

The problems are already evident in our children, and

which has been predicted by Bill Gates, which is triggering a response from the world health organizations that the Bill & Melinda Gates' Foundation has bank-rolled, and driving us toward a vaccination and biometric ID solution which Bill Gates has been working on for years, one would do well to learn more about the man and the ideologies driving him, for he is greatly and seriously impacting our lives.

As parents, teachers and caregivers we have been complicit, forcing children to adhere to unproven nonpharmaceutical interventions (social distancing, masking, cohorting) and shutting down schools, social and sporting activities, and confining them to their homes. We have allowed our children to learn to regard one another with suspicion, as if they are walking virus factories capable of infecting and killing each other, as opposed to fellow human beings that can share love, joie de vivre, comfort and support. In short, our children have collectively suffered willful, wrongheaded neglect and abuse, and it's time to put it to an end.

The lockdowns, school closures and related measures are the core drivers of children's suffering and the drastic increases in child suicidality and depression over the past 18 months. The sooner we get children back in school, in sports, around their friends and into their routines, the sooner they can start to heal and to get back on track with proper social, mental and physical development. We still have a lot of work to do as a society to recover not only from COVID-19 but also from the often counter-productive interventions of our governments. For our children, it starts with them getting back in school full-time, in-person as they were before 2020.

We have focused this discussion on children's suffering. However, we must also note that some children have been unfortunate to lose parents and other caregivers to suicide and other deaths of despair, as well as to COVID-19 and other health problems. Every one of these losses is tragic; however the deaths of despair are especially poignant and painful because in many cases key contributing factors were man-made, and therefore were preventable. **In Conclusion** 

Using publicly available sources, we have made the case that the numerous restrictions on children have been irrelevant and ineffectual in minimizing the spread of COVID-19. Worse, these restrictions have severely damaged children's overall health and development, to the point of causing serious psychological stress and suicidality in many more children than have been at serious risk of severe outcomes from COVID-19.

On the basis of these publicly reported data (no doubt there are countless personal stories that would attest to the reality of these figures), we appeal to our fellow parents, teachers, school board trustees, politicians, health professionals, law-enforcement and other civic personnel – to our fellow citizens – to support us in securing the reinstatement of our children's full-time, in-person education. For various, arguably complex reasons our government officials have let us down; it is time to relieve them of some of the unmanageable pressures of governing by making it unambiguously clear what we want. The data we have presented here are clear: we can start by ensuring that government officials receive and read this material, and respond to it appropriately.

We also appeal to you to start to take responsibility for our children's future, and for accelerating their healing and recovery from the trauma of unnecessary lockdowns and isolation. Put plainly, there is no argument that justifies school closures and now that you have read this evidence package, you are aware of the destruction that school closures and lockdowns have caused and continue to cause to our children. We believe that you have a duty to act to ensure that changes will be made immediately in our government and educational system to guarantee the full re-opening of our children's schools and the full restoration - with no prospect of reversal - of all of the social interactions and opportunities that have been available to them pre-lockdown. Thank you for reading this deaths of despair: Child Suicide Evidence Package. We have already lost the lives and the vitality of too many children. Please share this material and play your part — support a friend, speak to a child, call a teacher, challenge a politician, do whatever you can — so that we don't lose any more children. The first comprises those of our fellow Canadians who are fully onboard with just about anything their provincial authorities or our federal government passes as law or decree. We can call this first group the (sadly) unreachable. They are deeply entrenched in their ideologies, much like many of us are in the freedom movement, and the earth will need to move before their minds will be changed. We can contin-

ue to expend our energy trying to reach those who feel that divisive and discriminatory vaccine passports are legitimate, that authoritarian or totalitarian measures are appropriate, and that anyone who thinks differently merits no voice. But you will usually waste your breath only to find condescending and emotionally charged responses in return. This is perhaps not the most productive use of your time. I know, I've had a hard time learning that lesson myself.

The second group to which this message is NOT aimed is comprised of true freedom fighters. This group must not be confused with the plethora of keyboard warriors and armchair activists who share many of our collective concerns, occasionally voice them

publicly, but otherwise fail to meaningfully implicate themselves and dedicate time and energy to making a difference. True freedom fighters fight in a broad number of ways. They may not be known at all in the resistance movement, but they already take their stand daily with simple but conscious acts of civil disobedience.

So, this message is directed at those in the middle, the mostly silent majority who are sympathetic to the eternal struggle to maintain and promote freedom, individual liberty, and bodily autonomy, but persist in asking the question, "I know it's wrong, but what can I do about it?" I want to try to help to answer that question, since we get it asked often. We also get a lot of people asking us to lead a specific initiative with questions like, "why don't you do this or that?" The obvious answer to this second question is, "why don't YOU do this or that?" There is scarcely any difference between our activist group and your activist soul. We do not wield any power that you do not hold yourself. We have no more magic in our arsenal than each of you have within you to effect change. It is only when we ALL act that real change is achieved.


And, so, before answering the first question posed in the title, here are some other common questions and viable solutions that each of us can execute as soon as right now:

"I don't want to get vaccinated, but I don't have a choice or else I'll lose my job."

This is an especially tough question right now as the federal government is trying to implement vaccine mandates for all federal employees and will likely attempt to extend such discriminatory policies to a larger segment of the workforce. But what do you mean, precisely, when you say you don't have a choice? The real answer is that you have many choices, none of which are easy. Your first option is to get vaccinated. But then you wouldn't because a government or employer implements a certain policy, this does NOT mean that it passes the legal test. Indeed, the only way we can know if a statute, policy, or premature termination is lawful is if we challenge that law. Yes, this can mean self-sacrifice and investment, but it is a CHOICE. You have a choice.

Your third option is to organize and strike. In much of Europe, unions have organized general strikes with the aim of pressuring the government to abandon their abusive and overreaching policies. You must always remember that YOU have power. We are living in a time present no symptoms of an infectious disease, it is very difficult and contentious for the Canadian government to require any of these interventions under the Public Health Act or quarantine regulations. So, once again, stand your ground!

The most important concept to consider in all of this is that accepting a medical procedure in order to regain your fundamental and inalienable rights is a decision you would be taking for all the wrong reasons. The ONLY reason you should get vaccinated is if you personally have evaluated the risks and benefits, have been properly and

This last question is broad in its implications, but the answer is simple. It was perhaps best expressed by Marlon Brando in his role as the Godfather: "You can act like a MAN!" Please note, acting like a "man" should not be misconstrued as an expression of toxic masculinity. It is this author's opinion that the colloquialism more correctly refers to acting with courage,




when perpetual government hand-outs have decimated the workforce. If you're still getting up every morning and going to work, you are now a rare and precious commodity in Canada! While general strikes in France have caused the country to fall to its knees while the economy grinds to a halt, Canadians can engage in the very same lawful acts. Truckers: Stop trucking! Nurses: Strike! Doctors: Take that sabbatical year off you've been dreaming about! Government bureaucrats: Same thing. Organize and strike! Unions: wake up and start representing the rights of your members! If society is trying to exclude you, then don't play ball and don't play into their hands. Exercise your power and fight back!

Your fourth option is to write letters to your employer. We have provided model letters you can use and adapt to your own needs at www.fearlesscanada. org. Make your employer know that you are refusing vaccine coercion.

Your last option (there may be more that we haven't considered) is to try and obtain a medical exemption. This may be hard, but if you have a legitimate health condition that precludes you from being vaccinated, then make sure you obtain a medical exemption from your doctor. There are many contraindications cited by vaccine manufacturers. Look them up and see if you are at risk. Of course, obtaining an exemption will do little to change the oppressive system that is forcing you to justify your personal and private health decisions. However, for the time that it's needed, it can provide you with some temporary relief until the war on our freedoms is over, whenever that may be.

with conviction, and with conscience. What is your conscience telling you to do? Will you compromise your convictions in order to appease a family member, a government, or an employer? And what will happen if we all acquiesce and compromise our convictions in order to satisfy another's misplaced fears? What is our great, free nation if it forces us to swallow our pride, forsake our courage, and abandon our convictions? In this author's humble opinion, it is no nation at all, and not one worth living in.

be doing that for the right reasons, would you? If you are forced or coerced into getting vaccinated against your own conscience, then you are participating in an egregious breach of the law, of medical ethics, and of fundamental human rights. So, let's call that option what it is: off the table.

Your second option is to refuse flat out. You can quit your job, or you can force your employer's hand to attempt to take action against you. The latter is the best of both options. By refusing an unlawful and unethical vaccine mandate that threatens your constitutionally guaranteed right to earn a living as a function of your private and personal medical choices, you force your employer (yes, even the federal government) to either abandon the action or make a decision that is legally contentious. Of course, there is a risk involved in playing this game of chicken, but it also comes with some amazing rewards.

The first reward may be the most important of all: You followed your conscience. You exercised your inalienable rights to integrity of your person, safety and security, and moral conscience. What can be more rewarding than that? The second reward may take much more time, money, and energy to achieve: You can be wrongfully terminated and sue your employer for discrimination and human rights violations. We must never forget that, just "They won't let me travel if I don't show a vaccine passport."

Solution 1: Don't travel. For as long as such policies impede your constitutionally guaranteed freedom of mobility, you can stay put. Again, this isn't the only solution, but it is an available CHOICE. For the time being, there is no obligation to be vaccinated in order to travel. That's right, despite the rhetoric and political posturing, for right now, there is no vaccine obligation in Canada or in many countries and regions abroad.

You must also consider that not every country will require vaccination to allow entry. For example, travelling to Mexico requires no vaccination and no test! And, as a Canadian citizen, re-entry into Canada cannot be legally refused under any circumstances. This is your country and your home. Yes, they can insist you get tested, or even require you to quarantine. However, if you are healthy and

### **Rock Legend Says No to Discrimination**

B ritish music legend Eric Clapton will not perform at venues that require music goers to provide evidence of a covid vaccination. The guitarist has been brave and outspoken with his views on covid and vaccines.

In a statement posted on Italian architect and film producer Robin Monotti Graziadei's Telegram account, Clapton said, "Following the PM's announcement on Monday the of July 19, 2021, I feel honour bound to make an announcement of my own: I wish to say that I will not perform on any stage where there is a discriminated audience present. Unless there is provision made for all people to attend, I reserve the right to cancel the show".

The statement was in response to an announcement by UK Prime Minister Boris Johnston that social settings like nightclubs and concert venues must now require guests over 18 to show proof of vaccination for entry.

### Australia Shuts Down Capital City After One Covid Case Is Detected

n early August, Australian authorities ordered a strict lockdown in Canberra after a single case of covid was detected in a man in his 20s.The snap lockdown was implemented in the capital city and surrounding areas in a region that is home to 400000 people.

The capital city region was ordered into a seven-day lockdown with strict measures in place after the one covid case was reported. Measures include stay-at-home orders; retail stores been closed and restaurants offering takeout services only. Residents in the region were told that they can only exercise outdoors for no longer than one hour and that they must work from home if possible, during the lockdown.

Australia has had one of the world's longest and strictest lockdowns and has been ruled with a tyrannical iron fist. At a recent press conference, the chief health officer for New South Wales Kerry Chant bizarrely advised people not to talk to each other even if they're wearing masks in order to reduce the spread of covid. ### Only Fully Vaccinated Can Dine Indoors In Ireland

The Irish pub experience is world renowned for its hospitality, humour and atmosphere. Having 'a bit of craic' (fun) is an integral part of an Irish pub. Unfortunately, medical apartheid has now hit the Emerald Isle and the hospitality sector.

Since July 26<sup>th</sup> in the Republic of Ireland, anyone who is fully vaccinated or can provide evidence that they have recovered from covid in the past 6 months can now dine or eat indoors. The discriminatory 'health' measure was recently passed and legislated by the Irish Parliament. A large peaceful protest was held outside the Convention Centre in central Dublin when the voting was held.

### A List Of Some Of The Most Absurd Things That Have Happened In Recent Weeks

- Barbie is now a COVID vaccine developer. The Barbie, part of a new series that honors frontline workers, is a miniature of real-life Oxford-AstraZeneca COVID vaccine co-developer.
- Forbes has revealed **660 new billionaires in 2021**. The list now includes a record-breaking 2,755 billionaires throughout the world.
- A disturbing new video game, called StayHomer, encourages killing lockdown protestors in cold blood. The goal of the "game" is to kill those demonstrating against the lockdowns, so they learn to "stay home," as the name implies.
- A new study by Johns Hopkins University found, of the 2020 NIH annual budget, 5.7% was spent on COVID-19 research -with most spending allocated to vaccines. Only 1.8% of the \$42 billion NIH budget last year was spent on clinical research for COVID. Not a single grant was dedicated to studying masking children. Nor were there grants for studies on Ivermectin for COVID. Aging, however, was funded 2.2 times more than COVID-19 research.
- A preprint paper by the prestigious Oxford University Clinical Research Group, published Aug. 10 in *The Lancet*, found that, when infected with the dominant Delta variant, Astrazeneca vaccinated individuals carry 251 times the load of COVID-19 viruses in their nostrils compared to the unvaccinated.
- Dr. Fauci finally admitted, "When you look at the level of virus in the **nasopharynx of a vaccinated person** who has a breakthrough infection with Delta, it is **exactly the same as the level of virus in an unvaccinated person** who is infected."
- About mask mandates in schools on Fox News, former CDC Director (2018-2021) Dr. Redfield admitted "I haven't been able to review data that supports that recommendation." He came to that conclusion after noting the lack of research on this topic since no human randomized-controlled studies were conducted to determine if masks "protect others" from COVID.
- State Departments of Education released their data on the past school year, revealing US public schools served 14% less kindergarten students in the 2020/2021 school year.
- Public Health England's data reveals that between 39-43% of "hospitalized COVID-19 patients" were admitted to the hospital for "a diagnosis unrelated to Covid" this summer, and only tested positive later after routine swabbing done after admission.
- Those who oppose COVID measures are now deemed by the U.S. Department of Homeland Security as potential terror threats. Those who make claims of election fraud and those who commemorate the 20th anniversary of the Sept. 11 attacks also made the list. Additionally, the National Guard is coincidentally looking for people to work as Internment/Resettlement Specialists, people who can be trained to confine people in a military setting.
- The Australian Military has been deployed across Sydney to help enforce the COVID-19 lockdown among civilians. So far, 32% of the eligible Australian population has received both doses.

- Real-time surveillance and censorship is in the works as Biden and the **Democratic National Committee are** working to engage fact-checkers more aggressively and with SMS carriers to dispel "misinformation" about vaccines sent over text messages and social media.
- US President Biden announced in a speech that **all federal employees and contractors are now required to be fully vaccinated against COVID-19** (or face regular testing and other restrictions). He also encouraged states and localities to pay \$100 to each newly vaccinated American.
- The Canadian government announced a sweeping new mandate requiring all federal government employees and those working in federally regulated industries, including air and train travel, to be vaccinated against COVID-19.
- US Capitol Police issued a bulletin stating members of Congress will "be subject to an arrest" if they show up and stay at work without a mask on.
- In addition to scanning drivers' faces to make sure they're wearing masks, **Uber is now asking drivers to rate if their** *passengers* **are wearing a mask as well.** Riders reported by drivers for not wearing a mask would be required to take a selfie with the Uber app — with a face covering on — before they're able to take another ride
- The previously well-respected Canadian magazine *Maclean's*published an article where they inciteviolence against anti-vaxxers. The article, titled *"Vaccinations: No more carrot—bring out the stick,"* calls anti-vaxxers "toddlers" and "assholes" and "fools." Concluding: "It is not fair that reasonable and responsible Canadians

should pay the price for their deadly selfishness. No more soothing tones and patience. Time for the stick."

- The World Health Organization is working with an artificial intelligence tool called EARS to mine online blogs, articles and forums, analyzing "misinformation" and countering the concerns people express such as "vaccine hesitancy" potentially through bot farms.
- The CDC's strategy for controlling what people see about COVID on social media sites, including Facebook, was **funded by \$3.5 million in free ads,** according to a Judicial Watch expose.
- Despite overwhelming evidence of its effectiveness, the FDA reiterated a warning against the use of ivermectin as a COVID-19 treatment and warned it can result in death, (despite not one reported case of an Ivermectin overdose death during COVID-19 worldwide).
- Burial costs will now be covered by Ottawa for Canadians killed by federally approved vaccines.
- Bank of Canada's inflation rate surpasses the 2% maximum-per-year-threshold and reaches 3.7%.
- US health officials are reviewing reports that Moderna's COVID-19 vaccine may be linked to a higher risk of a rare heart condition in younger adults than previous-ly thought. Canadian data indicates there may be a 2.5 times higher incidence of myocarditis in those who get Moderna compared with the Pfizer vaccine, and men below the age of 30 are particularly at risk.
- **Opioid overdoses were 29% higher in 2020** than before the pandemic, according to a study in JAMA Psychiatry on Feb. 3.
- FDA ignores new UK study by the Francis Crick Institute in the *Lancet* showing 2-dose Pfizer vaccine recipients have 6 times lower amounts of neutralizing antibodies to the dominant variant —the Delta (when compared to the original strain). Neutralizing antibodies are also much lower for older people and people who were vaccinated more than 6 months ago. The public is now being told to prepare for an autumn booster program. Meanwhile, the study *Antibody Evolution after SARS-CoV-2 mRNA Vaccination* concluded: "memory antibodies selected over time by natural infection have greater potency and breadth than antibodies elicited by vaccination."
- Long-time NIH funding recipient Dr. Pete Hotez publishes an article in the PLoS Biology Journal claiming that **criticizing Dr. Fauci should be a "federal hate crime."**
- A team of Johns Hopkins researchers recently reported that when studying a group of about 48,000 children, **they found** *zero* **COVID deaths among children** without pre-existing conditions. The official **number of "COVID deaths" among kids under 18 is 335** (as of last month).

• A preprint study titled *Impact of the COVID-19 Pandemic on Early Child Cognitive Development,* found that children born during the pandemic have significantly reduced verbal, motor, and overall cognitive performance compared to children born pre-pandemic.

• Ohio judge orders a 21-year-old man to get a COVID-19 vaccine as part of probation conditions for drug possession.
