# Decades of Vaccine Damage

The first U.S. shots for COVID-19 were given in December 2020 to health care workers in New York. In the short 20 months that followed, a lot has been learned about the jabs and the adverse effects that have devastated those who have taken them.

The sheer number of adults and children affected is dramatically higher than in any year since the vaccine adverse event reporting system (VAERS) began recording events in 1990.

As of August 12, 2022, there have been over 1.3 million adverse event reports after the COVID jab, including over 30,000 deaths and over 56,000 individuals who are now permanently disabled. The pandemic has demonstrated that many physicians were unaware of the existence of VAERS, which is co managed by the CDC and FDA.

In the past, the system’s intended use had been to detect “*unusual or unexpected patterns of adverse event reporting that might indicate a possible safety problem with a vaccine.*”

However, it’s apparent as the FDA, CDC and other public health agencies ignore the number of reports following the COVID jab, that the system may be recording damage, but the public health officials are ignoring it.

As you consider the documented evidence below presented by the Children’s Health Defense (CHD)(<https://childrenshealthdefense.org>), it begs the question — since the damage and devastation from the COVID shot is obviously being ignored by public health officials, how long have they been ignoring vaccine damage in our most vulnerable? According to CHD and the National Vaccine Information Center (NVIC), it’s been going on for decades.

### Factors Involved in Vaccine Safety

There’s no question the number of vaccinations required for children just to enter school has jumped dramatically from the 1970s to the present time. According to the Children’s Hospital of Philadelphia, the number of vaccines increased from four in the 1940s, to seven in the 1970s and then to 14 by 2020.

But, according to CHD, that vaccine schedule includes 50 shots by age 6 and 69 shots by age 18. When you add all the antigens — the weakened or inactive microbes of the diseases that trigger an immune response — to the adjuvants — foreign substances added to a vaccine to help the antigens create a stronger immune response — you have a staggering amount of foreign substances being pumped into your child over a very relatively short period of time.

As CHD points out, some children appear able to handle this, but many do not, which leads to another factor: how vaccine safety is tested and proved. Unfortunately, while you may think that independent research tests and supports safety, this is not true. Actually that’s all done by the vaccine manufacturers themselves. According to the FDA:

*“Before the FDA licenses (approves) a vaccine, the vaccine is tested extensively by its manufacturer. FDA scientists and medical professionals carefully evaluate all the available information about the vaccine to determine its safety and effectiveness.”*

When you read the last line, you’ll notice they evaluate “all available information.” As the CHD points out, this does not include all the information from testing. Let’s consider the current release of Pfizer documents that were used to approve Comirnaty, the Pfizer COVID-19 jab.

Operation Rescue reported the data revealed that 270 pregnant women were vaccinated and a large percentage — 238 (88%) — of those were not followed up. This lack of follow-up is concerning since the data also showed that 124 of the 270 had some adverse reaction to the shot; 75 were serious and 49 were nonserious.

The outcome of only 34 pregnancies was recorded and 28 of those babies died in utero or at birth. Of the 34 pregnancies only one was recorded as normal and five were recorded in Pfizer data as “pending.” This is the data that the FDA used to determine that the shot was “safe” for pregnant women. Yet, the data show that from 82% to

97% of the documented outcomes resulted in death.

This demonstrates that even when the FDA has the data, the results of the analysis that leads to the statement “safe and effective” are questionable. When the FDA approves shots based on this flawed data, you must ask yourself how bad is the data Big Pharma is hiding?

### Vaccines Do Not Reliably Prevent Disease, but Do Spread It

Another point the CHD makes is that data demonstrate that vaccines do not reliably prevent disease. Not only that, vaccinated people can and do spread the diseases against which they’re vaccinated. If you need a current example, consider the COVID shot, which the CDC acknowledged is not effective for disease prevention:

*“CDC’s COVID-19 prevention recommendations no longer differentiate based on a person’s vaccination status because breakthrough infections occur, though they are generally mild, and persons who have had COVID-19 but*

*are not vaccinated have some degree of protection against severe illness from their previous infection.”*

The CHD goes on to show several examples of vaccinated people who got the disease they were vaccinated against, for example, measles. Statistics from the CDC showed up to 30% of measles cases in 2019 were in people who were vaccinated against measles. The CHD cites four more cases in which researchers documented measles in individuals who were vaccinated.

Unfortunately, although vaccines are supposed to protect vulnerable people, those who receive certain vaccines can spread the diseases in a process called shedding. According to the CDC, individuals given a live attenuated influenza vaccine can shed the virus and spread the illness.

The CHD also notes other viruses that can shed or spread after vaccination include measles, rubella, chickenpox, rotavirus and shingles.

### Disease Decline Not Related to Vaccines

Probably just as important as the fact that the vaccines are not always safe, do not always protect against the disease and may cause shedding and spreading of the illness, is that government data show the vaccine program does not deserve the credit for alleviating problems in the U.S. against contagious diseases.

In fact, when you look at the data, it’s apparent that public health experts have lied about the importance of the vaccine program. As demonstrated by CHD, data from the National Vital Statistics System (NVSS), which is overseen by the CDC, unequivocally show that improvements in hygiene and clean drinking water triggered the

decline in mortality from these diseases before the vaccines were even introduced.

### Vaccines Are Big Business

In 2009, the *Globe and Mail* looked at the growth of the vaccine industry and how the H5N1 bird flu contributed to the growth of the flu vaccine industry, which soared 32% every year between 2004 and 2007. At the time, experts estimated the global vaccine industry would top \$40 billion by 2012.

In 2022, *Fortune Business Insights* released data from 2020 and estimated the global vaccine market at \$55.44 billion before COVID-19 shots were introduced. They then projected the market would grow to \$61.04 billion in 2021 and \$125.49 billion by 2028 with an estimated compound annual growth rate of 10.8%, the largest contributor of which would be the COVID-19 shot. The market analysis called this “*stellar growth.*”

In March 2021 Pfizer reported they expected sales of the COVID jab to total \$15 billion by the end of the year with a profit margin of 30%. However, by 2022 they had far exceeded expectations. According to Poynter, Moderna reported first quarter earnings in 2022 that were more than triple the same period the last year, earning \$5.9 billion in just one quarter.

This was dwarfed by Pfizer’s first quarter earnings in 2022 that grew 77% to more than \$25 billion compared to the same period in the previous year. According to CNBC, this growth was driven by \$13.2 billion in sales of the COVID shot in one quarter, compared to the \$15 billion in annual sales they “estimated” for 2021.

The CHD points out that in one year Merck sold \$3.15 billion worth of Gardasil. Fierce Pharma reported sales of Gardasil increased by 31% in the first quarter of 2019 after launching the product in China. Merck executives called this “unprecedented.”

Note that Gardasil has yet to demonstrate that it’s prevented a single case of cancer. Why? To prove its effectiveness against cancer, Merck would have had to wait roughly 35 years — or more — between giving the shot to young females and age 50, when the average woman develops cervical cancer. But they didn’t do that because, they said, “studying cancer itself isn’t feasible, because it takes too long.”

When you understand that Merck having to wait 35 years for a true efficacy finding would cost \$3 billion a year in sales over that 35 years, or about \$105 billion total, it becomes plain that it’s all about the money, not safety or efficacy. Who says vaccines aren’t big business?

The CHD also notes the revolving door between health authorities and Big Pharma. Dr. Julie Gerberding was the director of the CDC when Gardasil was approved. The CHD writes:

*“Her move from the CDC to Merck significantly increased her income. Apparently, she went from about \$172,000 in salary to around \$25 million in compensation from stock sales at Merck and CERN. Vaccines make billions of dollars for corporations and millions of dollars for some lucky insiders. If they weren’t such “gravy trains” do you really think they would be pushed so hard?”*

### Parents Must Make Health Decisions

# Public Health Officials Cash In On Covid

*“There is no art which one government sooner learns of another than that of draining money from the pockets of the people.”*  
- Adam Smith, *Scottish Economist and Philosopher*, 1776

It would appear as though not much has changed over the past 300 years. Governments still find ways to pick our pockets from every angle, and all current levels of government seem especially adept at this skill.

A look at the recently published Sunshine List (S/L) for 2021 supports Mr. Smith’s observation as it shows Public Health administrators being obscenely compensated for their efforts in purportedly fighting Covid.

One of the top earners was Penny Sutcliffe, Medical Officer of Health Sudbury. Her 2021 annual pay increased from \$347,324.55 to a whopping \$800,726.87. That’s right folks, we are looking at an increase of \$453,402.32. It was explained that this increase was effective for a 2 year period and that Penny was also doing double duty as the Associate Medical Officer of Health; a role which was vacated in April 2020. This begs the question, if one individual can cover another role for such a sustained period, might that other role be redundant?

**Some other notable increases, of which there are many, are as follows:**

Ian Arra, Medical Officer and Chief Executive Officer of Grey Bruce; pay increased from \$385,349.79 in 2019 to \$631,510.22 in 2020, an increase of \$246,160.43. This leveled off in 2021 to a pay of \$514,572.06; still significantly higher than in 2019.

Mustafa Hirji, Commissioner Public Health, Ministry of Health, Niagara; pay increased from \$296,583.32 in 2020 to \$457,013.15 in 2021, an increase of \$160,429.83.

Lisa Berger, Associate Medical Officer of Health for Toronto; pay increased from \$214,809.24 in 2019 to \$355,940.01 in 2020, an increase of \$141,130.77. This pay leveled off to a 2021 pay of \$329,212.93; still significantly higher than the 2019.

Robert Kyle, Commissioner and Medical Officer of Health for the Region of Durham; pay increased from \$337,142.41 in 2020 to \$535,190.04 in 2021, an increase of \$198,047.63.

Elsbeth McTavish, Associate Medical Officer of Health for the Region of Durham; pay increased from \$246,774.14 in 2020 to \$463,598.40 in 2021; a pay increase of \$216,824.26.

These are but to name just a few. It should also be noted that most of these people likely worked from home the past couple of years, which would have padded their pockets even more with savings on gas and meals. But they would probably argue that the time they would have spent traveling to and from work or eating lunch was spent working hard at ‘protecting the public.’

The Sunshine List includes ten (10) Associate Medical Officers of Health for the City of Toronto whose pay for 2021 totaled \$2,890,021.94, which is an average pay of \$289,002.19. This includes what appear to be two new hires with a combined salary totaling \$386,639. The increase for the remaining eight employees for the two-year period 2019-2021 totaled \$1,380,300.64, an average increase of 40.5%. I guess, if the bosses are getting big increases, their seconds-in-command deserve hefty increases as well. It’s only fair; and after all, it’s only tax dollars.

**Exorbitant pay increases**

When reviewing the Sunshine List, it’s only natural to dwell on the top earners, but closer examination shows these exorbitant increases were prevalent all the way down the Public Health ladder. Take the Region of Durham, Ontario for instance, where the total compensation for 37 individuals was \$4,819,617.67 in 2020. This increased to \$7,741,615.25 for these 37 individuals in 2021. Four (4) new additions to the S/L accounted for \$465,786.98 of the increase while the remaining 33 employees shared in an overly generous increase totaling \$2,456,210.60, an average increase of 50.96% per employee.

In addition to the aforementioned top earners, Robert Kyle (\$535,190.04) and Elsbeth McTavish (\$463,598.40), additional examples of the largest increases over a one year period are as follows:

Kavine Thangaraj, Director - Population Health &

Chief Nursing Officer, received an increase of 107% from \$156,623.05 to \$324,125.34.

Rebekah Anne Mills, Assistant Manager - Population Health, received an increase of 135% from \$131,154.59 to \$308,798.44.

Paula Hanley, Manager - Population Health, received an increase of 93% from \$144,060.50 to \$277,661.56.

Michelle Martin, Manager - Health Protection received an increase of 100% from \$119,532.96 to \$239,330.05.

Although Glendene Collins, Manager - Community and Resource Development, is not in Public Health, her pay deserves a spotlight as it increased a whopping 150% from



\$117,722.52 in 2020 to \$294,561.43 in 2021.

These are the amounts paid by the Region of Durham - Public Health for the top 37 earners as reported by the Sunshine List. The salary/wages budget is no doubt even higher when we include workers who make less than the \$100,000 Sunshine threshold. This makes one wonder where the funds came from to pay for these large increases and who approved these increases? Will these increases show up on future property tax bills? Were these obscene increases given in the form of one-time bonus payments, or, is the spending so out of control that these increases are permanent and we will be burdened with over-paying these individuals for years and years to come?

This generous bonus payment practice seems to be prevalent in other parts of the country as well. Deena Hinshaw, the Alberta Medical Officer of Health received a 63% bonus, or \$227,911, for her ‘hard work’ during the pandemic.

**USA Sunshine List also shows huge salaries for public health officials**

Dr Robert Malone, inventor of the MRNA Vaccine and a vocal critic of its current use, recently reported that he reviewed a similar Sunshine List in the United States (see [openthebooks.com](https://www.openthebooks.com)) and he discovered a similar pattern of high salaries for Medical Officers. It turns out that there are about 300 medical officers and other executives in the US government making in excess of \$400,000 per year. He goes on to say that the vast majority of physicians don’t make this amount of money annually as the average salary of a physician in the US is around \$195,000. Many U.S. corporate executives also don’t make this amount of money. So why is the US government paying these huge salaries?

Evidence indicates that large numbers of health bureaucrats from other provinces and other countries have been paid generously during the last few years. Is this money intended to encourage them to “keep up the good work and don’t ask questions”? When we look at the robust salaries paid to these health bureaucrats, it makes one think about how much better these resources could have been used in front line settings. The average salary for a nurse in Ontario on July 22, 2022 was \$105,831.00. The \$2,456,210.60 in additional compensation paid by the Region of Durham Health Department to 33 of its highest paid administrators could have paid for approximately 23 additional nurses. Bill 124 capped nurses’ annual salary increases at 1% — too bad there wasn’t a similar cap for health bureaucrats.

**3 million Canadians lost their jobs**

It would be remiss if we did not do a brief comparison of the private sector that fared very poorly over the last few years with countless lockdowns and onerous health measures to comply with. Public sector employment is up 10.8% while private sector employment is only up by 3.2%, and self employment is actually down by 7.2% over the period July

2019-July 2022. Simon Gaudreault, Chief Economist and VP of Research at the Canadian Federation of Independent Business (CFIB) recently told the Epoch Times that when looking at total paid employment during this same 3 year period, about half of it came from the public sector when normally only about one quarter should come from the public sector. The government has the resources to offer high paying jobs with lots of benefits as they can raise taxes or debt to pay for it. Three million Canadians lost their jobs during the Covid period; how many public sector workers lost their jobs or even missed a paycheck? Many private sector employees actually took pay cuts to help save their company and their job. About one third of small/medium businesses had temporary closures due to the pandemic. There were no such efforts made in the public sector.

Innovation, Science and Economic Development (ISED) Canada reported that small/medium enterprises employed 88.3% of the private sector labour force and that between 2019 and 2020 they were responsible for 92% of the employment changes — job losses — in the private sector. Hardest hit though has been the self employed. According to the CFIB, 62% of small businesses have pandemic debt and 78% say they are still experiencing pandemic stress. Meanwhile, back at Public Health in Durham Region, administrators pocketed an average 51% pay increase. At one time in history, people went into the private sector to make a higher salary and went into the public sector for job security. It appears as though the public sector now has a significant edge

on both counts. Which begs the question, who is going to pay these public sector salaries if the private sector is struggling? How much longer can we afford to have these people continue to ‘look after us’?

*“The problem with socialism is that you eventually run out of others peoples’ money”* - Margaret Thatcher

When health bureaucrats make more than most physicians, executives, frontline workers and private sector workers, it becomes evident that we have reached a point where we can no longer afford our government. The government needs to allow individual citizens to protect their own health; allowing them to keep their bodies healthier as well as their wallets.

# Can Britain Break From Feudalism or Will King Charles’ Great Reset Go Unchallenged?

“London Bridge is Down” were the code words delivered by the Queen’s Private Secretary Edward Young to high ranking officials upon the death of Queen Elizabeth II.

This code was selected as part of a larger protocol dubbed strangely enough “operation Unicorn” for reasons beyond the wildest imagination of this author and which sets into motion a set of actions culminating in the anointing of Prince Charles as the new King of Britain and the Commonwealth.

For Canadians who had thought they would no longer be forced to endure watching their Prime Minister slavishly declare his oaths of fealty (and oaths of secrecy) to an inbred monarch sitting on the other side of the ocean as had occurred in 2017 ([youtube.com/watch?v=xA92oPwKK70](https://www.youtube.com/watch?v=xA92oPwKK70)) they will be very disappointed. Canada’s Parliamentary Oaths Act of 1866 demands that both houses of Parliament are required to take pledges of allegiance after the deaths of all sitting monarchs. That’s right, every single member of the supposedly “elected and democratic” government of Canada must declare their oaths of fealty not to the people or non-existent constitution, but to some inbred family bloodline on the other side of the world.

Similar oaths will be read by elected officials across every other Commonwealth Five Eyes member state.

It is thus worth asking, is this institution of hereditary powers which Charles has inherited just a ceremonial gig with no real substance or influence behind it?

Although the majority of citizens including British subjects believe this to be the case, the facts point to a very different reality.

## Prince Charles Just Became the World’s Largest Property Owner

This may surprise you, but the British Crown happens to be the world’s largest property owner clocking in possessions amounting to 6.6 billion acres ([businessinsider.com/worlds-biggest-landowners-2011-3](https://www.businessinsider.com/worlds-biggest-landowners-2011-3)) across Australia, New Zealand, Northern Ireland, Canada, Great Britain and the Falkland Islands.

On top of the “Crown Lands” and “Crown Corporations” which are legally owned by the monarch of Britain, an organization called ‘The Crown Estate’ is one of the world’s largest property groups. *“The Crown Estate owns property all across the UK, from castles and cottages to agricultural land and forests plus retail parks and shopping centers. It owns more than half the UK’s entire seashore, giving it hugely valuable auction rights for offshore commercial activity, such as wind farms.”*

The Crown controls nearly the entire seabed (and half the seashore) around the UK with any business wishing to build offshore windmills as part of the Green New Deal forced to rent their sea beds from the Crown Estate. A July 2022 edition of Australia’s Spectator ([spectator.com.au/2022/07/prince-charles-great-reset](https://www.spectator.com.au/2022/07/prince-charles-great-reset)) aptly characterized the Prince’s misanthropic activism in the following terms:

Where one paradigm assumes as self-evident the existence of inalienable rights of all people, the other system presumes that the only inalienable rights are those held by an oligarchical master class who wish to rule over subjects (aka: useless eaters) whose population levels must be periodically culled for easier management.

The supposition that rights cannot be granted or withheld by a superior bloodline is truly anathema to any system of oligarchism even if it masquerades behind the costume of a species of democracy designed to placate plebs but not allow them or their representatives the means of influencing anything truly meaningful about their reality.

It is evident that the new incoming King of England has taken on the worst traits and dispositions of oligarchism and probably won’t willfully make any positive changes (or learn any useful real world skills) without being pulled by the scruff of the neck.

Perhaps British citizens who have been fed generations of royal propaganda will finally get sick of their new green warrior king before mass famines and death-by freezing sweep across the Commonwealth and decide to catch up with the 21st century and become a real nation.

# Follow The Yellow BRICS Road

I am speaking of their affiliations to Non-Governmental Organizations (NGO's), which are groups that function independently of any government. They usually operate on a non-profit basis although they can hold millions and even billions in reserves. NGOs are established on community, national, and even international levels and are designed to serve a social or political goal. Some of these organizations are a force for good attempting to better the lives of the populations of third world countries with increased standards of education and health care.

Although there have been some in recent times that have been involved in the sexual exploitation of the very people they were meant to be helping, as in February 2018 a report by the UK's House of Commons International Development Committee found that sexual abuse was *"endemic across the international aid sector"* and targeted both locals and staff members. This begs the question as to how these organizations can receive government funding (our money), without there being any form of governmental oversight.

So, why are all the above-mentioned people still in office and able to wield power, when they should be in jail for "Political Crimes"? Surely they cannot serve the people that elected them and the World Economic Forum at the same time!

## Progress in Court Cases and Big Hearings in the Fall

A number of legal challenges emerged countering mandates, restrictions, and government overreach. Most resolutions to date were in favour of protesters and those opposing government mandates. The fines imposed on Artur Pawlowski, as well as many other Canadians, were thrown out in court and many protesters have been released. Overall, public support for harsh treatment is waning.

Here are a few of the major cases starting or continuing this fall mounted by civil liberties groups:

**JCCF- The Justice Centre for Constitutional Freedoms**

The JCCF is supporting past Newfoundland Premiere Hon. Brian Peckford and others in the trial *Peckford et al. v. Transport Minister*. They wished to challenge the entirety of the COVID mandates and restrictions but had to pick a specific violation for the courts. Their argument claims the travel ban directly infringes upon section 2, 6, 7 and 15 of the *Charter of Rights and Freedoms*.

The travel ban was announced in October of 2021 and the case filed the following January. In May and June the JCCF cross-examined five government expert witnesses and compiled 14,000 pages of evidence. The governments-chosen experts had some shaky grounds for support of the mandate:

- Celia Lorengo, approved the vaccines as they were, "above 50% effective" and later admitted that it was closer to 20% effective and after mutation protection disappeared nearly completely.
- Fertility expert, Paula Quinn, when asked about the Pfizer data dump, stated she had not heard of it.
- Jennifer Little, a member of the COVID response team, stated there was no medical reason for the domestic travel ban and it was the most strict in the

world, suggesting vaccine mandates were politically motivated.

The Liberals announced the suspension of the travel ban during these cross-examinations and requested that

to be protected by cabinet confidence. Liberals will be scrutinized more heavily and will need to broaden their provisions and reduce redactions in some capacities going forward. Justice Mosely determined there should be more scrutiny to what falls under cabinet confidence. These files will be made available in the coming weeks.

The Supreme Court will hear the CCLA's views on broadening cabinet confidence use in relation to transparency and oversight in an unrelated case.

**TDF - The Democracy Fund**

TDF is mounting cases for the students of Western University and University of Toronto in response to mandates on campus in the fall. They have written letters to the Universities recommending alternatives that are less disruptive, but will likely need to resolve the issue in court. The cross-examinations in these kinds of cases elucidated much obscured or protected information. Preliminary scheduling commenced on September 9 for the trial concerning Western.

A notice of application was filed against the Minister of Health over the ArriveCAN app. The government has been relying on the Quarantine Act to justify most mandates and restrictions. TDF is arguing that the imposition and forced collection of personal data violates the Charter of Rights and would not be justified by the Quarantine Act.

**Public Order Emergency Commission into the use of the Emergencies Act**

Civil liberties groups including the JCCF, TDF and CCF will be involved in Rouleau Commission (<https://publicorderemergencycommission.ca>), an inquiry that is enshrined in the Emergencies Act. The justice appointed by the Liberals is a long-time Liberal donor and the legal groups expect more disruptions to the processes. This commission has been delayed as Justice Rouleau is currently recovering from surgery where it will now resume October 13 and conclude November 25.



the case be rendered moot. After the dates for hearing were released they were pushed back several times. The mootness hearing is September 20 and the main hearing was set for October 31, if not determined obsolete. They are also challenging vaccine mandates in Ontario.

An earlier challenge lead to a cross-examination of Deena Hinshaw and the release of memos which revealed she may have perjured herself. They are waiting on a trial date for a challenge against ArriveCAN. Seneca College students are being supported by the JCCF against campus mandates.

# Why Russia and China Do Not Want War

In 1961, a Soviet KGB secret intelligence General named Anatoliy Golitsyn defected to the USA and brought startling news which has been downplayed and hidden by the establishment ever since. He predicted the "collapse of Communism" about 30 years before it happened. Golitsyn, who had been privy to Soviet long-term planning, claimed the coming "collapse of communism" was really phase 2 of the Cold War. He revealed that the international communists realized in 1957 that they could never defeat us by war. Therefore they planned to conquer us by more subtle means. The new strategy to be used against us was called "convergence."

Convergence is a multifaceted strategy to remake the meaning and composition of our way of life into another form, by peaceful steps. It is war without guns, financed by our money and implemented by "our" leaders. One facet of convergence is immigration. There is no longer much need for spies, when their people can simply take up residency here. The West now has millions of foreigners in our governments, corporations, universities and even religious institutions. By simply replacing our population, or at least the majority of voters, we become a totally transformed culture. The attendant multiculturalism changes the meaning and focus of society into an alien pattern. The breakdown in morality which has happened since 1957 leaves people directionless, with no solid understanding of right and wrong to defend against the overall assault. All this is convergence.

The new communist plan is essentially the Oriental strategy laid out by the ancient Chinese philosopher, Sun Tzu. In his book, *The Art of War*, Sun Tzu stressed that wars should primarily be fought by deception, rather than physical combat. He stressed that, by removing our perception of them as an enemy, they can walk right into our camp and take us over from within. That is another facet of convergence which has been successfully used against us.

Russia has a solid, mutual defense pact with China, so a war with Russia means war with China too. In the past 30 years, most of our industries have been moved to communist China, thanks to billionaire communists in our midst. The time to fight China would have been before we made them into a major power. As it stands, if we fight a war with China, we'll have to beg for a truce every couple of weeks, so they can resupply us.

Why would the "former Communist" nations risk money and blood to overcome us, when their long-term plan is working so well? But the fact that the "former communists" do not want war does not mean we won't have it. The late historian Eustace Mullins wrote that, back in the 1800's, the World Order planned three world wars. The first was to create the atheist state (USSR and Red China). The second would make the atheist state into a world power (WW2). The third war would destroy both atheism and Christianity at the same time, so that pure Lucifer-worship would reign unopposed, globally.



"Our" leaders are working hard to start that war, today, in Ukraine. President Biden and Canadian Deputy Prime Minister Chrystia Freeland have both called for regime change in Russia.

The war is also being started on another, subtler level, through crippling economic sanctions against Russia. The purpose of sanctions is to provoke war. It is important to bear in mind here that the Japanese attack on Pearl Harbour was in retaliation for similar sanctions against Japan. The sanctions on Russia work both ways, too. They weaken and impoverish Western populations dependent on Russian food, petroleum, etc. All this is part of the globalist plan to depopulate the earth.

The World Order often uses the same tricks over and over, so here another parallel with WW2 comes to mind. "Our" leaders always want to appear as the guys in the white cowboy hats, so they provoke other nations to attack and then pretend to "defend" against that. As outlined in the 1976 best-seller, *A Man Called Intrepid*, before WW2, the British secret service organized "secret

armies" in several nations of Europe. Today, these would be called terrorist organizations. After WW1, a big chunk of Germany was given to Poland. The secret army there began killing the German minority population. People in Germany wanted to protect them. Hitler feared that invading Poland would give the UK an excuse to start a war but after 10,000 Germans had been murdered, he invaded anyway and Britain immediately declared war. How much the allies really cared about Poland became clear after the war, when Poland was handed over to the enslaving USSR. The same strategy is being used against Putin today, in the Ukraine, where the Ukrainian government has been persecuting and killing the minority Russian population of Donbass. It is naïve to believe that "our" leaders really care about the poverty-ridden people of Ukraine. Once again, they are using a little country to start a big war. At the same time, the same leaders are provoking a fight with China over Taiwan.

So the Russians and Chinese do not want war but it looks like we might get it anyway. That communism and capitalism are "opposites" is establishment propaganda. The capitalists own the communists and they always did. The Bolshevik Revolution in Russia was financed by \$25,000,000 in gold from New York banker Jacob Schiff. Communist and environmental activism in the West would never have gained a foothold without constant grants from capitalist foundations. It

is enlightening to notice the billionaire leaders of Red China, who easily manage to be capitalists and communists at the same time. Capitalism and communism are merely two features of Third World culture, where a few rich people control all the money and the remainder are held in destitution by rigid rules—a way of life which the World Order has in mind for us.

Anatoliy Golitsyn wrote two books to warn us of the new communist strategy. They are *New Lies For Old* and *The Perestroika Deception*. Now that we can see the strategy coming true, they are more interesting than ever.

# News From Around The World

## Former BBC Radio Presenter Jailed For “Online Stalking”

A popular British YouTube presenter and ex BBC employee has been jailed for five and a half years for a ‘campaign of harassment’ against BBC employees and journalists.

Over a nine-year period, the court heard that Alex Belfield posted regular messages on his social media accounts, sent emails, and made YouTube videos about the four complainants including Jeremy Vine. Belfield justified his online actions by stating: “I am a journalist who is instinctively going to upset people by the nature of what I do. Nobody wants to be exposed. Nobody wants to be caught out.”

Belfield’s charges stated that he “pursued a course of conduct that amounted to harassment of the complainants”, which caused them “serious alarm and distress” and “amounted to stalking.” According to the *Yorkshire Evening Post*,” Belfield denies eight counts of stalking spanning a period between 2012 and 2021, after his contract with BBC Radio Leeds was not renewed.”

Despite the deceiving mainstream headlines, Mr Belfield was not accused of physical stalking against the complainants, who were mostly made up of current or former BBC staff. Prosecutor John McGuinness said: “The stalking which this case is concerned with is of a different type-and is more akin to internet trolling.”

BBC top earner Jeremy Vine described Belfield’s online behaviour as “like an avalanche of hatred you get hit by”, and “absolutely Olympic-level stalking, even for broadcasting.” In a despicable comparison, Vine labelled Belfield the “Jimmy Savile of Trolling” in court. He said: “This is not a regular troll here.

This is the Jimmy Savile of Trolling.” Vile and evil Jimmy Savile was an BBC employee for decades and is one of the UK’s most serial sexual predators ever seen.

Belfield responded to the deplorable association with Savile by saying: “What possible reason could Jeremy Vine have said this in front of you other than to destroy me and get the headline of the century, which he did. He thought of the most evil, awful person in media history and compared him to me. For him to associate me with Jimmy Savile is unthinkable.”

Melodramatic Vine continued, “it felt like I had a fishhook in my face and my flesh was being torn, and the only way to avoid further pain was to remain completely still.” Belfield called Vine’s antics in court as “the cleverest razzle dazzle I’ve ever seen.”

Belfield who defended himself in court said in his closing speech that the BBC was trying to “shut me up” because of “inconvenient truths”. He added: “As a whistle-blower of the BBC, I was there for 15 years and I saw where the bodies are buried, if you like, and I saw where they wasted money.”

Belfield told the court he has a right to freedom of speech and had legitimate reasons for posting the messages. During the court hearing Belfield told the jury: “I’m a Nottingham lad with a potty mouth and I speak as I find it, and I appreciate that’s not to everyone’s taste. People who claim I was stalking them were actively seeking out my content. Human rights allow me to have free speech in this country, until you are given bail conditions where you cannot speak.”

Popular online political and social observer Paul Joseph Watson (PJW) tweeted about the case: “5 years in prison for ‘online harassment’ (tweets mainly) while members of grooming gangs up and down the country avoid jail. Absurd.”

Belfield hosted a YouTube channel called *The Voice of Reason* with a large, subscribed following over 350,000. Belfield is often described as a ‘marmite’ type presenter and is known for his sneery, crude sarcastic language. His presenting style is not to everyone’s taste as he mentioned at Nottingham Crown Court.

However, the severe custodial sentencing handed out to Alex Belfield for ‘cyber stalking’, or serious online trolling sets a worrying precedent for the future of free speech online and plays nicely into the hands of advocates for the UK Online Safety Bill proposed.

The sentencing appears politically motivated and entirely disproportionate to the alleged crimes he committed. The apparent witch-hunt and piling on from the BBC during the case may act as a deterrent to anyone wishing to go up against large institutions in the future.

## Nigeria Bans Foreign Models and Voiceovers in Adverts

Nigeria is unapologetically banning foreign models and voiceovers from advertisements in a move to develop and promote indigenous Nigerian talent.

The Advertising Regulatory Council of Nigeria (ARCON) said in a statement on August 22: “All advertisements, advertising, and marketing communications materials are to make use of only Nigerian models and voiceover artists. Ongoing campaigns are permitted to run out their terms, however, subsequent applications for revalidation for continued exposure of such materials will not be granted by the Advertising Standards Panel (ASP). Advertisers, advertisement agencies, media houses advertising community and the general public are hereby enjoined to take note.”

Head of ARCON, Olalekan Fadolapo, said: “Advertising should resonate with people. How do you think it will resonate if we keep using foreign artists?”

Steve Babaeko, president of the Association of Advertising Agencies of Nigeria

told the *UK Times*: “Ten to 20 years ago if you checked the commercials, I would say they were almost 50/50 in terms of foreign faces and all the voiceovers were British accents.” He added, “People will tell you, there are about 200 million of us. Are you telling me you could not find indigenous models for these commercials?” Babaeko believes the new law in the former British colony will act as a ‘kind of renaissance’ to ignite confidence in local artists and bolster the Nigerian economy.

British-Nigerian author, Lotanna Igwe-Odunze, reacted to the prioritization of Nigerian talent by saying: “The government banned foreign models, not white models. White models are foreign to Nigeria, so of course, they are naturally banned, however, the bans bars anybody who simply isn’t Nigerian. Huge difference.”

One has to wonder what would happen if Nigerian models were banned from other countries? ‘Tolerant liberals’ must be engaging in ‘mental gymnastics’ regarding the ‘Nigeria First’ policy.

The ban is in line with the country’s federal government policy to grow local talent and improve the economic growth of the country. Nigeria’s brazenness and ingenuity to solely focus on creating new jobs for local indigenous talent should be admired and applauded.

The ban will come into effect from October 1 which also happens to be Nigerian Independence Day.

## Brave Irish Teacher Jailed Over Pronoun Dispute in Secondary School

A secondary school teacher has been jailed for refusing to use the pronoun “They” in a controversial High Court case in Ireland. Enoch Burke from Co. Mayo was imprisoned for contempt of court after refusing to adhere to a court order secured from his school over the issue of gender identity.

The disagreement began in May when an email was sent by the principal of Wilson’s Hospital School in Co. Westmeath asking all teachers to use the pronoun “They” for a male student transitioning. Based on religious grounds, Mr Burke said he would

refuse to call the student their requested pronouns and publicly confronted the then principal of the school over his concerns during the summer. As a result of his objections, Mr Burke was placed on paid administrative leave from teaching at the school pending the outcome of a disciplinary process.

In September, the situation intensified when despite the suspension, Mr Burke attended the school and sat in an empty classroom willing to teach his students. Concerned, the debacle may cause disruption to pupils, the Church of Ireland school in Multyfarnham secured an ex-parte temporary High Court injunction preventing Mr Burke from either teaching at its premises or from teaching any classes at the school while he remained under suspension. According to the *Irish Independent*: “Despite this order, he continued to come to the school each morning. This led to a further application from the board of management, and Ms Justice Miriam O’Regan ordered on Friday that Mr Burke be arrested and brought before the court.”

Addressing the court and representing himself without legal assistance, Mr Burke said: “I am a teacher, and I don’t want to go to prison. I want to be in my classroom today, that’s where I was this morning when I was arrested.” Mr Burke has been a teacher at the school for the past four years.

The German and History teacher also responded to his suspension from school and contempt of court by saying: “It is extraordinary and reprehensible that someone’s religious beliefs on this matter could ever be taken as grounds for an allegation of misconduct. My religious beliefs are not misconduct. They are not gross misconduct. They never will be. They are dear to me. I will never deny them and never betray them, and I will never bow to an order that would require me to do so. It is just not possible for me to do that.”

During the court hearing on September 5, Justice Michael Quinn was satisfied that Mr Burke breached the injunction and was in contempt of court. He said, “I order he be committed to Mountjoy Prison and remain therein until he purges his contempt or until further order of this court.” Enoch Burke responded passionately to the court outcome by saying: “It is insanity that I will be led from this courtroom to a place of incarceration, but I will not give up my Christian beliefs.”

Once again, the international issue of compelled speech and the imposition of transgender ideology is showing its ugly fascist head again. Renowned Canadian Psychologist Jordan Peterson warned society in 2016 that once you make ‘Gender Identity’ a protected class, you are compelling people to use speech against their own logic, reality, and belief system. Jordan Peterson recently commented on his Facebook page about the Burke case: “I said very clearly in 2016 that the first people jailed for ‘pronoun misuse’ would be dragged through the courts and then hit with contempt charges. “Nobody will be jailed for pronouns” was the reaction. Wrong. More than once now.”

At the time of writing, Mr Burke is still enslaved at Mountjoy Prison in Dublin. Enoch Burke told the court: “If this court so determines, I will never leave Mountjoy Prison if in leaving the prison I violate my well-informed conscience and religious belief and deny my God.”



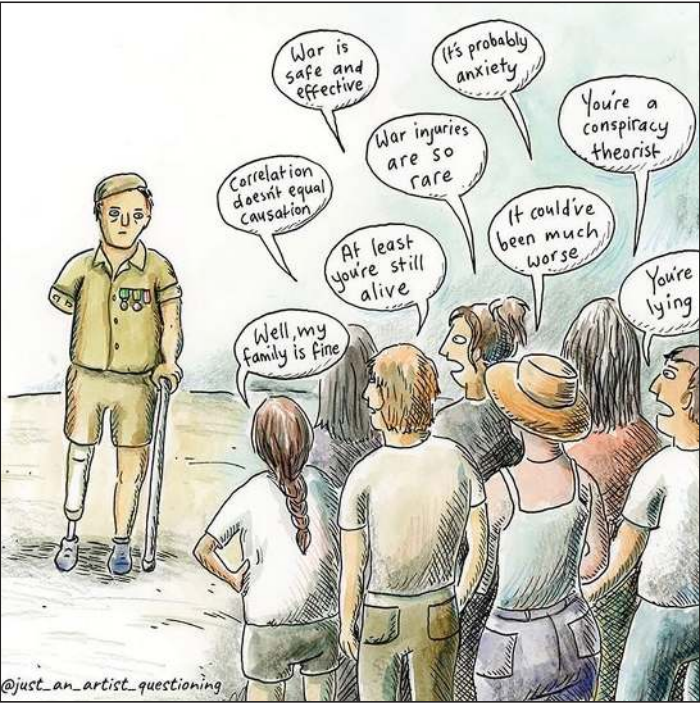

## Some Of The Most Absurd Things That Have Happened In Recent Weeks

- **An Ottawa police officer accused of donating money to the Freedom Convoy has been charged with misconduct.** Constable Kristina Neilson has been accused of acting in “a disorderly manner ... bringing discredit upon the reputation of the Ottawa Police service” for donating to a fund where “the money was being raised for the illegal occupation known as the Freedom Convoy.”
- **Ottawa police detective charged for seeking links between COVID vaccine and child deaths.** Ottawa Police detective with the sexual assault and child abuse unit, Helen Grus, is facing a charge of Discreditable Conduct after investigating unexplained deaths of children with potential links to the Covid 19 vaccines.
- **Saskatoon woman dies suddenly inside of a Shopper’s Drug Mart within minutes of receiving the new bivalent COVID-19 booster shot.** A spokesperson from Saskatchewan Health announced that Carol Pearce died from “natural causes,” but the family disagrees. “I do not believe this was caused from natural causes,” Pearce’s daughter said. “My Mom had no health conditions. I believe had she not gotten that Covid shot then she would be here with us today!” Carol and her daughter were pro-vaccine, getting all of the required COVID-19 shots.
- **Health Canada approves Pfizer COVID-19 vaccine for kids six months to four years old** despite the company’s own data showing the vaccine increased the risk of COVID-19-related hospitalizations by 3 times. The vaccine also showed little to no efficacy after doses 1 and 2.
- **COVID Vaccine destroys natural immunity,** a large study published in *The NEJM* (Lin et al.) says. The study, conducted by public health researchers at the UNC and the North Carolina Department of HHS, found the efficacy of Pfizer’s COVID-19 vaccine in children age 5 to 11 was not only negative some 5 months after being vaccinated (meaning, the vaccinated are more likely to be infected) but that the vaccine also destroyed any protection a child had to COVID from naturally acquired immunity.
- **City of Toronto ad campaign suggests kids must be vaccinated for Covid to enjoy a normal life.** The manipulative campaign, aimed at parents and caregivers implied that children need Covid vaccines so they can get back to a normal life. One ad showed children being isolated from school and their friends because “there’s still something going around.”
- Study finds that **today’s children are 30% less aerobically fit than their parents were at their age.** Strangely, the study, published in *Temperature* (Morrison et al.) points to “climate change” and rising temperatures adversely affecting childhood obesity, as children spend less time exercising outdoors.
- Long-term scores for NAEP (“The Nation’s Report Card”) shows an **unprecedented decline for kids in math and literacy.** Two decades of growth for American students in reading and math were wiped out by just 2 years of plandemic-disrupted learning.
- **Leaked Documents Reveal Serious Quality Issues in the mRNA Vaccines.** Leaked emails from late 2020 revealed that European regulators had significant

concerns over the lack of intact mRNA in the commercial batches sampled. Compared to the clinical batches (the shots used in the clinical trial,) 55% to 78% of the commercial shots had “a significant difference in % RNA integrity.” For an effective product, mRNA integrity needs to be 100%. Considering how ineffective the jabs are, it’s fair to question whether lack of



mRNA integrity might be to blame.

- Study published in *The Journal of Clinical Medicine* (Fujio et al.) finds that **vaccinated patients are rejecting cornea transplants at an exceptionally high rate.** The study found that of all the patients experiencing corneal rejection, 95% of patients had a COVID vaccination within the last 3 weeks.
- Weeks after **California announces a ban on the sale of gasoline cars** in the name of climate change, California also tells its residents not to charge their electric cars to avoid “straining the grid.” Fuelling private jets and other activities and modes of transportation used by the elite are ok.
- **FBI told Facebook, Hunter Biden’s laptop was “Russian disinformation.”** According to Facebook CEO Mark Zuckerberg and several FBI whistleblowers, the FBI worked actively to deceive Facebook into censoring information about Hunter Biden and the 2020 election. In light of these allegations, the bureau responded, “the FBI routinely notifies U.S. private sector entities, including social media providers, of potential threat information, so that they can decide how to better defend against threats.”
- Chris Cox, the Chief Product Officer at Meta (Facebook) Platforms, testified at a Senate hearing that **Meta held regular meetings with CDC, the HHS, and the World Health Organization to help shape their misinformation policies and censor user’s speech.** A Freedom of Information Act Request by ICAN (the Informed Consent Action Network) found that the CDC even celebrated the removal of prominent anti-vaxers from social media platforms in group emails.

- **The UK government introduces stringent anti-protest law** where they can act on “noisy protests that have a significant impact on others” or disrupt an organization’s activities. This new law resulted in female protesters being arrested after the queen’s death. One for holding sign saying “abolish monarchy, Fuck imperialism”, another for holding a “not my king” sign, and another for yelling “you’re an old sick man” to Prince Charles.
- **The World Economic Forum promotes brain implants to children.** In a blog post posted to their website, The World Economic Forum (WEF) called on governments, health officials, and “humans” around the globe to consider their arguments for implanting chips in children’s brains, stating that they form part of a natural evolution that wearables once underwent.
- New study published in *Science Direct* (Fraiman et al.) finds that the risk of serious adverse events from either the Pfizer or Moderna mRNA vaccine greatly surpassed the risk reduction for COVID-19 hospitalization relative to the placebo group. Meaning: **the vaccine recipients’ risk of experiencing a serious vaccine injury was greater than the unvaccinated risk of being hospitalized for COVID** (57% more likely for Moderna, 77% more likely for Pfizer).
- **The average lifespan of Americans of all ethnicities has dropped nearly 3 years in the last 3 years,** CDC study says. In 2019, the average American life expectancy was nearly 79 years. By the end of 2021, life expectancy had dropped to 76. Before the plandemic, global life expectancy was consistently getting higher by a few months every year.
- **The Ministry of Environment & Climate Change Canada is hiring “climate police” and building a new Climate Enforcement facility in Winnipeg.** The Facility will be home to an armoury, interrogation rooms, biological labs, media relations offices, “controlled quiet rooms,” and intelligence facilities. The Ministry is currently looking to recruit a battalion of Climate “Pollution” Officers, a unit within the coldly named “Environmental Enforcement Directorate.” The Impact Assessment Act, which was quietly passed in the final days of Trudeau’s majority government, grants sweeping power to Ministerial Climate Police, including the power to enter premises without a warrant to “verify compliance or prevent non-compliance with [the Act].”
- Mainstream media refuses to apologize for calling Ivermectin an ineffective horse paste. A study published in the medical journal *Cureus* (Kerr et al.), analyzed data from 223,128 people from Brazil and is the largest study of its kind. **The peer-reviewed paper showed a 92% reduction in mortality in participants who took Ivermectin.** Researchers wrote, “Non-use of Ivermectin was associated with a 12.5-fold increase in mortality rate and a seven-fold increased risk of dying from COVID-19 compared to the regular [prophylactic] use of Ivermectin. This dose-response efficacy reinforces the prophylactic effects of Ivermectin against COVID-19.”
- **The FDA authorized Pfizer’s mRNA COVID bivalent boosters without any human testing.** It was tested on a total of eight mice. The FDA did not allow members of its Vaccines and Related Biological Products Advisory Committee (VRBPAC) to meet, discuss or vote on the matter.
