Nearly 5 Million Adverse Events Reported By Pfizer's Own Document

The numbers were staggering, with 1.6 million adverse events jumping off the page. But guess what? The actual report from Pfizer is even more shocking.

December 2021 and June 2022. However, when you dig into the cumulative data from December 2020 to June 2022, the adverse event count skyrockets to almost 5 million. Talk about a jawdropping revelation!

What you really want to focus on is the "C" column, which represents the cumulative cases from December 2020 to June 2022. This column reveals the serious adverse events, including those categorized as Death, Life Threatening, or resulting in Disability/Permanent Damage.

It's great to see this news gaining more traction, it is crucial. While many of us have been focused on VAERS over the past two years, it is even more important to shed light on Pfizer's 393 pages of Adverse Events. Allow me to explain why through a Q&A format.

Before we proceed, I want to mention a caveat: I am not a Pharmacovigilance("PV") expert. Therefore, most of what I'm about to share is based on my interactions with former PV colleagues.

Is this VAERS Data?

No, this is not VAERS.


So, what is the difference between this and VAERS?

VAERS is a U.S.-based system used for capturing Vaccine Adverse Events. It allows individuals, healthcare providers, and vaccine manufacturers to report

Is this 393-page Adverse Event underreported?

In my opinion, yes. It shares similarities with the underreporting issues seen in VAERS. However, there are also systematic methods employed by Big Pharma to deliberately underreport Adverse Events.



What are Spontaneous vs Non-Spontaneous AEs?

Spontaneous adverse events occur when individuals

independently report negative reactions to drugs. On the other hand, non-spontaneous adverse events are identified through meticulous studies, such as clinical trials, or through monitoring conducted by researchers or drug companies.

Regarding the 5 million adverse events, how many doses of Pfizer's mRNA vaccine were administered in relation to these cases?

2.693.922.584 administered (https://tkp.at/wp-content/ doses. uploads/2023/03/3.PSUR-1.pdf)

To put this into perspective, there have been 4,964,106 adverse events reported, indicating a 0.184% chance of an adverse event for every administered dose. This means approximately 1 adverse event occurs for every 543 doses administered!

Now, using Senator Rennick's numbers from the April 2022 update, I calculated the ratio of Serious AEs to Non-

serious AEs.

With 28.8% serious AEs, it appears that we are observing 1 Serious Adverse Event for every 1887 doses administered.

This is above Fraiman's paper (1 in 800 serious adverse events), maybe it could be explained by the underreporting.

1 in 2000 doses for every SAE is still a very bad ratio!

Due to its unverified nature, CDC Director Rochelle Walensky has stated that VAERS may have an overreporting of adverse events. She mentioned that examples like "people getting hit by a truck" are included in VAERS, highlighting the range of reports it collects.

On the other hand, pharmaceutical companies employ robust pharmacovigilance systems to capture adverse events associated with their products. These systems involve a more comprehensive and thorough process of data collection, assessment, and verification.

In essence, internal Adverse Event data is verified. This means that whenever they receive a report, there is someone internally verifying the accuracy of the data. In some cases, they may reach out to the patient or docit. "Public" documents, such as Annual Reports, are accessible to everyone. "Restricted" documents may be limited to employees and contractors/suppliers. "Private" documents may be restricted to employees only. "Confidential" documents may be available to custom-defined groups, such as regulators. The release of these documents to the public is typically determined by regulators, and acquiring them may involve additional processes like Freedom of Information (FOI) requests. It's important to note that "Confidential" does not necessarily mean leaked; it often means the document is subject to certain restrictions.

The documentation systems in place are complex, they give me nightmares up to this day. "Documentum" is commonly used in the big pharma I worked with, and tech geeks may have more insights about it.

Anyway, thanks to Twitter, I recently became aware

I believe this is a significant **issue**, as it involves an Out of Spec situation. Both the FDA and Pfizer are aware of it, and now it has been officially documented. Multiple laboratories across the globe have replicated Kevin's findings, which further validates the concerns. An immediate investigation followed by a product recall is necessary.

hy would the Liberals be given the benefit of the doubt — yet another appeal to incompetence — when C-18 represents an obvious continuation of their efforts to narrow the realm of discussion and debate in this country?

In a move that should surprise nobody — given the fact that Meta promised to take this exact action if Bill C-18 passed — the company is ending news sharing on Facebook and Instagram in Canada. Here's their full announcement:

"Today, we are confirming that news availability will be ended on Facebook and Instagram for all users in Canada prior to the Online News Act (Bill C-18) taking effect.

We have repeatedly shared that in order to comply with Bill C-18, passed today in Parliament, content from news outlets, including news publishers and broadcasters, will no longer be available to people accessing our platforms in Canada.

Earlier this month, we announced that we were conducting product tests to help us build an effective product solution to end news availability as a result of C-18. These tests are ongoing and currently impact a small percentage of users in Canada.

The changes affecting news content will not otherwise impact Meta's products and services in Canada. We want to assure the millions of Canadians on our platforms that they will always be able to connect with friends and family, grow their businesses and support their local communities.

We will continue to combat misinformation and have built the largest global fact-checking network of any platform by partnering with more than 90 independent fact-checking organisations around the world who review and rate viral misinformation in more than 60 languages globally. Fact-checking will continue with respect to content that remains available in Canada."

If the Liberal government claims they are surprised by this action, they are lying. Here's what Meta said on June 1st of 2023:

"As we have shared, content from news outlets, including news publishers and broadcasters, will not be available to people accessing

"Today, we are confirming that news availability will be ended on Facebook and Instagram for all users in Canada prior to the Online News Act (Bill C-18) taking effect."

Facebook and Instagram in Canada if Bill C-18, the Online News Act, is passed into law. As we prepare to comply with the legislation, we are announcing today that we will begin tests on both platforms that will limit some users and publishers from viewing or shar-

Now, an honest government should actually support this. A government that believes in freedom of speech, and believes in true 'Liberal Democratic' values as we once understood them would be happy to see a proliferation of media outlets and perspectives thriving online. While there are obvious downsides to this — the ability for extreme groups and vile



opinions to be more easily shared — those downsides are outweighed by the fact that information flows much more freely because of social media, and because more discussion — rather than less discussion — is how we arrive at the truth over time.

But for a government that has a penchant for lying — like the Liberal government does — the free flow of information is seen as a threat to their political power.

Thus, by driving Meta to end news sharing in Canada, C-18 achieves the Liberal government goal

of narrowing the b o u n d s of free speech. It will also w e a k en many independent news o utlets, and weaken estabincompetent.

Yet, the warnings of what would happen if they passed C-18 without changes were so clear, and the end of news sharing on Facebook in Canada fits so well into the long-term goals of the Liberals that the incompetence defence doesn't hold up.

This is what they wanted.

They either would have gotten Meta to 'back down' (which would have played well in Quebec), or they would have weakened the independent outlets that have been galvanizing opposition to their actions. It's a win-win for the Liberals.

But of course, the rest of us lose out here.

Canada is now an outlier among most democratic nations with our access to news on a major platform — part of the essential digital public square — has been seriously constrained. The federal government doesn't get an 'incompetence' pass on this one. They have shown their hostility to free expression and the free flow of information time and time again.

If we want to preserve our liberty and our democratic way of life, we must speak out against this legislation and support the independent outlets that could be most impacted.

I encourage you to contact your MP and the Senators in your province and encourage them to pressure the government to make the necessary changes to C-18 (such as removing the demand of payment for links). And, if you are able, I encourage you to make a financial contribution to this website. It is essential that we don't allow the Liberals to get away

with their efforts to weaken those voices who hold them accountable.

Truth Catching Up with the Lie?

A recently released Cleveland Clinic study involving 48,344 of their working-age healthcare employees, is being touted as proof positive that the more vaccinated a person was, the more likely they


were to become infected with Covid-19. The yet-to-be-peer-reviewed study entitled "Risk of Coronavirus Disease 2019 (Covid-19) among those up-to-date and not-up-to-date on Covid-19 Vaccination", can be found here: (news-medical.net/news/20230614/Beingnot-up-to-date-on-COVID-19-vaccinationlinked-to-lower-risk-of-Infection-studysuggests.aspx)

The 100 days-long study, authored by Shreshta, Burke *et al*, of the Department of Infectious Diseases at Cleveland Clinic, notes that, "The CDC recently defined being up-to-date" on Covid-19 vaccination as having received at least one dose of a Covid-19 bivalent vaccine. The authors note that, "The purpose of this study was to compare the risk of Covid-19 among those up-to-

date and not up-to-date on Covid-19 vaccination". In a nutshell, the Ohio-based Cleveland Clinic researchers decided to test whether the CDC guidance made any sense. Spoiler alert. It did not end well for the CDC.

In its summary, the study notes that among 48,344 working age Cleveland Clinic employees, those not "up-to-date" (according to the official CDC definition)

had a lower risk of getting sick with Covid than those employees who were "up-to-date". According to the study's authors, "The current CDC definition provides a meaningless classification of risk of Covid-19 in the adult population".



The "not up-to-date" employees Hazard ratio was 0.77- that means they were 23% less likely to get infected compared to those "up-to date" employees. This difference is recognized as statistically significant and cannot be ignored. Also recall that government's worldwide promoted the so-called as supposed to greatly protect those who got it and greatly reduce their chances of being

infected and dying of it.

To reiterate, the purpose of this study was to evaluate whether individuals who were not "up to date" on the Covid-19 vaccines had a higher risk of Covid-19 than those who were "up-to-date". The conclusion was that

> there was 23% less risk of catching Covid-19 for those employees not totally vaccinated (according to the CDC definition).

> This study is interesting for another important reason. It seems to represent the first time "mainstream" researchers are directly and pointedly questioning the CDC's logic and decision making process.

> Some key quotes/takeaways from the researcher's summary are worth reprinting here:

> "Given the lack of efficacy of the bivalent vaccine against the XBB variants, which are the predominant circulating strains at this time, it is reasonable to question whether individuals being "up-to-date" with a vaccine of questionable effectiveness are in fact protected against C19 as compared to those up to date"

who are not "up-to-date."

"The study's findings question the wisdom of promoting the idea that every person needs to be up-to-date on C19 vaccination, as currently defined at this time. It is often stated that the primary purpose of covid vaccination is to prevent serious covid19 and death... it should be pointed out that there is not a single study that has shown that C19 bivalent vaccine protects against severe disease of death caused by the Omicron variant. At least one prior study has failed to find a protective effect of the bivalent vaccine against SARS Cov2. People may still choose to get the vaccine, but an assumption that the vaccine protects against severe disease and death is not reason enough to unconditionally push a vaccine of questionable effectiveness in all adults."

"This study found that not being up-to-date on C19 vaccination by the CDC definition was associated with a lower risk of C19 than being up-to-date. This study also demonstrates the folly of risk calculation based solely on receipt of a vaccine of questionable effectiveness while ignoring protection provided by prior infection".

In these days of open censorship, it will be interesting to see whether that open admonishment aimed at the CDC, to maintain the long-held scientific truth that acquired immunity derives from prior infection, makes it through the "review" process.

If it does, could it mean the façade is beginning to truly crumble?



Health Canada is Strangling Natural Health Products in Red Tape



In Canada, Natural Health Products (NHPs) are regulated by the Natural and Non-Prescription Health Products Directorate (NNHPD) under the *Natural Health Products Regulations* (NHPR). These regulations came into effect in 2004. The regulations were developed following extensive consultations, they reflected the desire of Canadians for a regulatory framework appropriate to the level of risk associated with NHPs. Almost 20 years later, Canada is still the only country that has a dedicated set of regulations governing NHPs.

All NHPs must be approved by Health Canada before they are legally allowed to be sold in Canada. Always look for a Natural Product Number (NPN) or Homeopathic Medicine Number (DIN-HM) on the product label. Canadians should feel confident that the products they use are safe, effective, and high-quality.

On July 6, 2022, Health Canada published new labelling requirements under the Natural Health Products Regulations (NHPR) that are set to come into practice in 2025. The intention is to ensure label information is presented in a legible and comprehensive manner - this is to reduce confusion, medical errors, product interactions and to allow consumers to locate information about safe use. All current NHP labelling requirements continue to apply, specifically what is required on the principal display panel (PDP) of a label. Unfortunately, Government did not consider industry feedback on these changes, conduct user testing or consult labelling sciences to ensure the changes would indeed result in a clearer, more consumer-friendly label. What they did create was a very technical and inflexible guidance document that is difficult for brands to comply with.



atively impact profit margins, cause packaging sizes to double, and beyond current supply chain challenges, further limit product availability while hurting competition, innovation, and new product offerings.

Cost Recovery is the process of collecting user fees for services (like the cost for renewing your drivers license or passport). For NHPs cost recovery is proposed to include fees for regulatory activities such as product evaluation, site licenses and annual renewal fees.

With the establishment of the Natural Health Product Regulations in 2004, NHPs have not been subject to cost recovery. We understand cost recovery is a necessary part of doing business in Canada however, any cost recovery efforts should be phased over multiple years and be based on accurate data reflecting the current NHP sector which is mostly comprised of small/mid-sized companies and include measurable service standards.

Currently, the foundation of our regulatory system is

We launched an Economic Impact Study to find out how this would impact our industry – we found:

76% of brands say there is a high/very high chance they will need to pull product from the market as a result of these regulations.

1 in 5 companies say they are seriously considering leaving the Canadian market. Exciting new products and international brands will likely not come to Canada because the regulatory burden will be too severe.

66% of companies said it would have a negative impact on employment.

We put the new requirements into practice to see how these changes will impact labels. The new requirements do not present the information in a more legible and comprehensive manner as they were intended to – but actually create a more confusing label that will negstretched to the brink with massive backlogs in product applications. In short, data used to establish this current program is dramatically flawed and the proposed fees will financially decimate the NHP industry in Canada.

The timing of implementing this program at the same time as new labelling requirements will financially decimate many companies in our industry, making it extremely challenging for them to stay viable. These regulatory changes are unfair, unrealistic, and so costly they will force many small to medium-sized businesses to shut down Canadian operations.



- Federal government moves to delay MAID for people suffering solely from mental illness.
- A Texas-based federal judge has mandated that the FDA must disclose all data pertaining to the COVID-19 vaccines from Pfizer for the 12-15 age group, as well as Moderna for adults. Climate Change or Climate Terrorism?

ormally at this hour I'd be at the gym. This morning, however, I woke up to the smell of wood smoke a sky that looks like this: (see barsoom.substack.com/p/canada-burning)

The air quality is noticeably terrible, and it doesn't much feel like a great time for devotions in the iron temple.

There are currently over 100 fires raging throughout Quebec and, now, Ontario. The number goes up every time I go to check Google, last I saw was around 160. The closest is just over 100 km

from here.

Wildfires on this scale, at this point in the year, are in my experience unprecedented. Ten of thousands of people in outlying communities have already been evacuated. So far about 3.5 million hectares have burned.

As you can see, not only are we on track for the worst wildfire season on record, the temporal pattern is completely out of step with what we normally see. In every other year, wildfire season is mid-August, mid-July at the earliest. The beginning of June is unheard of.

The usual suspects are blaming this on, of course, the climate emergency crisis catastrophe. Carbon dioxide concentrations have finally gotten out of hand, the tipping point has been reached, and Canada is burning as a result.

Cue Greta, waving her hands in the air like the Ron Paul meme — It's HAPPENING! You should have eaten the bugs, damn you. A cricket a day keeps the wrath of Earth Mammy at bay.

Only, that would be quite the remarkably rapid transition. As you can see in the graph, last year was a quiet year for wildfires. The year before was high, but followed the expected seasonal pattern. The year before that there were almost no wildfires to speak of. I don't see much of a pattern there, personally.

Granted, not every system in nature evolves smoothly and monotonically. Many systems undergo abrupt phase transitions.


Still, if that were the case, you'd expect the last month or so to have been both unseasonably warm and dry compared to historical averages. Certainly where I am, nothing has felt particularly out of the ordinary – we had a warm week or so at the end of May, and while it hasn't rained much in the last two weeks it rained plenty before that. That said, it was something of a dry winter, and a bad wildfire season was expected out in the Rockies due to the lack of precipitation.

reporting arrests or active investigations of suspicious activity. The Alberta government has assigned just under half of the wildfires to human activity, with the rest under investigation.

Wildfire arson isn't exactly unknown. I've seen reports in previous years of people setting fires in order to get jobs fighting the fires. And of course, not every human-initiated wildfire is deliberate. Accidents from unattended campfires or cigarette butts that weren't quite extinguished are hardly uncommon. But accidental wildfires seem unlikely to yield coordinated fires across such a wide geographical area, and

Would an eco-terrorist group really be capable of that level of coordination, though? We're talking a minimum of a hundred people going to remote areas and setting fires all at once. Certainly there are well more than a hundred carbon cultists in the world, but there's a big difference between the levels of emotional buy-in that result in 'I should not eat meat' and 'burn 3 million hectares of forest'. There's also the competence question. As a rule, fanaticism and professionalism are inversely correlated. Not always, but the combination of ability and zealotry is fairly rare.

State actors tend to be much more capable of



rednecks looking to get summer jobs with the local little boost? Remind people of how dire the situation fire brigade also don't seem like the kind of bad actors that would possess this level of coordination.

That leaves, as far as I can make out, three broad categories of perpetrators: a foreign state actor; the Canadian government itself; or non-state actors.

A foreign state might be motivated by the intention to cause economic damage, but I find this somewhat unlikely. It doesn't really seem like Russia's or China's style. Damaging Canada's softwood lumber trade isn't

It really is an amazing coincidence that all of those fires would start at more or less the same time. Perhaps if there had been an epic lightning storm blanketing the area, which there wasn't. Or maybe a particularly large shower of meteors, although a cosmic impactor swarm large enough to set fire to the country would presumably have been

seen by a lot of people, and there are only 2 reports for 2023 from the whole of Canada, with the most recent being out in Alberta.

The only other way I can imagine that you'd have that many fires starting with such perfect synchronization is via coordinated human activity. If you go on social media, the other narrative vying for supremacy with the climate crisis shrieking is that this is mostly deliberate arson. Yes, that's a crazy conspiracy theory. It's one that at least some police share, however, with local news in British Columbia, Alberta and Nova Scotia



How Much Energy Will the World Need?

energy future. Wind and solar will power the world of tomorrow. And tomorrow isn't far off! It's time to wake up. You're having a dream. Here's the reality.

Oil, natural gas, and coal provide 84% of all the world's energy. That's down just two percentage points

from twenty years ago. And oil still powers nearly 97% of all global transportation.

Contrary to headlines claiming that we're rapidly transitioning away from fossil fuels, it's just not happening. Two decades and five trillion dollars of governments "investing" in green energy and we've barely moved the needle.

This was supposed to be easy. Why is it so hard?


In a word: rocks. To get the same amount of energy from solar and wind that we now get from fossil fuels, we're going to have to massively increase mining. By more than 1000%. This isn't speculation. This is physics. Copper, iron ore, silicon, nickel, chromium, zinc, cobalt, lithium, graphite, and rare earth metals like neodymium. We need them all. And then those metals and materials have to be turned into motors, turbine blades, solar panels, batteries, and hundreds

of other industrial components. That also takes lots of energy, which requires even more mining.

As a World Bank study put it, these green "technologies are in fact significantly more material intensive" than our current energy mix. That may be the understatement of the century: raw materials account for 50-70% of the costs to manufacture both solar panels and batteries. Until now it hasn't really mattered that much because wind and solar still account for only a few percentage points of the global energy supply. They're an applause line for environmentalists—not a major energy player. And it's unlikely they will be in the foreseeable future.

But for the sake of argument, let's say we sharply ramp up mining. Where would these new mines be located? Well, for one, China. That country is today the single largest source for most of our critical energy materials. The United States is not only a minor player but is dependent on imports for 100% of 17 critical minerals. Do we want to give China more political and economic leverage? Europe has made itself dependent on Russia for 40% of its natural gas. How well has that worked out?

Ironically, we have all the minerals we need right here in North America. But good luck trying to get





them out of the ground. Proposals to build mines in the United States and, increasingly almost everywhere else, meet fierce opposition if not outright bans. To give just one example, in 2022 the Biden Administration canceled a proposed copper and nickel mine in northern Minnesota. This was after years of delays, navigating a maze of environmental regulations.

Yes, the same environmentalists and green-leaning politicians who tout all the benefits of electric cars are the same people who make mining the materials essential to build those cars—like copper and nickel—all but impossible.

Try to square that circle!

So far, we've only talked about today's energy needs. What about tomorrow's? Future energy demand will be far greater than today's. That's been true for the entire

for every 100 citizens. In most of the world, it's about five per hundred citizens. Over 80% of air travel is for personal purposes. That's two billion barrels of oil a year. Hospitals use 250% more energy per square foot than an average commercial building. And the global information infrastructure-the Cloud- already uses twice as much electricity as the entire country of Japan, the world's thirdlargest economy. The massive data centers at the heart of the Cloud alone consume almost 10 times more electricity than the world's 10 million electric cars. E-commerce has taken off and is propelling record growth in warehouses, increasingly filled with energy-hungry robots. America's truck freight index more than doubled in the past decade to deliver the goods to and from those warehouses.

These are today's known trends. While we can't predict the future, we

can predict there'll be more innovation—in robotics, drones, quantum computing, biotechnology. And new industries not yet imagined. All of it will require more energy—a lot more. Fossil fuels, nuclear energy, and yes, renewables will be required.

But if you think we can get it all from wind and solar, dream on.



years. This pattern is substantially changing from April 2021 onward at the time when more and more people were vaccinated."

The authors also noted concerns about a lack of oversight by the country's safety regulators: "Given the temporal relationship between the increase in vaccinations and excess mortality, it seems surprising that a respective safety signal has not been detected in the pharmacovigilance by the Paul-Ehrlich-Institut (PEI), which is responsible for the safety monitoring of drugs in Germany. A closer inspection of the methods used by the PEI to monitor possibly deadly side effects of the COVID-19 vaccinations reveals that a flawed safety analysis is used that will not indicate a safety signal even if a vaccine causes extremely large numbers of unexpected deaths." "As is visible in Figure 8, the obvious hypothesis of a decrease in excess mortality with an increasing number of vaccinated persons is not correct. During periods when many persons were vaccinated, excess mortality seems to have increased more strongly compared to the same periods in the previous pandemic year... ... it seems also very unlikely that the abrupt increase in mortality in spring 2021 is due to delayed or avoided clinical services, which should lead to much smoother changes or due to side effects of COVID-19 measures. This is more unlikely in the year 2022 when excess mortality increases even further despite a decrease in reported COVID-19 deaths and although clinical care should slowly return to normal."



The authors also noted: ".. during the months with a high number of the first, second, and third vaccinations, also a high number of excess deaths was observed. The temporal relationship between the courses of vaccinations and excess deaths is especially pronounced for the third vaccination."

A similar mortality pattern was observed for stillbirths, with an increase of 19.4% in the fourth quarter of the year 2021 compared to previous years.

The study concludes: "Taken together, one would expect that vaccinating large parts of the population should have reduced excess mortality. The contrary is observed: both excess mortality and the number of stillbirths increased with increased vaccinations."

Lewis, who suffers from what the courts have described as an "idiopathic condition" which is progressive and debilitating, was part of a program which made it mandatory that patients receive the vaccine prior to transplantation. Lewis tried to restore her place on the list and sought a declaration that the vaccine requirement violated her Charter right to freedom of conscience, the right to life, liberty and security of the person and the right to equality, arguments which were rejected by the Alberta Court of King's Bench (Lewis v. Alberta Health Services, 2022 ABQB 479) and the Alberta Court of Appeal (Lewis v. Alberta Health Services, 2022 ABCA 359). Both courts found the Charter does not apply to doctors' exercise of clinical judgments.

The 1985 Siracusa Principles were never part of our legal education system. These principles were meant to protect the rights of citizens from government overreach.6 They could positively change the outcome of our human rights cases, and the last three years could have been drastically different from an economic, health and labor perspective. Moreover, all politicians and legislative officials should be required to know the basics of international law binding within our Constitution before creating laws; precisely, in reference to international instruments binding on Canada.7

International Instrument, creating the International Criminal Court (ICC) in 1998 (to which the U.S.A. refused to participate9). It is ironic that Canadians have paid part of the ICC's legal establishment, yet in Canada, the peoples' rights have been and are still being abused by our governing bodies.10 11

We are in the midst of an epic social, cultural and political crisis that affects almost every developed country. We must look forward to the day when the col-

lective people, as Head of State above the government, will be able to ensure and maintain peace, order and good governance once and for all! We would take pride in how we replaced a corrupt political and legal system by revamping democracy to suit the needs of the people rather than the greed of corporate and political interests. countries, guaranteed us all these rights within the international instruments signed by them.

The WHO Treaty Is Tied to a Global Digital Passport and ID System

he WHO recently announced plans for an international pandemic treaty tied to a digital passport and digital ID system. Meeting in December 2021 in a special session for only the second time since the WHO's founding in 1948, the Health Assembly of the WHO adopted a single decision titled, "The World Together."

The WHO plans to finalize the treaty by 2024. It will aim to shift governing authority now reserved to sovereign states to the WHO during a pandemic by

legally binding member states to the WHO's revised International Health Regulations.

In January of 2022 the United States submitted proposed amendments to the 2005 International Health Regulations, which bind all 194 UN member states, which the WHO director general accepted and forwarded to other member states. In contrast to amendments to our own constitution, these amendments will not require a two-thirds vote of our Senate, but a simple majority of the member states.

Most of the public is wholly unaware of these changes, which will impact the national sovereignty of member states.

The proposed amendments include, among others, the following. Among the changes the WHO will no longer need to consult with

the state or attempt to obtain verification from the state where a reported event of concern (e.g., a new outbreak) is allegedly occurring before taking action on the basis of such reports (Article 9.1).

In addition to the authority to make the determination of a public health emergency of international concern under Article 12, the WHO will be granted additional powers to determine a public health emergency of regional concern, as well as a category referred to as an intermediate health alert.

The relevant state no longer needs to agree with the WHO Director General's determination that an event constitutes a public health emergency of international concern. A new Emergency Committee will be constituted at the WHO, which the Director-General will consult in lieu of the state within whose territory the public health emergency of international concern has occurred, to declare the emergency over.

The amendments will also give "regional directors" within the WHO, rather than elected representatives of the relevant states, the legal authority to declare a Public Health Emergency of Regional Concern.

port of the U.S., appears to be responding to roadblocks that China erected in the early days of covid. This is a legitimate concern. But the net effect of the proposed amendments is a shift of power away from sovereign states, ours included, to unelected bureaucrats at the WHO. The thrust of every one of the changes is toward increased powers and centralized powers delegated to the WHO and away from member states.

Leslyn Lewis, a member of the Canadian parliament and lawyer with international experience, has warned that the treaty would also allow the WHO unilaterally to determine what constitutes a pandemic and declare when a pandemic is occurring. "We would end up with

a one-size-fits-all approach for the entire world," she cautioned. Under the proposed WHO plan, pandemics need not be limited to infectious diseases and could include, for example, a declared obesity crisis.

As part of this plan, the WHO has contracted German-based Deutsche Telekom subsidiary T-Systems to develop a global vaccine passport system, with plans to link every person on the planet to a QR code digital ID. "Vaccination certificates that are tamper-proof and digitally verifiable build trust. WHO is therefore supporting member states in building national and regional trust networks and verification technology," explained Garret Mehl, head of the WHO's Department of Digital Health

Over 500 Excess Heart Deaths A Week In England Since COVID-19 Began

ore than 500 additional deaths a week involving heart diseases have been recorded in England since the COVID-19 pandemic began, the British Heart Foundation (BHF) has said.

Based on data from the Office for Health Improvement and Disparities, the BHF revealed in a report that, since February 2020, there has been a total of 96,540 excess deaths involving cardiovascular conditions-an umbrella term for a range of heart and blood vessel conditions, including heart attacks and strokes.

Average ambulance response times for heart attacks and strokes have consistently been more than 30 minutes since the beginning of 2022.

There has also been significant disruption to the detection and management of high blood pressure and other conditions that put people at much greater risk of a heart attack or stroke, the charity said.

Babu-Narayan said: "Long waits for heart care are dangerous-they put someone at increased risk of avoidable hospital admission, disability due to heart failure, and premature death. Yet people are struggling to get potentially life-saving heart treatment when they need it due to a lack of NHS staff and space, despite cardiovascular disease affecting record numbers of people."

But the BHF said, "The benefits of receiving COVID-19 vaccines in reducing severe outcomes from COVID-19 infection in people living with cardiovascular disease greatly outweigh the risk of extremely rare side effects." 'Not Surprising'

Professor John Greenwood, president of the British Cardiovascular Society, said: "The high numbers of excess cardiovascular disease (CVD) deaths published today are worrying, but unfortunately not surprising. We know that COVID-19 has caused direct (COVID-19 leading to new CVD), indirect (reduced treatment and prevention of CVD), and long-term effects (CVD and Long COVID-19)."

It is deeply troubling that so many more people with cardiovascular disease have lost their lives over the past three years," BHF Chief Executive Dr. Charmaine Griffiths said.

In the first year of the pandemic, COVID-19 infection drove high numbers of excess deaths involving cardiovascular disease.

While deaths from COVID-19 have since fallen yearon-year, the number of deaths involving cardiovascular disease have remained high above expected levels, the BHF analysis stated.

Dr. Sonya Babu-Narayan, associate medical director at the BHF and consultant cardiologist, said, "COVID-19 no longer fully explains the significant numbers of excess deaths involving cardiovascular disease."

She said there may have been other contributing factors, including the disruptions to the NHS over the past few years.

NHS Disruption

The charity said a major contributing factor has been the "severe, ongoing disruption" to heart care in the NHS.

The number of people waiting for time-sensitive cardiac care was at a record high of nearly 390,000 at the end of April in England, according to NHS England.

Vaccine Link

The BHF also said that COVID-19 may potentially have caused a rise in heart problems. It cited a separate study showing that those who were infected before the vaccine rollout were five times more likely to die in the 18 months after infection.

Some studies have linked myocardial inflammation to the mRNA vaccines, but the BHF played down the risks posed by vaccines.

"COVID-19 vaccine associated myocarditis has been rare, more common in young men after a second vaccine dose, and fortunately shows a favourable clinical course in the vast majority of those affected.

"Myocarditis can cause heart scarring that can be detected with cardiac MRI-to mitigate the small chance of scarring causing a life-threatening arrhythmia in the future, it is likely that affected individuals will be offered long-term follow-up and monitoring," it stated.

Between December 2020 and February 2023, the Medicines and Healthcare Products Regulatory Agency recorded 72 UK deaths suspected to be related to the COVID-19 vaccine.

Griffiths urged the government to "take control of this crisis" by "prioritising NHS heart care, better preventing heart disease and stroke, and powering science to unlock future treatments and cures."

A government spokesperson said: "We are cutting waiting lists, ambulance response times are falling, staff increasing and we are improving access to blood pressure and health checks.

"We know there is more to do which is why we are consulting on a Major Conditions Strategy to tackle cardiovascular disease-including strokes and diabetesand we have opened 108 community diagnostic centres that have delivered over 4 million tests, scans, and checks including for those with cardiovascular disease.

"The government is also working with NHS England to combat some of the causes of cardiovascular disease, with schemes to support increased physical activity, reduce obesity rates, and encourage people to stop smoking."

Drugs and Propaganda

ccording to Aldous Huxley, the tyrant of the future will use drugs and propaganda to convince the individual to "love his slavery". Huxley explained as follows: "If you want to preserve your




In their own party platform, the Liberals have stated they intend to "put a stop to harmful online content" and "tackle extreme and harmful speech". Western Standard reports that Minister Rodriguez "remains determined to suppress speech the prime minister described as 'destabilizing for democracy'" - a startling comment. It turns on its head the US Supreme Court statement that, "government may not prohibit the expression of an idea simply because society finds the idea itself offensive or disagreeable."

These Liberal censorship promises have been put into action. In 2022 the Twitter Files disclosed over 200 episodes where the Liberal government asked social media companies to delete data, at times complaining the material was "offensive". More substantially, in 2023, the Liberal government rolled out censorship powers in the Online Streaming Act and the Online News Act. And more is coming. Before year end, Canadians can expect to see the Online Harms Act together with its ominous Digital Safety Commissioner. Friends of the Liberals though, have little to fear because the Liberals are in favour of speech they like. But real freedom of expression in Canada is in jeopardy. So much so that Elon Musk recently advocated for "a new government in Canada" that would respect free speech rights. Musk believes in a marketplace of ideas - or as George Orwell explained, "If liberty means anything at all, it means the

right to tell people what they do not want to hear."

Meanwhile, as if to follow Huxley's prediction, Canada's Liberal government has also become a world leader in legalizing and distributing illicit drugs. Indeed the Liberal government will not condemn drugs and states it will invest millions in "public education to





Examiner says the Liberal drug policies are "controlled by a clique of ideologically driven researchers who simply do not believe that rehabilitation is possible" and who "push for hyper-libertarian policies that minimize exposure to recovery-based treatments". Canadians are now observing an avalanche of drugs - all sponsored by

a Liberal government that claims more and better drugs will cure addiction, and that enabling addicts is a form of healing them. Drastic things are happening in Canada.

But this Liberal drug policy fits hand in glove with the Liberal censorship policy. Two dystopian novels predicted that drugs, like censorship, would be used to stifle opposition. In Brave New World the drug "soma" is distributed to create conformity and "stability". And in Lois Lowry's novel The Giver, drugs are handed out to prevent dissension or "stirrings". The novels present a depraved but simple message: a fried society is a compliant society. Or in the Canadian context: drug addicts don't organize freedom convoys.

Very recently, drugs and censorship have washed over Canadians like a fast-water tide. In their own way, each of these weapons attempt to make Canadians more compliant and less resistant. But in truth they are attacks on bedrock principles. These are turbulent times and Canadians are searching for answers.


Keep speaking. Keep shouting. Keep raising the sound of deliverance. Keep spreading truth by all means. Keep showing humanity what is going on.

Some Of The Most Absurd Things That Have Happened In Recent Weeks

- Delta Air, who claimed to be "the world's first carbon-neutral airline," is facing a lawsuit after an investigation finds their claims to be "false and misleading." The investigation into the "carbon credit" scheme the airline used found that "nearly all offsets issued by the voluntary carbon offset market overpromise and underdeliver on their total carbon impact."
- Health officials delayed a key report linking fluoride to brain harm. After a 6-year systematic review of fluoride's impact on the developing brain, a court order has led to *The National Toxicology Program* making public their finalized report that was blocked by the US Department of *Health and Human Services* leadership and concealed from the public for nearly a year. The NTP reported that 52 of 55 studies found decreases in children's IQ associated with an increase in fluoride.
- A study published in Cureus titled "Estimation of Excess Mortality in Germany During 2020-2022 (Kuhbandner et al.) finds a strong correlation between the increase in mortality rates within the country and the introduction of COVID-19 vaccines. As the authors noted, "The results show that the observed number of deaths in 2020 was close to the expected number with respect to the empirical standard deviation... By contrast, in 2021, the observed number of deaths was two empirical standard deviations above the expected number and even more than four times the empirical standard deviation in 2022." Additionally, the authors noted that excess mortality shot up in groups below 30-years-old (where typically no excess mortality occurs) from April 2021 onward. A similar mortality pattern was observed for stillbirths, with an increase of 19.4% in the fourth quarter of the year 2021 compared to previous years.
- The WHO has announced its plans for an international pandemic treaty tied to a digital passport and digital ID system. The plan, slated to be finalized by 2024, aims to shift governing authority from sovereign states to the WHO during a pandemic by legally binding member states to their revised *International Health Regulations*. German-based Deutsche Telekom subsidiary *T-Systems* has been contracted to develop a global vaccine passport system that links every person on the planet to a QR code digital ID so compliant subjects can *"move around as safely as possible"* during present and future health threats.
- Canada Bread (McCain) has admitted to colluding with rival Weston Foods (Loblaws) to set Canadian bread prices, ending a seven-year investigation into one of the largest price-fixing scandals in the country's history.
- Washington State issues a bill to become a "sanctuary state" for child sex changes. Senate *Bill 5599* would allow host homes to provide housing for runaway transgender minors without being required to notify their parents in some instances. The bill would also allow transgender minors to seek "gender-affirming" health care.

- Planned Parenthood is suspended by the Saskatchewan government from giving school presentations after "Sex from A-Z" cards describing graphic sexual acts were presented in a grade 9 class in Lumsden. The set of cards is "intended for gay, bi, and queer young people" to help discuss topics in a "sex-positive, identity-affirming context." (Note: The content of these cards is far too vile to even give examples here, they are certainly not child-friendly.)
- One year after Canada made it illegal to "condone,

deny or downplay the Holocaust," an interim report by the **federal government reveals plans to also make questioning the narrative of unmarked mass graves near residential schools illegal** by categorizing these thoughts as "hate speech."

- An article recently published to *Case Rep Ophthalmol* titled "*Ocular Surface Erosion after Suspected Exposure to Evaporated COVID-19 Vaccine*" (*Chantra et al.*) describes a disturbing incident that occurred during a vaccination campaign where **a nurse accidentally broke a vial of vaccine: 15 out of the 20 people in the room were diagnosed with "ocular surface erosion"** after experiencing symptoms such as red eyes and a rash within hours of exposure.
- A FOIA request by *Blacklock's Reporter* revealed that, as early as 2021, the **Privy Council Office sought to downplay vaccine injuries and other adverse events** to "maximize public confidence in the safety of the COVID vaccine." In the memo, titled "Testing behaviourally informed messaging in response to severe adverse events following immunization" the memo suggested skewing statistics to minimize the impact of vaccine deaths or injuries. The memo further noted, "different framings of the exact same risk can drastically affect a person's decision and percep-

tion of risk."

- After MPs passed a motion requiring the Liberal government to let them see the COVID-19 vaccine contracts the federal government made with big pharma, the **cabinet is now demanding MPs sign an NDA if they wish to see the terms of the COVID-19 vaccine contracts** so that the public never learns the truth.
- A terminally-ill woman in Alberta, who had been denied a place on an organ transplant list because she is not vaccinated against COVID-19, has now
 - had her case dismissed by the Supreme Court of Canada. The Alberta Court of Queen's Bench and the Alberta Court of Appeal also ruled against her, stating that the Charter and Bill of Rights do not cover the specific Covid-19 vaccine policies. Having exhausted all her legal options in Canada, Sheila Annette Lewis has now started a fundraiser to obtain surgery in the US.

• Dr. Patrick Philips, an Ontario-based physician, has just been issued a fine of \$6,000 and had his medical license revoked by the CPSO over his vocal opposition to Covid-related public health measures.

• Despite a nursing shortage, a London Health Sciences Centre nurse is facing termination for refusing to get a COVID-19 vaccine. The nurse, Sandra Hartman, was on maternity leave in 2021 and recently returned to work only to be put on unpaid leave for declining to be vaccinated against the coronavirus.

• Sources within the US government reveal that the earliest three people believed to have been infected with SARS-CoV-2 in the fall of 2019 were all members of the Wuhan lab who worked closely on coronavirus research: Ben Hu, Yu Ping, and Yan Zhu. As reported by *Public and Racket*, all three were working with the closest relatives of SAPS CoV 2 inserting gain of function

atives of SARS-CoV-2, inserting gain-of-function features unique to it, and all three were co-authors on the journal article published pre-COVID titled "Discovery of a rich gene pool of bat coronaviruses provides new insights into the origin of SARS coronavirus" (Hu et al.) The lead author, Hu, also co-authored a 2017 paper on chimeric bat coronaviruses with Peter Daszak, the head of EcoHealth Alliance, which was funded in part by the NIH.

A study by the Cleveland Clinic published in OFID titled "Effectiveness of the Coronavirus Disease 2019 Bivalent Vaccine" (Shrestha et al.) finds that, while the vaccine appeared to work in the first few weeks, after that the vaccine had negative efficacy. As the authors of the study put it, the "risk of COVID-19 increased with time since most recent prior COVID-19 episode and with the number of vaccine doses previously received." Another study published in April of this year to Vaccines (Uversky et al.) may help explain why. The study concludes, "Ig4 levels detected after repeated vaccination with the mRNA vaccines may not be a protective mechanism; rather, it constitutes an immune tolerance mechanism to the spike protein that could promote unopposed SARS-CoV2 infection and replication by suppressing natural antiviral responses."
