## The Biggest Untold Story in Canada

# 1984 is Here, 40 Years Later

## The Elite War on Free Thought Address at Free Speech Event in London, with Russell Brand and Michael Shellenberger

A funny thing happened last night, at a remarkable event in London in celebration of free speech with Russell Brand and Michael Shellenberger. Before the proceedings Michael suggested we give prepared remarks. I wrote a speech, tinkering with it at night on the plane over, then all day after landing. At the event Michael stood before the large crowd and extemporaneously delivered a rousing address. I slid what I wrote under a chair. Though I did end up mumbling a few things from memory, this is the whole speech, as written:

It's heartening to see so many faces here in London, to talk about the crisis of free speech around the globe, or to protest censorship, or whatever it is we're doing exactly. Before we begin, I think it's important to make a distinction. Unlike Russell and the rest of our hosts, Michael and I, and a few of us in the crowd, are Americans. For us, belief in unfettered free speech is a core part of our character. It's a big reason that we Americans enjoy the wonderful reputation we do all around the world, especially here in Europe, where (I'm sorry to tell you) we hear you whispering to the restaurant hostess that you'd like to be seated at the table as far away from us as possible.

That was meant to be a laugh line, but in some ways, that's what the First Amendment of the U.S. Constitution comes down to: the right to be an asshole. We have a prettier way of saying it — a right to petition for a redress of grievances — but it's the same basic idea.

Isn't that a beautiful phrase, a redress of grievances? Great, memorable language. Like a lot of Americans, I know the First Amendment by heart. I've recited it to myself enough to know it doesn't say the government gives me the right to speech, assembly, a free press. It says I have those things, already. As a person, as a citizen.

This is a very American thing, the idea that rights aren't conferred, but a part of us, like our livers, and you can't take them away without destroying who we are. That's why in other contexts you'll hear some of us say things like, "I'll give you this gun when you pry it from my cold dead hands!"

Some people roll their eyes and think that sounds crazy, but we know that guy actually means it, and to a lot of us it makes sense. We're touchy about rights, especially about the first ones: speech, assembly, religion, the free press.

But we're not here tonight to debate the virtues of American speech law versus the European tradition. Instead, Michael and I are here to tell a horror story that concerns people from all countries. Last year, he and I were offered a unique opportunity to look at the internal documentation of Twitter.

I entered that story lugging old-fashioned, legalistic, American views about rights, hoping to answer maybe one or two questions. Had the FBI, for instance, ever told the company what to do in a key speech episode? If so, that would be a First Amendment violation. Big stuff!

But after looking at thousands of emails and Slack chats, I first started to get a headache, then became confused. I realized the old-school Enlightenment-era protections I grew up revering were designed to counter authoritarianism as people understood the concept hundreds of years ago, back in the days of tri-cornered hats and streets lined with horse manure.

What Michael and I were looking at was something new, an Internet-age approach to political control that uses brute digital force to alter reality itself. We certainly saw plenty of examples of censorship and de-platforming and government collaboration in those efforts. However, it's clear that the idea behind the sweeping system of digital surveillance combined with thousands or even millions of subtle rewards and punishments built into the online experience, is to condition people to censor themselves.

In fact, after enough time online, users will lose both the knowledge and the vocabulary they would need to even have politically dangerous thoughts. What Michael calls the Censorship-Industrial Complex is really just the institutionalization of orthodoxy, a vast, organized effort to narrow our intellectual horizons.

It's appropriate that we're here in London speaking about this, because this is the territory of George Orwell,

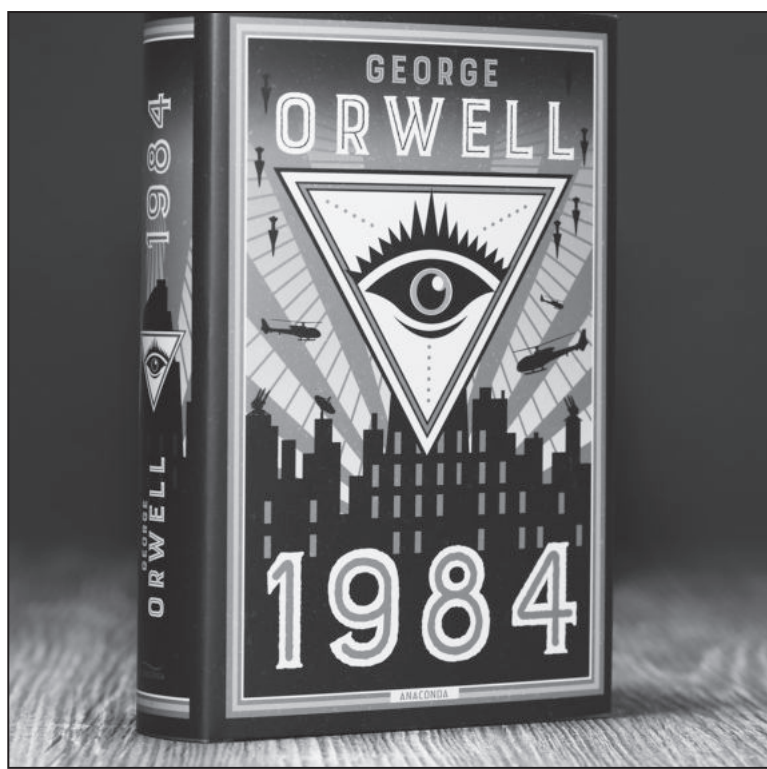
who predicted a lot of what we saw in the Twitter Files with depressing accuracy.

One example stands out.

One of the big themes of *1984* was the reduction of everything to simple binaries. He described a world where "all ambiguities and shades of meaning had been purged," where it wasn't really necessary to have words for both "warm" and "cold," since as he put it, "every word in the language — could be negated by adding the affix un-."

Let's not bother with cold, let's just have unwarm.

A political movement has long been afoot in America and other places to reduce every political question to simple binaries. As Russell knows, current political thought doesn't like the idea that there can be left-neoliberalism over here, and right-Trumpism over here, and then also all sorts of people who are neither — in



between, on the peripheries, wherever.

They prefer to look at it as, "Over here are people who are conscientious and believe in science and fairness and democracy and puppies, and then everyone else is a right-winger." This is how you get people with straight faces calling Russell Brand a right-winger.

But it goes deeper. Michael and I found correspondence in Twitter about something called the Virality Project, which was a cross-platform, information-sharing program led by Stanford University through which companies like Google, Twitter, and Facebook shared information about Covid-19.

They compared notes on how to censor or deamplify certain content. The ostensible mission made sense, at least on the surface: it was to combat "misinformation" about the pandemic, and to encourage people to get vaccinated. When we read the communications to and from Stanford, we found shocking passages.

One suggested to Twitter that it should consider as "standard misinformation on your platform... stories of true vaccine side effects... true posts which could fuel hesitancy" as well as "worrisome jokes" or posts about things like "natural immunity" or "vaccinated individuals contracting Covid-19 anyway."

This is straight out of Orwell. Instead of having "ambiguities" and "shades of meaning" on Covid-19, they reduced everything to a binary: vax and anti-vax.

They eliminated ambiguities by looking into the minds of users. In the Virality Project

if a person told a true story about someone developing myocarditis after getting vaccinated, even if that person was just telling a story — even if they weren't saying, "The shot caused the myocarditis" — the Virality Project just saw a post that may "promote hesitancy."

So, this content was true, but politically categorized as anti-vax, and therefore misinformation — untrue.

A person who talks about being against vaccine passports may express support for the vaccine elsewhere, but the Virality Project believed "concerns" about vaccine passports were driving "a larger anti-vaccination narrative," so in this way, a pro-vaccine person may be anti-vax. They also wrote that such "concerns" inspired

broader discussions "about the loss of rights and freedoms," also problematic.

Other agencies talked about posts that shared results of Freedom of Information searches on "authoritative health sources" like Dr. Anthony Fauci, or used puns like "Fauxi." The VP frowned on this.

"This continual process of seeding doubt and uncertainty in authoritative voices," wrote Graphika, in a report sent to Twitter, "leads to a society that finds it too challenging to identify what's true or false."

It was the same with someone who shared true research about the efficacy of natural immunity or suggested that the virus came from a lab. It all might be factual, but it was politically inconvenient, something they called "malinformation." In the end, out of all of these possible beliefs, they derived a 1984 binary: good and ungood.

They also applied the binary to people.

This was new. Old-school speech law punished speech, not the speaker. As a reporter I was trained that if I commit libel, if I wrote something defamatory that caused provable injury to someone, I would have to retract the error, admit it, apologize, and pay remuneration. All fair! But the court case wouldn't target me as a person. It wouldn't assume that because I was wrong about X, I would also be wrong about Y, and Z.

We saw NGOs and agencies like the FBI or the State Department increasingly targeting speakers, not speech. The Virality Project brought up the cases of people like Robert F. Kennedy, Jr. The posts of such "repeat offenders," they said, are "almost always reportable." They encouraged content moderators to make assumptions about people, and not to look on a case-by-case basis. In other words, they saw good and ungood people, and the ungood were "almost always reportable."

Over and over we saw algorithms trying to electronically score a person's good-or-ungoodness. We found a Twitter report that put both Wikileaks and Green Party candidate Jill Stein in a Twitter "denylist," a blacklist that makes it harder for people to see or search for your posts. Stein was put on a denylist called is\_Russian because an algorithm determined she had too many beliefs that coincided with banned people, especially Russian banned people.

We saw the same thing in reports from the State Department's Global Engagement

Center. They would identify certain accounts they claimed were Russian operatives, and then identify others as "highly connective" or "Russia-linked," part of Russia's "information ecosystem." This is just a fancy way of saying "guilt by association." The technique roped in everyone from a Canadian website called Global Research to former Italian Prime Minister Giuseppe Conte, and former Italian Democratic Party Secretary Nicola Zingaretti.

If you apply these techniques fifty million, a hundred million, a billion times, or a billion billion times, people will soon learn to feel how certain accounts are deamplified, and others are not. They will self-sort and self-homogenize.

Even when Twitter doesn't remove an account if the FBI recommends it, or passes along a request from Ukrainian intelligence to remove someone like Grayzone journalist Aaron Mate, users start to be able to guess where that line between good and ungood is.

One last note. As Michael and I found out recently with regard to the viral origin story, things deemed politically good often turn out to be untrue, and things deemed ungood turn out to be true.

I can recite a list if need be, but many news stories authorities were absolutely sure about yesterday later proved totally incorrect. This is another characteristic Orwell predicted: doublethink.

He defined doublethink as "the act of holding, simultaneously, two opposite, individually exclusive ideas or opinions and believing in both simultaneously and absolutely."

Not long ago we were told in no uncertain terms the Russians blew up their own Nord Stream pipeline, that they were the only suspect. Today the U.S. government is telling us it has known since last June that Ukrainian forces planned it, with the approval of the highest mili-

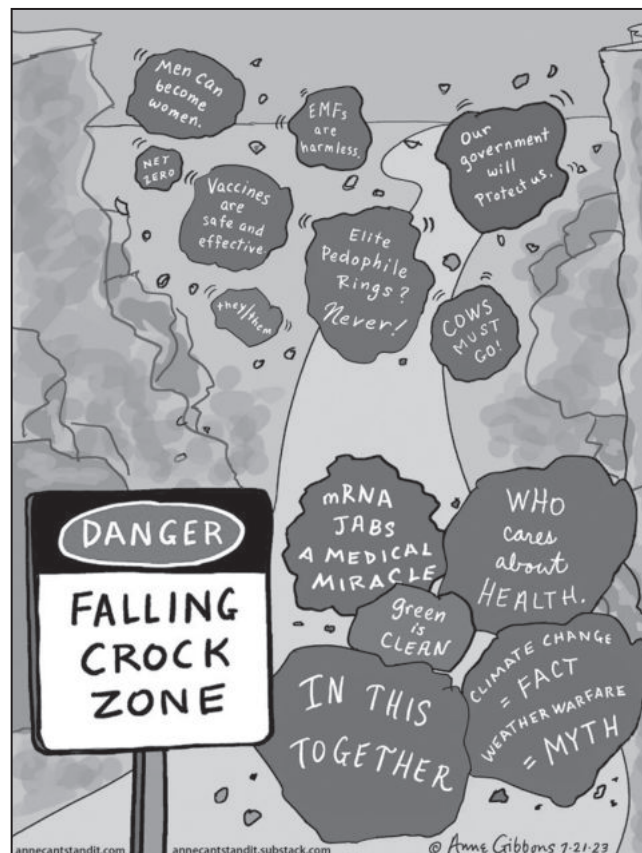
It would have been better if Canada had acted in a peacekeeping role to do everything it could to have prevented war in Ukraine. I

# The Media Recipe

## They've Been Practicing the Script for Decades

When I wrote my book, *FOWL: Bird Flu Is Not What You Think* in 2005, (no longer in print) global health masters were gearing up to terrorize the public over a new (novel?) influenza virus named H5N1 causing a condition that came to be known as 'Bird flu.' In retrospect, Bird flu was a trial balloon that tested the waters and set the groundwork for where we are now. I've posted four previous substacks that were inspired and partially excerpted from my book here, ([drtenpenny.substack.com](https://drtenpenny.substack.com)). This substack looks at the 'media recipe' that was created in 2004 and still used today to drive people to get injected with foreign matter ostensibly to keep them from getting sick.

### Little Interest in Flu Shots

The ho-hum attitude most people have about the next pandemic is the same attitude exhibited in the aftermath of other pandemic fiascos: Swine flu (1976), smallpox hysteria (after 9-11), Bird flu (2005), and more recently, Delta, Omicron and monkeypox and now, even Ebola, in the Marburg family of hemorrhagic viruses. In fact, more and more people are also giving a hand flick regarding all of the various 'jab and boost' campaigns. The media's frenzy has lost its effect. People have not only lost interest, but they also see the lies for what they are: strategically placed propaganda for global control and dominance.

Predictably, public health officials, especially the WHO, don't like this one bit...

### The Truth about Flu Deaths

Every winter, millions around the world get sick with what is called 'the flu.' Coworkers and classmates are home for about a week, feeling miserable. Some die from this illness, mostly the elderly and infirm. We have long been told the annual death toll exceeds 36,000 people in the U.S. and hundreds of thousands of more deaths around the globe. As it turns out, the CDC was forced to back away from this mantra because they were caught in a lie.

Instead of the estimated 36,000 annual flu deaths in the United States, a figure often cited to encourage people to get flu shots, the actual number of deaths caused by influenza illness over a 14 year span (1999 to 2013) ranged from as few as 257 to a high of 3,550 in 2013.

Let that sink in.

In fact, if you look at the 2015 stats compiled by the American Lung Association ([lung.org/getmedia/98f088b5-3fd7-4c43-a490-ba8f4747bd4d/pi-trend-report](https://lung.org/getmedia/98f088b5-3fd7-4c43-a490-ba8f4747bd4d/pi-trend-report)) using the CDC mortality files, you can clearly see that the number of deaths from influenza is a fraction of the total number of deaths from pneumonia. Yet, all stats parroted by the media and attributed to 'the flu' are a combination of pneumonia and influenza deaths.

*John Hopkins Medical Center reports there are more than 30 different causes ([hopkinsmedicine.org/health/conditions-and-diseases/pneumonia](https://hopkinsmedicine.org/health/conditions-and-diseases/pneumonia)) of pneumonia grouped into bacterial, viral, fungal, and mycoplasma pneumonia. The most common is *Streptococcus pneumoniae*, not influenza."*

### The Hype to Keep Up the Heat

As predictable as the return of yellow school buses and Monday Night Football, the arrival of fall also brings chatter about the approaching flu season. In 2003, surveys showed that nearly 65% of people did not receive the flu shot — including 47% with chronic illnesses and 78% of children aged 6-23 months. A new strategy was devised for the 2004 flu season to push their worthless shots into the arms of every one, from six-month-old babies to 96-year-old grandmas.

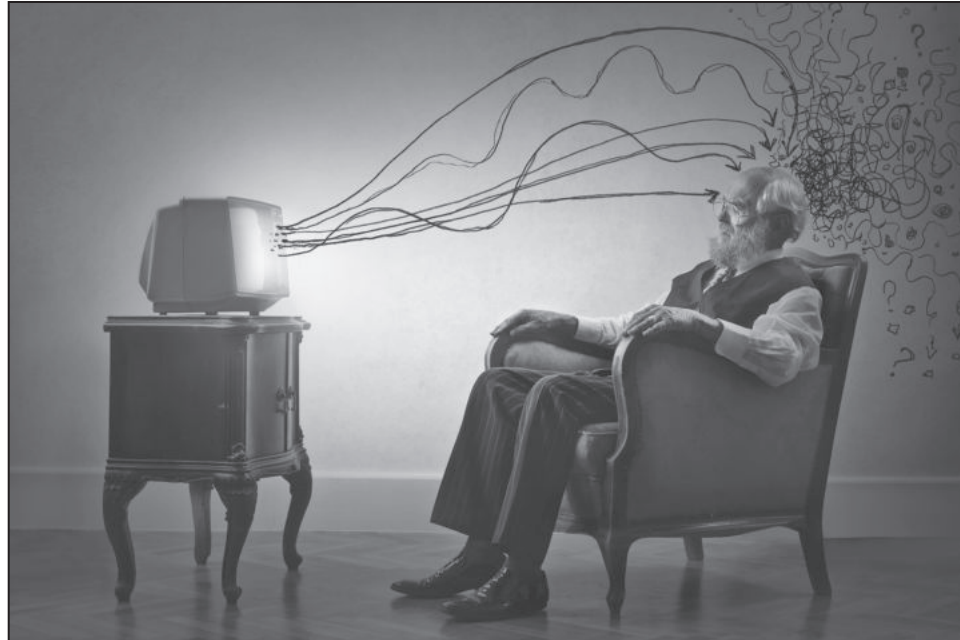
Knowing the flu shot doesn't prevent the flu, as I wrote about here ([drtenpenny.substack.com/p/giving-up-the-belief-in-flu-shots](https://drtenpenny.substack.com/p/giving-up-the-belief-in-flu-shots)), the CDC needed a new plan to support pharma's revenues. The value of the influenza vaccine market has grown year after year. I don't have the revenue stats from 2003, but it was - and remains - big business. In 2021, the global influenza vaccine market was valued at USD \$7.02 billion and is projected to grow from USD \$7.54 billion in 2022 to USD \$13.58 billion by 2029. The CDC's new plan was fully disclosed in a 51-slide communiqué called "Planning for the 2004-05 Influenza Vaccination Season: A Communication Situation Analysis," prepared by Glen Nowak, Ph.D., the Associate Director for Communications at the National Immunization Program.

The most important part of the program, "The Seven-Step Recipe for Generating Interest in, and Demand for, Flu (or any other) Vaccination," (slide 24) was



designed to methodically manipulate the general public. Language used in the presentation reveals the intent of the government and their drug company partners: Use major media to send scheduled, fear-based messages designed to convince the public that the flu shot is necessary to save lives. The more subtle message was to motivate patients to demand to be vaccinated.

Here is a synopsis of Nowak's 7-step Recipe:

#### Step 1: Begin discussing flu shots as part of the "flu season."

Posters, fliers, and media campaign materials are mailed to public health departments, pharmacies, and offices of healthcare providers by mid-August. The 5-color glossy materials are strategically placed to "plant seeds" in the minds of patients so that they request the flu vaccine when it arrives.

#### Step 2: Engage the Media.

The media will start announcing early on that a "new influenza strain" is anticipated and this year, it "will be associated with severe illness and serious outcomes."

By announcing the locations of flu shot clinics throughout a community during the evening news and a radio public service announcements, the stations are an accomplice to the propaganda. The media gives millions of dollars of free advertising to vaccine manufacturers.

#### Step 3: Predict dire outcomes.

The build-up continues throughout the fall as local and national medical experts and public health authorities parade across national mainstream TV and radio shows to voice concern, sound the alarm, and urge influenza vaccination.

Here's an example of hundreds of similar interviews: "We know we're going to have a pandemic because, historically, we're overdue for one," said Neil Pascoe, an epidemiologist in the infectious disease division of the Texas Department of Health. "When it happens, it's going to be huge. It will be global, and everyone is going to be affected...it could be terribly fatal. Imagine 4 million Texans [becoming] infected, and 20 percent of them die."

#### Step 4: Use 'worst case' language.

The reports from medical 'experts' are used to frame the flu season, using terms specifically chosen to "motivate behavior." Broadcasters are instructed to use language such as "very severe," "more severe than last or past years," and to repeatedly use the word "deadly."

#### Step 5: Everyone is at risk...and could die.

The media is coached to continually release reports from health officials, to increase credibility, that "this year's influenza is causing severe illness," fostering the perception that everyone is susceptible, unless, of course, they are 'protected' by a flu shot.

#### Step 6: "It's about the children..."

Again, the media is an accomplice to the promotions. Examples of sick children are shown, with reporters often standing in front of a local hospital. They occasionally interview families willing to come forward with their stories. They show pictures of people being vaccinated, "first to motivate, then to reinforce" the importance of flu shots.

#### Step 7: Positive reinforcement.

All parties involved are encouraged to use history to reference past influenza pandemics to continually stress the importance of vaccination.

Fast forward: 2020

On November 19, 2020, Nowak was tapped again to push the uptake of vaccines, but this time, it's the Covid jab.

He spoke at the ImmunizeDC Virtual Summit with a presentation entitled, "Improving Confidence in COVID-19 Vaccines & the Nation's Immunization System." The focus was on building Covid-19 vaccine and vaccination trust using risk communication principles. His was particularly addressing those who were reluctant to get the recommended Covid shot. He used this quote from Forbes to make his point:

*"What we do know is that public acceptance of a Covid-19 vaccine will play an outsized role in our ability to get as many people vaccinated as possible—and to that end, it isn't too early to begin planning our efforts to educate the public. As a new analysis published in JAMA makes clear, early planning and public education is a*

*must. To proactively confront barriers to Covid-19 vaccine acceptance in the United States, its authors argue, we must ramp up public health education now."*

The educational objectives of the conference were:

- Identify potential missed opportunities for vaccination due to the pandemic and increase immunization rates within your practice setting
- Identify reasons for vaccine hesitancy and utilize lessons learned to respond to vaccine hesitancy in local communities
- Describe latest data and recommendations on COVID-19 and implement those within your practice
- State the best approach to conducting mass vaccination clinics for a diverse group of potential patients
- Identify methods for increasing vaccine confidence and utilize these strategies for increasing immunization rates in your practice

The target audience for this conference was physicians, pharmacists and nurses and childcare providers engaged in the care of children and vaccines.

### Vaccinate, Vaccinate, Vaccinate...

If you are entertaining any thoughts that they will stop pushing for every human to be fully vaccinated with every shot they have created in the past, or will create in the future, think again. They are relentless and even 15 years later, are formulating language for the media to convince you to be injected with solutions of their making.

There are many programs such as this designed to educate providers on how to administer shots, then code appropriately and bill for insurance reimbursement. Doctors are also taught phrases and are given language on how to manipulate the general public into believing that flu shots, Covid jabs - and all other shots for that matter - are safe, effective, and absolutely necessary for avoiding illness.

We now know nothing could be further from the truth.

Fortunately, the same old 'recipe' has worn thin and many are seeing through the lies. It is becoming increasingly difficult to whip up fear about the flu and about Covid, no matter how many reports of "catastrophic concern" are rolling off the presses.

The next time you hear fear-based stories pushing any type of jab, know that the messages have been crafted and those delivering them have been thoroughly trained. They have been practicing the scripts for decades. Don't let their next round of ominous forecasting about a new 'scary pathogen' enter your psyche.

## A Systematic Review of Autopsy Findings in Deaths After Covid-19 Vaccination

## ABSTRACT

- **Background:** The rapid development and widespread deployment of COVID-19 vaccines, combined with a high number of adverse event reports, have led to concerns over possible mechanisms of injury including systemic lipid nanoparticle (LNP) and mRNA distribution, spike protein-associated tissue damage, thrombogenicity, immune system dysfunction, and carcinogenicity. The aim of this systematic review is to investigate possible causal links between COVID-19 vaccine administration and death using autopsies and post-mortem analysis.
- **Methods:** We searched for all published autopsy and necropsy reports relating to COVID-19 vaccination up until May 18th, 2023. We initially identified 678 studies and, after screening for our inclusion criteria, included 44 papers that contained 325 autopsy cases and one necropsy case. Three physicians independently reviewed all deaths and determined whether COVID-19 vaccination was the direct cause or contributed significantly to death.
- **Findings:** The most implicated organ system in COVID-19 vaccine-associated death was the cardiovascular system (53%), followed by the hematological system (17%), the respiratory system (8%), and multiple organ systems (7%). Three or more organ systems were affected in 21 cases. The mean time from vaccination to death was 14.3 days. Most deaths occurred within a week from last vaccine administration. A total of 240 deaths (73.9%) were independently adjudicated as directly due to or significantly contributed to by COVID-19 vaccination.
- **Interpretation:** The consistency seen among cases in this review with known COVID-19 vaccine adverse events, their mechanisms, and related excess death, coupled with autopsy confirmation and physician-led death adjudication, suggests there is a high likelihood of a causal link between COVID-19 vaccines and death in most cases. Further urgent investigation is required for the purpose of clarifying our findings.

## Good News Tidbits

- **A terminally-ill woman in Alberta has likely returned to the organ transplant list after being denied life-saving surgery over her COVID-19 jab status.** After a Supreme Court dismissal, Ms. Sheila Annette Lewis launched a new lawsuit against Alberta Health Services for medical malpractice. # Standing in Solidarity: The Imperative of Supporting Political Prisoners

*“Most Canadians don’t know that these men are being held without bail and that by the time they get to trial, they will have been sitting in remand center jails for over two years.” (...)* *“To any trained investigator the photo shows substandard, even suspect, evidence handling. It also indicates a surprising sloppiness in the investigation – especially considering the serious nature of the charges against the Coutts Four and the fact that a conspiracy is alleged.”* ~Donald Best, former Toronto Police Detective and Canadian anti-corruption whistleblower and activist.

Canada has seen some dark years of late and hope for positive change is often hard to imagine. Like many others, I felt very alone during the lockdowns and it seemed like nobody could stop the totalitarian agenda with its many lies from swallowing more and more of the rights I had been promised as a child. There were times when I held despair in my heart for the Nation that I loved and served. Yet today I stand firmly in faith and love, knowing a rekindled hope in my heart. That hope was rekindled at the Coutts border in February 2022 and it hasn’t left me since.

Soon after the Ottawa Convoy ignited the Nation in protest against vaccine mandates, a group of farmers from southern Alberta parked their equipment across the highway near Coutts and in the days following that act of courage, thousands of Albertans joined them in solidarity. I was one of those thousands. When I arrived at the Milk River encampment, the place was humming with energy and excitement, there were so many vehicles. Everyone had a look in their eyes like they couldn’t believe what they were seeing — like they had just crawled out of a dark cave and found sunlight for the first time in years. It would be impossible to encompass all that had transpired at that place but two things happened on February 14th, 2022 that I contemplate regularly.

It was Valentine’s Day, it was cold, and the Emergencies Act was in full effect. We were all emotionally exhausted by the fear and increasing psychological pressure being mounted on us by the RCMP to leave that roadside encampment. I remember feeling great anxiety and doubt about what would happen to us if we persisted in our protest. That morning a large group of local children came to our camp and gave us Valentine’s Day cards. A young boy gave me a little heart made from pink construction paper that said “Thank you Truckers” and asked me if I was a Trucker. I told him that I wasn’t but I wanted to be one when I grew up. He laughed and ran off to play in the straw-bale castle the children had built that they called “Fort Freedom”. I stared at that card for a long time and I still look at it often and it reminds me why we took the risk to stand there that day, going as far as to write lawyer’s phone numbers on our arms in permanent marker.

Twenty kilometres south of me, Tony Olienick, a 40-year-old farmer and trucker from the Claresholm area was handed a very similar card by another small child at the Coutts saloon. I spoke to him over the

phone from my home in Medicine Hat, while he sat in jail well over a year after the protest had ended. Tony is one of the four men who was arrested and charged with conspiracy to murder a police officer — the narrative that was used to justify the enacting of the Emergencies Act, previously known as the War Measures Act. Tony was arrested that Valentine’s Day evening outside Smugglers Saloon. The narrative that has been constructed around his arrest is that he and three other men were planning to engage in violence if the RCMP

ment could justify holding him without bail for over 500 days while we see violent criminals and sex offenders released within days. This man has not hurt anyone, he has not damaged property, and he has shown no interest in fleeing the justice system, yet there he sits. I often wonder how close I was to sitting in his very same shoes. One emotional comment to one of the many undercover officers at the protest might have landed me in the same circumstances. Then it would be my family suffering the imprisonment of a son.

I place myself in his shoes regularly and wonder what I would want from the public, especially from the people who understand why we stood there at the border despite threats of imprisonment. Tony stood there for that child with the Valentine’s Day card. He was scared yet he felt he had a responsibility to stand up for the God-given rights those children were promised. I remember both the fear and the faith that helped me overcome that fear. We can’t ask others to stand up for our freedoms and then turn away from them when they pay the price for taking that stand. I got to go home to my family but Tony Olienick, Jerry Morin, Chris Carbert, and Chris Lysak didn’t. Are we doing enough for these men? The fear that we all felt standing at that border is alive and well in our movement when it comes to speaking up for these young men who didn’t come home. Please consider speaking out against the treatment of these four men — picture that little pink paper heart and the hope for the future that it represents. These men were called to do their part and their efforts overcame the mandates for us. I think it’s time for the rest of us to be called into service to bring our brothers

made arrests at the Saloon. Yet the night Tony was arrested, he calmly engaged with the RCMP and was streaming live on his Instagram encouraging people to stay peaceful. (instagram.com/p/CZ8eN6VIC98 or @tony\_o1911) It was his last post on social media. Over 500 days later Tony and three other men are still behind bars without bail, awaiting an ever-postponed trial.

Tony has no criminal record, no history of violence, not even a speeding ticket. His friends tell me he got in a fight in elementary school and he still feels guilty about it. Everyone I’ve spoken to that knows the man describes him as kind, gentle, and charitable. Tony’s mother turned 80 this summer. She emigrated to Canada from the Philippines, she has a hard time understanding why this is happening to her son. She’s taken it upon herself to care for Tony’s farm and his dogs while he is imprisoned. It’s hard to express in words the pain and hardship that has been visited on this family by the “Justice” system. Many of their assets and equipment have been sold to retain legal counsel, the trial is estimated to cost over a million dollars just for Tony.

You get the feeling talking to Tony on the phone that he’s the one encouraging and lifting you up, not the other way around. He expresses deep faith that he’s in captivity in order to expose corruption. Despite finding himself very ill due to a lack of access to medical care or a suitable diet, he is known for his friendly and good-spirited interactions with the guards and staff. Every time I talk to this man I wonder how the govern-

What can we do practically? I would encourage people to educate themselves on the facts of the case so they can speak truthfully and courageously for these men. Attend their court appearances, and attend protests or fundraisers that groups like “Operation Rescue” and “Save The Coutts Boys” are promoting.

# Ghost Words from the Past - Prophecies of a Russian Defector

When I was a young conservatory student back in 1974, I ran across a book in the University library titled *The Marxist Minstrels: A Handbook on Communist Subversion of Music*. My young mind was fascinated with this idea, and I voraciously read through the book. I have always been interested in Marxism and Leninism. Not because I resonate with the ideology, but because I am fascinated how people throughout history have insisted that they can create systems in conflict with human nature and think they will flourish.

This basically is the “utopia syndrome,” some strange internal set of archetypal forces that compels people to attempt to implement some “perfect” idea for our “perfect” human race to embrace and live by. It can’t be done folks. And the more we try for that ideal, the more likely we will have a dystopia on our hands, as that is generally what has happened every time the attempt has been made.

When I found the book, I also ran across the since-debunked comment made by First Secretary of the Communist Party, Nikita Khrushchev, “*We will take America without firing a shot.*” Too bad he never actually said this, at least not publicly, he certainly would have been proud of it if he had. Whether he said it or not, he surely believed it. And even though the Soviet Union is long gone, the results of their psyop efforts to “take America without firing a shot” is finally, clearly, coming to fruition.

Anyone who takes any time to investigate the current situation in Canada, the U.S., as well as in other nations following similar paths, will find that a clear picture of Marxist ideology is beginning to form. Today it is called democratic socialism — or “social democracy,” which is claimed to be quite different, you decide,<sup>1</sup> and although clothed in altruistic liberal clothing, it has lost much of its original appeal as a good, solemn, and upstanding way to run a country or a society. I need not spend the time in this article to outline the indications that this grand experiment aimed at a leftist utopia has run awry—at least for us common folk — I think the signs are clear. So how did this happen? How did a relatively decent “idea” become so “wrong?” Even if you are a die-hard liberal, you must admit that things are just not as clean and copacetic as they used to be. The liberal form of government as it is practiced today does not function as the framework of a free and democratic society. It does work however, in a deeply socialist society — a society more closely structured as the society and government were structured in the Soviet Union. Some interesting modifications have been made to the new Neo-Marxism, but no matter how you dress a pig, it still is a pig. So, again, how did this happen?

In 1984, the journalist and author G. Edward Griffith interviewed Soviet KGB agent defector Yuri Bezmenov. At the time this interview was largely ignored. Although the Cold War was still raging (not to end until 1991 when the Soviet Union officially committed Soviet style hari-kari), no one really wanted to hear about Soviet spies and their activities. The Soviet Union and its existential threats were largely a thing of the past, at least the general public thought so. The West had won with all of its opulence and sparkly trinkets to play with and people spending a lifetime making enough money to buy them. The Marxist way of life was a failure, and needn’t raise its ugly, threatening, head again. However, if it was disguised as a wolf in sheep’s clothing (democratic socialism), it might easily be invited back into the henhouse.

Recently (2020) this rather intriguing interview has seen a new light. The video game maker Activision licensed a snippet of the interview to be featured in their popular game, *Call of Duty Black Ops: Cold War*. (See: [tinyurl.com/4ru8cp6w](https://tinyurl.com/4ru8cp6w)) Suddenly the original interview went viral. (See: [tinyurl.com/yjyk9mdd](https://tinyurl.com/yjyk9mdd)) According to this rather shadowy ex-KGB agent, a psyop was instigated in the US with a goal to take down not only the American way of life, but to replace it with a Marxist-Leninist way of life, and a Marxist form of totalitarian government — all this without firing a shot.

How exactly? Well, it isn’t your typical James Bond

spy plot that’s for sure. This was something intended to actually take decades to implement. And as a matter of fact, it has taken just that. Bezmenov outlines the basic steps of the psyop. The first step is “demoralization.” Bezmenov describes this first phase as taking 15 to



20 years to accomplish, as it involves the indoctrination of an entire generation of young people through public education. Here the ideologies of Marxist-Leninism are pumped into the young generation’s “soft” minds with no counterbalance of American patriotism and the ideals of American democracy and freedom. Bezmenov claimed in 1984 that this first phase was already complete, he said: “You cannot change their minds even if you expose them to authentic information. Even if you prove that white is white and black is black, you still cannot change the basic perception and the logic of behaviour.”

The next phase is “destabilization.” This phase takes only about five years to complete. The people, and what they are now doing, does not really matter, Bezmenov claims, “Whether you eat junk food and get fat and flabby doesn’t matter anymore.” He goes on to explain that what matters are essentials: economy, foreign relations, and defense systems. The people now in power, who were the students indoctrinated in the first phase, make policies regarding these essential areas. Bezmenov clarifies: “Most of the people who graduated in the ‘60s, dropouts or half-baked intellectuals are now occupying the positions of power, in the government, civil service, business, mass media, educational systems. You are stuck with them. You cannot get rid of them. They are contaminated. They are programmed to think and react to certain stimuli in certain patterns.”

Then comes the “crises” phase. It seems that currently we are in this phase, and have been for a while. The Covid “crises” certainly can qualify as the ultimate example of such a crises.

After crises is “normalization.” In Bezmenov’s words: “This is what will happen in United States if you allow all the schmucks to bring the country to crisis. To promise people all kind of goodies and the paradise on earth, to destabilize your economy, to eliminate the principle of free market competition and to put a big brother government in Washington D.C. with the benevolent dictators like Walter Mondale,<sup>2</sup> who will promise lots of things, never mind whether the promises are fulfillable or not, he will go to Moscow to kiss the bottoms of new generation of Soviet assassins. Never mind. He will create false illusions that the situation is under control. Situation is not under control. Situation is disgustingly out of control.”

Fill in the 1984 words, names, and places with 2023 words, names, and places, and you get the picture. Sound familiar? Darn right it does.

The little book I found in the library when I was 19 years old was intriguing. My rather innocent mind could not figure out how a powerful ideology such as Marxist-Leninism could “take over a country” passively with a covert, psychological campaign. How could music influence a generation of kids growing up in the freest country of the world? Well, it wasn’t only music (not all music, of course) that was being used in this psyop, it was just about everything imaginable. And no one really noticed

what was going down, until now — until now when we see the frightening results of decades of indoctrination. A nation (Bezmenov was speaking specifically of the US in this interview, but Canada is following the same path) being led by the nose by a leftist (Neo-Marxist) regime dead set on carrying out these totalitarian ideals.

I will close with more profound words of Yuri Bezmenov:

“Ideological subversion is the process which is legitimate, overt, and open. You can see it with your own eyes. There is no mystery.”

This is nothing to do with espionage. I know that espionage intelligence gathering looks more romantic. It sells more deodorants through the advertising, probably. That’s why your Hollywood producers are so crazy about James Bond type of thrillers. But in reality, the main emphasis of the KGB is not in the area of intelligence at all. According to my opinion and opinion of many defectors of my caliber, only about 15% of time, money and manpower is spent on espionage as such. The other 85% is a slow process, which we call either ideological subversion or active measures in the language of the KGB, or psychological warfare.”

<sup>1</sup> Democratic Socialism is when the public owns and controls economic resources; Social Democracy supposedly allows markets to flourish, and uses taxes and spending policies to feed social systems.

<sup>2</sup> Walter Frederick “Fritz” Mondale was an American lawyer and politician who served as the 42nd vice president of the United States from 1977 to 1981 under President Jimmy Carter. A U.S. senator from Minnesota from 1964 to 1976, he was the Democratic Party’s nominee in the 1984 presidential election, but lost to incumbent Ronald Reagan in an Electoral College and popular vote landslide.

# Words as Weapons

*“Sticks and stones can break my bones, but words will never hurt me.”*

This is one of the first psych ops used against children. Broken bones usually heal, but harsh words can be devastating. Furthermore, words are used to manipulate us for nefarious purposes.

## Catchy Phrases

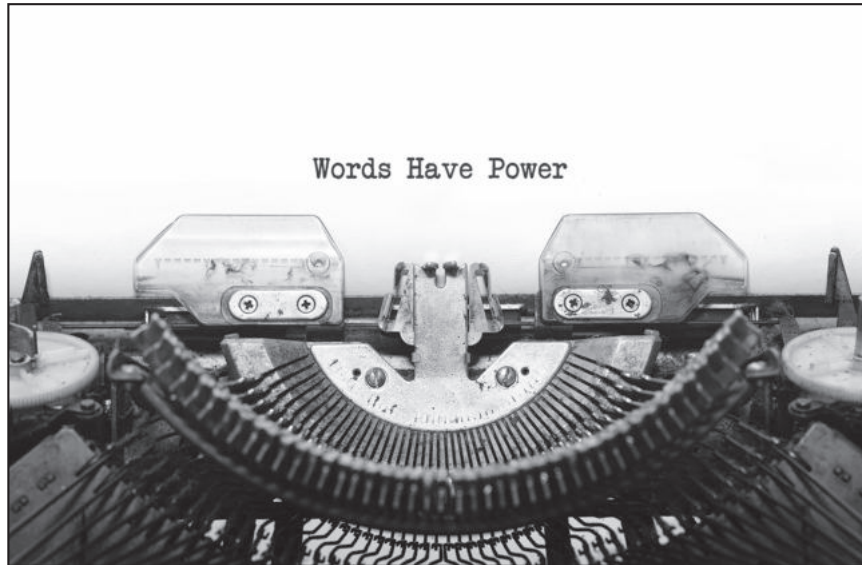
You may have noticed the extensive use of catchy phrases in the pandemic propaganda, such as “safe and effective”™ and “two weeks to flatten the curve”™. What I found surprising is that these phrases are often reused. Apparently, the claim has been made since 1945 that adding fluoride to drinking water is a “safe and effective” way to improve the public’s dental health<sup>1</sup>. Yet, toothpaste tubes contain a warning NOT to swallow due to toxicity. I guess fluoride is as “safe and effective” as the COVID vaccine.

## Redefinitions

In order to have effective communication between two parties, both sides must agree on what the words actually mean. This becomes more difficult when the language is evolving, either organically or maliciously. The word “factoid” illustrates this point to a tee. Definition: “<sup>1</sup>. A piece of unverified or inaccurate information that is presented in the press as factual, often as part of a publicity effort, and that is then accepted as true because of the frequent repetition. <sup>2</sup>. A brief, somewhat interesting fact.” The first definition was the original definition and the second definition was popularized by CNN<sup>2</sup>. Consider the following statement: Have you heard the factoid that ‘vaccines are safe and effective’? Notice how this statement has been completely neutered? “Factoid” was a very useful word to navigate the matrix; I wonder why CNN redefined it.

Is that how you want to build credibility with your friends and family -- by telling them that you have no problem mimicking the behaviour of people who don’t have a firm grip on reality? If so, good luck to you and auf wiedersehen. Associating with such people will destroy credibility and credibility is essential to spreading truth.

## Diversity

We’re told that diversity is our strength, yet, at the same time, a plethora of words are being winnowed out of our language, leaving us with a much smaller gene pool of words from which to compose our thoughts. This limits our ability to communicate. The most critical loss was that of our singular second person pronoun, i.e., “thou”. There is nothing stopping us from enriching our communications with archaic words. Whither dost thou seekest such words? Try reading classic literature, including authors such as Chaucer, Shakespeare, and Dickens, or pull out an older version of

the Bible. This will also sharpen your mind among other benefits. On the battlefield, you’ll have no regrets.

## Euphemisms

Our oppressors like to think of themselves as “elite”. I disagree. Their skill sets include lying, cheating, stealing, harming and chicanery. They are very good at these activities. ## Nova Scotia Health Covid Vaccine Policy is Costing Lives

Nova Scotia Health still clings to its COVID-19 vaccination policy for healthcare workers. One that other provinces have rescinded. This may have cost the life of at least one patient at Soldiers Memorial Hospital.

MIDDLETON, N.S. — While a man lay dying from heart failure at Soldiers Memorial Hospital, a doctor (who may have been able to save him) was raking leaves in his yard less than 10 minutes away.

With no doctors in the vicinity who were allowed to work, the hospital was forced to call in volunteer firefighters and EHS. The doctor they did call was in Kentville, almost 40 minutes away, and by the time he arrived, further attempts to resuscitate were unsuccessful. The man ultimately died. The blame rests solely on Nova Scotia Health’s COVID-19 vaccination policy. Only British Columbia and Nova Scotia still require healthcare workers to have two shots in order to work. Why have the others relaxed this mandate and even rehired unvaccinated doctors? Why is NS looking for doctors outside the province, while NS doctors have been sidelined and not allowed to work?

Does NS have a leadership deficit? Who is really running NS Health?

There are several emergency physicians in the (Annapolis) Valley who are no longer working because of the policy. One doctor has stated he would return to work at Soldiers Memorial Hospital emergency depart-

ment in Middleton if Nova Scotia Health drops its vaccine mandate. They have been off the job for more than a year and a half.

Doctors were readily available at Soldiers Memorial Hospital 24/7 before the COVID vaccine mandates were implemented. However, since June 2022, the emergency room has been partially staffed, open only Tuesday – Friday 7:30 am to 1:30 pm — if doctors are available. They are struggling to maintain even those reduced hours because of the (vaccine) mandates. How is a vaccine mandate about safety if people are dying as a result? The lack of leadership, along with bad policy puts the community at risk. If eight other provinces have rescinded this mandate and hired these doctors back, there is no reason why NS should cling to such Draconian measures that put people at risk.

In April, Carman Kerr (the Liberal MLA for Annapolis) raised concerns with Health Minister, Michelle Thompson, about the number of health care workers dismissed in his constituency because of the vaccine mandate. He asked her if there were any options. The Minister knew of none. Kerr has received phone calls from constituents and paramedics crying and still NS Health refused to change their policies for the protection of the public and did



not allow doctors to return to work. This is, again, a sign of poor leadership. The public needs to speak out and get this mandate rescinded and these doctors back to work, so that there are not more incidents like this and more hospitals closing.

# Child Sex Trafficking is America's Darkest Secret

A story about my brush against a child sex trafficking ring:

From 2009–2017 I had a regular column at a very popular but now defunct Hip Hop website. I was the lone writer who covered politics and conspiracy theories.

During that time I stumbled across a story about a child sex trafficking ring that operated out of Franklin, Nebraska. It was discovered when the FBI began to investigate a credit union that was owned by a prominent Republican donor and was involved in the Iran Contra scandal. During the investigation the ring was actively covered up by the FBI when they realized it stretched across the country and serviced some very prominent American businessmen and politicians. It was only through the work of State Senator John DeCamp and FBI Chief Ted Gunderson that anyone had any knowledge of it at all.

I wrote my piece and sent it to my editor before leaving for a trip to Hawaii. When I arrived in Honolulu I received an email from my editor telling me my piece was published. Then about an hour later I received another email telling me there were some "legal issues" and I had to change the language in my article. The editor was a fearless dude so something big had to have happened to prompt the email from him. So I stayed up all night re-writing my piece from scratch and sent it off the next morning. He gave me the thumbs up so I shut off my laptop and spent the rest of the week on the beach.

When I arrived back in Vancouver I turned on my cell phone and my voicemail inbox was full of threatening messages from disturbing high pitched voices telling me they knew where I lived, that I was gonna die, that an accident was going to happen, things like that.

The calls went on for weeks afterward — mostly after midnight in the early hours of the morning. It was always the same voicemails from the same voices. It was the most disturbing thing I've ever experienced.

It is entirely possible that somebody out there was just messing with me, but if it was, then it was the longest, cruelest practical joke in history. If it wasn't, then I stirred up something that didn't want to be found.

The point of this story is that these rings and these people are very, very real. I personally believe that child sex trafficking lies at the root of something much bigger and darker than we know. It's why Jeffrey Epstein was murdered in plain sight, and why every attempt to expose them is automatically met with accusations of being Qanon conspiracy theories. Something out there doesn't want us to know about it, and if we did know, it would expose everything else.

I lay awake at night — alone in my apartment, wondering if I made a life shattering error by writing about that story. Almost nightly my phone would rattle on my nightstand. I'd gaze at it, tempted to pick it up. Sometimes I did, sometimes I didn't. Nobody

ever answered when I did. They wanted my voicemail, and most often that's where I sent them. The number always appeared as "unknown" on my call display. I found it oddly fitting since the disturbing voice mes-

me come undone like this. They want me to self-destruct for their own entertainment.

The voices on the phone began to feel internal; they were inside me.

sages sounded like they were from some unidentifiable being in a lower dimension. I tried to resist listening to them until the morning, but curiosity won that battle most nights. There's something about a haunting voice speaking to you through your phone at 3 am that sends chills up your spine. That was the intended effect, I know. But when you're there, in the moment, it feels like they're in the room with you and you can't help but freeze in the blanket of fear that envelops you.

I jammed a towel under the entrance to my apartment and another under my closed bedroom door. This was part of my nightly routine. It wasn't the best mode of protection from an intruder, but I figured it would give me enough time to react as they forced themselves inside. I was two years into wrestling and Jiu Jitsu training and I had more years of boxing underneath me. When they entered my home I would go with what I know best: a snappy straight right hand with all of my two hundred-some-odd pounds behind it. If that didn't shut off their consciousness I would transition to a double leg takedown and mount them from behind. A tight rear naked choke would do what a straight right couldn't.

I ran through my strategy endlessly. If there was one of them — even if he were armed — I felt comfortable in my ability to potentially neutralize him if I attacked from the right angle. If there were two or more I was screwed. There was one way in and one way out of this three hundred and fifty square foot box. My only hope would be to create some chaos and run for the door.

Paranoia infected my mind. I interrogated my friends about the phone calls. I was positive it was one of them playing a cruel joke. They stared back at me with genuine concern when I accused them of this grand conspiracy to throw me into the deep end of a mental breakdown. The lack of sleep was enhancing my inner turmoil. Alex Jones is still very much alive and well though — despite legacy media's attempt to destroy him. He had always been the oddball on the fringes of mainstream society, screaming across the digital landscape about Satanic plots to enslave the global population under a new world order. Before the Covid-19 pandemic many regarded him as a poster boy for paranoid delusions and manic episodes of extreme psychosis. Now in the post pandemic world we're slowly realizing he was just ahead of the curve.

No matter what you may think of Jones and his dramatics, there's one ripple in the highly publicized history of his missteps that lends to his credibility: the night he infiltrated Bohemian Grove.

The ceremony is called the Cremation of Care ([en.wikipedia.org/wiki/Cremation\\_of\\_Care](https://en.wikipedia.org/wiki/Cremation_of_Care)) and is supposed to symbolize the burning of their conscience; a cleansing of guilt from reprehensible deeds.

In the Christian Bible Moloch is mostly associated with child sacrifice. Interestingly, Bohemian Grove is

frequently referenced in the victim statements given during the child sex trafficking investigation I covered.

In 1999 Jones successfully snuck into the retreat and videotaped the ritual. need of it. If they need it, they can take it.

121. In other words, if you live in a rich Nation of hard working people, you have to give what you have away to the poor people. You have to. This is catholic social doctrine. Capitalism in all its forms has to disappear.

in other states altogether. What they detailed were events so blood curdling I often cried when reading their accounts. These children — most now teenagers — had been abused so thoroughly it was amazing they were still coherent enough to tell their story. Many agreed to testify at a grand jury trial, and all but two mysteriously died before they had their day in court.

Eventually the phone calls stopped and life continued on, but the evil I was exposed to while writing the piece and my experience in the aftermath stained me forever. The recent release of the film *Sound of Freedom* and the propaganda effort to suppress it has resurrected those old memories. The same voices that wailed in my voicemail messages for three weeks after my essay was published have reemerged in articles from *Rolling Stone*, *Washington Post* and others trying to deter the public from discovering this world hidden beneath the cultural rot. Something out there doesn't want the public to know about the darkest ridges of society's underbelly, and it's my personal belief that it's within those creases we'll find the kernels of truth that will awaken us to the poison seeping into everything else.

Go see the movie, follow the breadcrumbs it's left behind, and most importantly, keep digging.

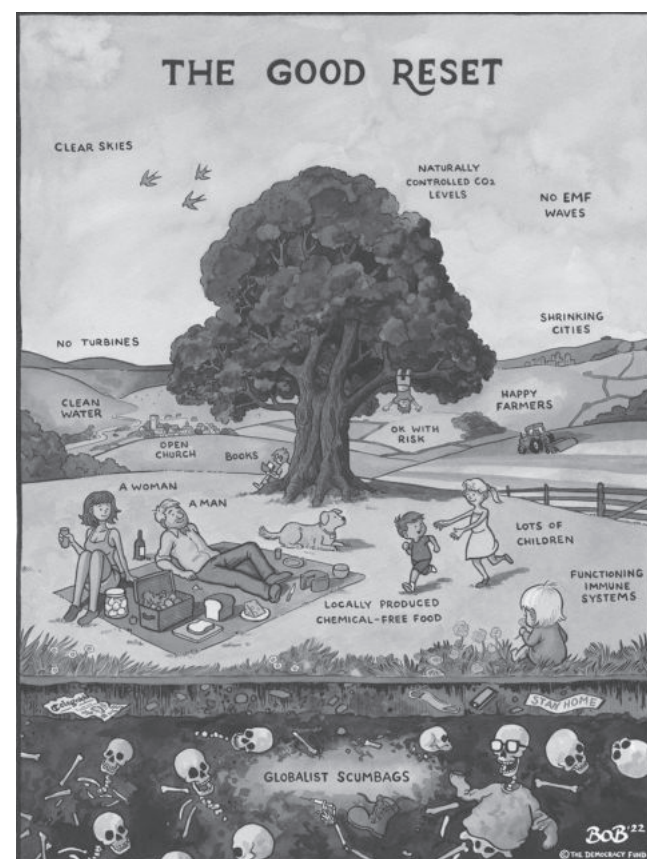

# Absurdity Observer

## Some Of The Most Absurd Things That Have Happened In Recent Weeks

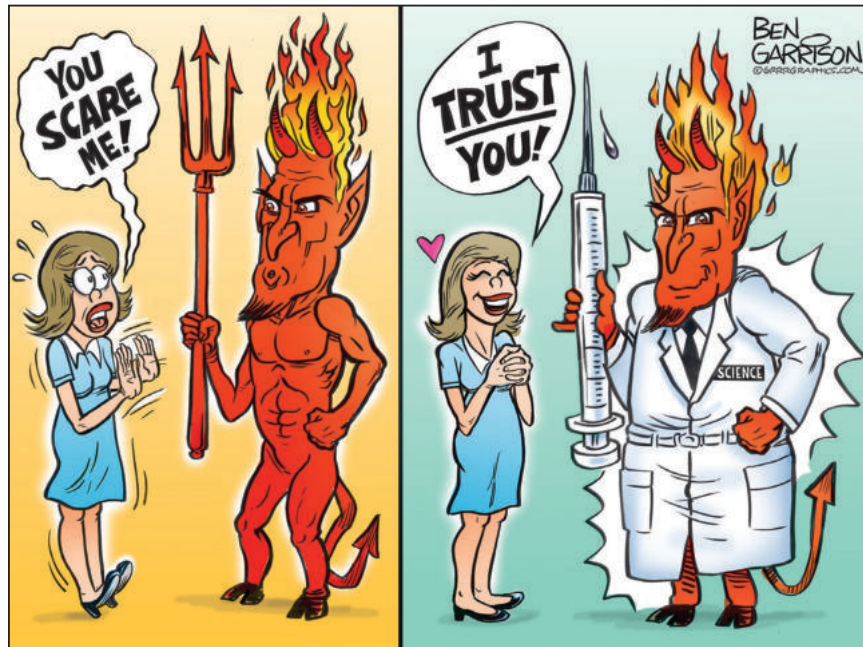
- The largest corporate welfare deal in Canadian history just went from bad to worse. After it was announced in April that Volkswagen would receive \$14 billion (now \$16 billion) to build an electric car plant, Chrysler's parent company, Stellantis, threatened to stop building their plant and demanded the same deal. Cabinet just approved \$15 billion to Stellantis, and an additional \$2 billion to Volkswagen, amounting to more than **\$31 billion in corporate handouts for Ontario electric car plants in the past few months**. For reference, \$31 billion is the equivalent of giving a million dollars to every household in the Yukon Territory AND the Northwest Territories.
- An explosive preprint study published in *The Lancet* (McCullough et al.) on July 6 titled "A Systematic Review of Autopsy Findings in Deaths after COVID-19 Vaccination," exposed direct statistical evidence of COVID-19 vaccinations being a direct cause of death, driving the excess mortality that we've witnessed since the government-pushed vaccination campaign. The results showed that, after surveying data from 325 autopsies in vaccinated people, "a total of 270 deaths (73.9%) were independently adjudicated as directly due to or significantly contributed to by COVID-19 vaccination" by the medical examiners of the cases. The review found that the primary organ system failure that caused death was the cardiovascular system (53% of cases). The study's explosive findings ranked it as one of the most downloaded studies within 24 hours of publishing. After the paper began circulating widely online, *The Lancet* removed the study from its website, claiming the study's conclusions lack evidence.
- Health Canada claims COVID deaths would have surpassed WWII casualties without lockdowns, and vaccine mandates without supplying any data to support their claim.
- The supposed highest-ever temperature recorded in European history, 48°C, was a lie. In mid-July, it was widely reported by corporate media that Sicily was a record-breaking 48°C. In actuality, the temperature only reached 32°C. The media took the European Space Agency's "ground surface temperature" and reported it as if the readings were taken as they normally are -2 meters above the ground.
- The total cost of the federal government's wasteful COVID spending — money either poorly targeted — will eclipse \$110 billion by 2033, with \$1 billion having already been wasted on expired vaccines, and \$21.1 billion going towards high debt interest costs, a *Fraser Institute* study finds.
- A charity that provides guidance to healthcare professionals is asking medics to refer to a vagina as a "bonus hole" or "front hole" to avoid upsetting transgender men. In a guide for healthcare professionals published online, *Jo's Cervical Cancer Trust* suggests using these terms to avoid causing one without a vagina "to feel hurt or distressed."
- A Quebec school district spent over \$1600 on a

drag queen event with infamous children's drag performer Barbada de Barbades. The Centre de Services Scolaire de la Capitale, which is responsible for Quebec City schools, paid the drag artist \$1609.65 for a one-and-a-half-hour drag conference.

- As of July 1, federal employees and their families are now eligible to receive a **\$75,000 grant for "gender-affirming" surgeries**. This can include everything from hair removal to invasive gender reassignment surgeries, such as a vaginoplasty and phalloplasty.

(Facebook) paid the fact-checking site the equivalent of **\$1052 CAD per article**. This agreement, believed to be worth about half a million dollars annually, raises questions about the independence and motivations of the fact-checking organizations involved.

- The Edmonton Heritage Festival Association publicly demonized Russian-Canadians and banned Russian culture from its festival. The board said that the decision was made due to "safety concerns" claiming that "Ukrainians feel" that "there shouldn't be any Russian culture promotion here because this is the culture that brought up the generation of people who turned out to be invaders, looters, killers, rapers."



- The CDC has published guidance on "chestfeeding" — a term used to describe feeding an infant milk directly from the breast by trans and non-binary parents. The CDC blurred the lines between politics and science, failing their responsibility to disclose the lack of research and potential risks to babies. In the section titled "Health Equity Considerations," the CDC claims "an individual does not need to have given birth to breastfeed or chestfeed" and can use "medication to induce lactation." These drugs are "off-label" and the primary medication used to produce milk in biological men — the anti-nausea drug 'domperidone' — has been linked to heart problems in babies.

- In an effort to make all children feel equal, the BC government is abolishing letter

grades for all public school students from Kindergarten to grade 9. In lieu of grading with letters A through F, a proficiency scale will assess students as "emerging," "developing," "proficient," or "extending."

- CBC paints the new hit film "Sound of Freedom" as being "Xenophobic," "Pro-Trump," and "Pro-Life" despite the movie not touching on any of these topics. The movie is based on a true story of one man's quest to save children from child traffickers.

- The University of Guelph's Department of Sociology and Anthropology is looking to hire a new assistant professor - but eligible applicants must "identify" as black or Indigenous.

- In a disquieting discovery, the Brazilian Central Bank Digital Currency (CBDC) is reportedly designed with a feature enabling the government to freeze user funds and adjust balances. The revelation emerged after a prominent blockchain developer and founder of Iora Labs, managed to decode the underlying technical details of the Brazilian CBDC.

- The total number of federal employees in Canada now stands at 357,247 — nearly 40% higher than in 2015 when Prime Minister Justin Trudeau was first elected. Between 2015 and 2022, federal executives received \$1.3 billion in bonuses. The federal government does not publicize a "sunshine list" of employees making over \$100,000 a year, but a report last summer by the *Post* put that number at 114,443. This included 39,000 six-figure jobs added in 2021 alone.

- Garnet Harper, a 35-year-old Ontario father of five, has died after multiple hospitals refused him a kidney transplant because he wasn't vaccinated against Covid-19, and despite his family members offering to donate their own kidneys.

- Bank of Canada officials earned \$20 million in bonuses last year while hiking interest rates and failing their 2% inflation mandate. According to records obtained by the Canadian Taxpayers Federation, as inflation reached a 40-year high, 80% of the central bank's workforce received at least one bonus for their supposed "job well done," with each bureaucrat receiving an average of \$11,200 in bonuses.

- Governor General Mary Simon spent \$71,000 of taxpayer money on limousine services (and \$115,000 on hotels) during a four-day trip to Iceland with her husband and team of 6 in October 2022. This example of exuberant spending, obtained by the Canadian Taxpayers Federation through an access to information request, is just the latest example of Simon billing taxpayers for her many expensive and lavish trips abroad to "promote Canadian culture and literature abroad." A prior access to information request revealed that GG Simon had charged taxpayers \$800,000 to go to Germany for a book fair, and \$1.15 million on a trip to Dubai.

- Court documents obtained during a defamation lawsuit have exposed the biased business of fact-checking. The agreement between the social media giant Meta and the site RMIT FactLab showed that Meta
